Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Cambium Learning Profit Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1 - Description of plan

The following description of the Cambium Learning Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time and certain part-time employees of Cambium Learning Group, Inc., ("Cambium" or "the Company"). The Plan was established on August 1, 1954, and was most recently restated effective January 1, 2022, and amended effective January 1, 2023 and July 29, 2024.

Covered employees are immediately eligible to participate in the Plan and may join or elect deferral percentage or investment election changes on any business day, effective at the next payroll processing date. The Plan is participant directed, and therefore, participants are allowed to select the investment funds into which they wish to contribute. The Plan is designed to qualify under Section 401(a) and the related provisions of the Internal Revenue Code (IRC) and is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until December 31, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan to Fidelity Management Trust Company, (the "Trustee"), and Massachusetts Mutual Life Insurance Company ("Mass Mutual"), an asset custodian of the Plan.

Contributions

Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants electing to make contributions to the Plan may contribute not less than 1% and no more than 75% of compensation, as defined by the Plan, on a pre-tax or after tax (as Roth contributions) basis, up to the maximum allowed by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of not less than 1% and no more than 100% of compensation, up to the maximum allowed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Contributions are limited in accordance with IRS regulations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated investment fund until changed by the participant.

For 2024, the Company contributed a matching contribution of up to 3% of eligible participants' annual compensation depending on the level of employee contributions. Additional amounts may be contributed at the option of the Company's board of directors. Company matching contributions are calculated each pay period and deposited into participant accounts with their employee

contributions. After the completion of the Plan year, a true-up Company match is calculated and subsequently credited to participant accounts.

The Company contributed \$7,776,829 to the Plan for the year ended December 31, 2024. These contributions were calculated in accordance with the terms of the Plan. The participant contributions and rollovers totaled \$30,935,116 for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions (including rollovers), and an allocation of the Company's contributions, Plan earnings, and charged with any withdrawals or distributions, investment losses and an allocation of administrative expenses. Gains and losses resulting from market appreciation or depreciation, interest, and dividends are allocated on the basis of participants' account balances. Each participant directs the investments of his or her account to any of the investment options available under the Plan.

Vesting

Participants are immediately vested in their contributions and the Company contributions, as well as any investment earnings on these contributions.

Payment of benefits

Upon termination of employment with the Company or other specified events, a participant may elect to receive an amount equal to the value of the participant's interest in his or her account in either a lump-sum amount or in installments. Additionally, participants may request partial distribution of their account as allowed by the Plan and subject to IRS regulations, including withdrawals for financial hardships.

Notes receivable from participants

Participants can borrow the lesser of \$50,000 or 50% of their vested account balance, subject to IRS limitations. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, set on the date the loan was distributed. The interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024. Principal and interest are generally repaid through payroll deductions. Loan terms range from one to five years or ten years if made to finance the purchase of a primary residence.

Administrative costs

Participants were charged administrative fees, primarily loan administration and investment advisory fees, of \$162,653 in 2024. The stable value investment incurred investment fees of \$5,279 in 2024. The Company paid certain other administrative expenses of the Plan.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the management to make estimates and assumptions that affect certain reported amounts and disclosures, and actual amounts may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value, except for a fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 5). Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts because contract value is the amount Plan participants normally would receive if they were to initiate permitted transactions under the terms of the contract and Plan provisions (Note 6). The Plan determines the valuation policies utilizing information provided by the Plan's investment advisors, the Trustee, and Mass Mutual.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company which is the pay date. Company matching contributions are recorded in the year they are earned and to coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivable for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Rollovers are recorded when received by the Plan's trust.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, are paid by participants, and are expensed when they are incurred. Repayments of principal and interest are generally received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan document.

Payment of benefits

Benefit distributions are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and changes therein.

Note 3 - Tax status

The IRS has determined and informed FMR LLC, the provider of the Pre-Approved Plan, by letter dated June 30, 2020 that the Pre-Approved Plan which the Company has adopted and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, that the Plan and related trust are tax-exempt.

Note 4 - Certified investments

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee, determined to be a qualified institution by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year) ("supplemental schedule"). The Trustee has certified that the following information included in the financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and,
- Investments and notes receivable from participants reflected on the supplemental schedule as of December 31, 2024.

Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing accounts: Level 1 investments valued using the daily closing price as reported by the fund and Level 2 investments valued using discounted cash flows that are observable.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the fund less its liabilities, divided by the number of outstanding shares. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The fund primarily invests its net assets (including the amount of any borrowings for investment purposes) in a diversified portfolio of income-producing (dividend-paying) equity securities, which will consist primarily of common stocks but also may include preferred stocks and convertible securities. The fund invests principally in securities of companies believed to be undervalued but also may invest in securities of companies believed to have the potential for long-term growth. The fund may invest in companies that have market capitalizations of any size. The fund may also invest up to 20% of its net assets in debt securities, including securities that, at the time of purchase, are rated below investment grade or are unrated but determined to be of comparable quality. The fund may also invest up to 20% of its net assets in foreign securities. The fund may invest in derivatives, including futures, forwards, options, swap contracts and other derivative instruments.

Note 6 - Fully benefit-responsive investment contracts

In 2012, the Plan entered into a fully benefit-responsive unallocated separate account guaranteed interest contract ("SAGIC") within a group annuity contract with Mass Mutual (or "issuer") as part of a stable value fund that is established and managed solely for the Plan. Mass Mutual maintains the contributions in a market value separate account with a general investment account guarantee that provides a stated rate of return and insulates participant accounts from daily fluctuations in the market. The separate account is credited with contributions and interest and charged for participant withdrawals and administrative expenses.

The SAGIC group annuity contract is fully benefit-responsive, therefore it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no allowances against contract value for credit risk of the contract issuer or otherwise. The contract value held by the Plan at December 31, 2024 and 2023 was \$9,513,836 and \$10,816,757, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include (1) amendments to the plan documents (including complete or partial Plan termination), (2) changes to the Plan's competing investment options, or (3) Plan sponsor events (for example, divestitures or spin-offs of a subsidiary, layoffs or early retirement programs) that cause a significant withdrawal from the Plan. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the issuer or with participants.

The SAGIC group annuity contract permits either Mass Mutual or the Plan to terminate the agreement with advance notice required. The contract does not have a maturity date.

Note 7 - Termination priorities of the plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Participants are 100% vested in their accounts, and in the event of Plan termination, the net assets of the Plan would be allocated to participants as prescribed by ERISA and its related regulations.

Note 9 - Related party and party-in-interest transactions

ERISA defines party-in-interest similar to a related party as defined under financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. We did not identify any related parties to the Plan that were not also considered to be party-in-interest. The Plan did not enter into any material related party transactions during the plan year related to compensation, arrangements, expense allowances or similar items.

Certain investments of the Plan were held in investment funds which were managed by the Trustee, and Fidelity Investments, an affiliate of the Trustee, and in a guaranteed interest contract managed by Mass Mutual. Therefore, these transactions represent exempt party-in-interest transactions which are not prohibited by ERISA. Expenses in the amounts of \$167,932 were paid to Mass Mutual, Creative Planning, LLC, and Fidelity Investments during the Plan year and qualify as exempt party-in-interest transactions. Further, notes receivable from participants qualify as exempt party-in-interest transactions.

Note 10 - Subsequent events

Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.
