Opinion

We have audited the financial statements of Horizons Diagnostics LLC Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

NOTE 1: Description of Plan

The following brief description of the Horizons Diagnostics LLC Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a prototype defined contribution plan sponsored by Horizons Diagnostics, LLC (the “Plan Sponsor”) for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally adopted on October 1, 1999 and has since been amended and restated with the Plan’s most recent restatement effective January 1, 2022 which changed the eligible entry date.

The Plan Sponsor has sole responsibility for the administration of the Plan. The Plan’s trustees have responsibility for the management of the Plan’s trust fund. Three individuals serve as the Plan’s trustees. Merrill Lynch, Pierce, Fenner & Smith Incorporated is the Plan’s recordkeeper and custodian. Fees for these services are incurred and paid by the Plan.

Eligibility – Employees of the Plan Sponsor, except for certain nonresident aliens and union employees who have no earned income from services within the United States and members of certain collective bargaining units, are eligible to participate in the Plan upon completing six months of service and attaining age 21. Employees may enter the Plan on the first day of the calendar quarter following the date eligibility requirements are met and will begin receiving safe harbor matching contributions upon entry. Participants become eligible for discretionary employer profit sharing contributions upon completing one year of service with at least 1,000 hours of service. Eligibility for discretionary employer profit sharing contributions begins on either the first day of the Plan year or the first day of the 7th month of the Plan year following completion of the service requirements. Additionally, participants must be employed by the Plan Sponsor on the last day of the Plan year to receive discretionary employer profit sharing contributions.

Contributions – Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Code (“IRC”) limitation. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The employer remits safe harbor contributions in an amount equal to the participant’s contribution up to 3% of the participant’s eligible compensation. Participant contributions in excess of 3% and up to 5% of eligible compensation are matched at 50%.

The Plan also allows for the Plan Sponsor to make an additional discretionary matching contribution in an amount equal to a discretionary percentage of participants' elective contributions that is tiered. The tiers may be based on the rate of a participant's elective contributions or years of service. For the years ended December 31, 2024 and 2023, no discretionary matching employer contributions were made.

The Plan Sponsor may also remit discretionary employer profit sharing contributions. For the years ended December 31, 2024 and 2023, discretionary employer profit sharing contributions totaled \$453,475 and \$406,897, respectively.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Plan Sponsor's contribution, and allocations of the Plan earnings and is charged with benefit payments and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their elective contributions, rollover contributions, and employer safe harbor contributions plus actual investment income or losses thereon.

Discretionary employer matching and profit sharing contributions are subject to the following vesting schedule based on years of service:

Participants also become 100% vested in Plan Sponsor contributions upon attaining the age of 65.

Forfeitures – At December 31, 2024 and 2023, forfeited, non-vested accounts totaled approximately \$2,500 and \$640, respectively. Forfeitures can be used to reduce employer contributions or to pay Plan administrative expenses. For 2024 and 2023, forfeitures totaling approximately \$6,500 and \$14,000 were used, respectively, to pay administrative expenses of the Plan, while none were used to reduce employer contributions.

NOTE 1: Description of Plan (Continued)

Investment Options – The assets of the Plan are allocated to a pooled separate fund approved by the Plan Sponsor. Participants may also invest in self-directed brokerage accounts. Participants may change their investment options on the first day of each calendar quarter.

In addition, certain participants have the option of self-directing contributions to a wider range of investment options outside of the investment options established by the Plan Sponsor, including mutual funds, publicly traded stocks and bonds, and alternative investments for an annual fee. Transactions are accounted for through personal brokerage investment accounts.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) and is fixed for the duration of the loan. Loan repayments are made ratably through payroll deductions over a period not to exceed five years unless the loans were used to purchase a primary residence, in which case the loan term may not exceed ten years.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits – Upon a participant's termination of employment, retirement or death, such participant may receive a lump-sum distribution in an amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals from employee contribution account balances are also permitted by the Plan. In-service distributions from vested amounts may be made to a participant provided the participant has attained age 59½. Vested account balances of less than \$1,000 are subject to automatic distribution in accordance with the Plan document upon a participant's termination.

Plan Termination – Although there is no present intention to do so, the Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, the participants will become fully vested in their account balances and the trustees shall dispose of the plan assets by distribution to participants and beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. See Note 3 for a description of the valuation and methodologies used to determine each investment’s fair value.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Tax Status – The Plan received a favorable determination letter from the Internal Revenue Services (“IRS”) dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in accordance with the applicable requirements of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods. However, there are currently no audits for any tax periods in progress.

Benefit Payments – Benefits are recorded when paid.

Plan Expenses – Significant costs of administering the Plan are absorbed by the Plan Sponsor and are excluded from these financial statements. These costs include legal and administrative fees. Certain administrative expenses, including trustee and recordkeeping fees, are incurred and paid by the Plan. Other investment-related expenses are included in net appreciation of the fair value of investments.

Reclassification – Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The Plan's trustees have evaluated all subsequent events that may qualify for disclosure through October 7, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Cash equivalents()*: Valued at net assets value ("NAV") of \$1 per share.

U.S. government securities()*: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Value as determined by quoted market prices, which represents the NAV of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks()*: Valued at their quoted market prices at year end.

Alternative investments()*: Valued at NAV per unit as determined by third party valuations at year end.

* Asset type is included in self-directed brokerage account balances below for each of the years ended December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
