December 31, 2024 and 2023

(1) Description of Plan

The following description of the Nascentia Health, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering eligible employees of Nascentia Health, Inc. and the following participating employers: Visiting Nurse Association of Central New York, Inc. d/b/a Nascentia Health at Home, CCH Home Care and Palliative Services, Inc., Independent Health Care Services, Inc. d/b/a Nascentia Independent Care and Home Aides of Central New York, Inc. d/b/a Nascentia Home Aides, hereinafter referred to as Employer (Employer). Union employees covered by a collective bargaining agreement and Independent at Home personal assistants and temporary employees are not eligible employees. Non-union employees who have attained the age of eighteen are eligible to participate in the matching and employer discretionary contribution features of the Plan. Those employees who are eighteen or older and have completed three months of service are eligible to elect salary deferrals under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Pension and Investment Committee of the Employer is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Employer's Board of Directors.

(b) Contributions

Each year, participants may contribute a percentage of their pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). For each participant who has completed at least six months of service and is age eighteen or older, the Employer may contribute a discretionary contribution. Employees are eligible for discretionary matching contributions if they are employed on the last day of each quarter. A non-elective discretionary amount may also be contributed at the option of the Employer for eligible employees who have completed at least one year of service and are employed on the last day of the Plan year. There were no discretionary contributions in 2024 and 2023.

(1) Description of Plan, Continued

(b) Contributions, Continued

The Plan also allows for eligible participants to receive a safe harbor matching contribution equal to 100% of their salary deferrals that does not exceed 4% of their plan compensation.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan within 30 days after all plan requirements are met. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation in 2024 and 2023 unless the participant makes a contrary election, and their contributions are invested in a designated fund based on the participant's target retirement date until changed by the participant. The Plan currently offers pooled separate accounts and a guaranteed investment account as investment options for participants.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and Employer's matching contribution and allocations of the Employer's discretionary contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Effective January 1, 2019, the 401k Plan changed to a Safe Harbor Plan. Participants are vested immediately in safe harbor matching contributions.

Participants vest in employer discretionary contributions based on the following schedule:

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid over a five year period, unless for the purchase of a primary residence, in which case, the maximum duration of the loan may be up to 25 years. The loans are secured by the balance of the participant's account and bear interest at the prime rate (7.50% at December 31, 2024 and 8.50% at December 31, 2023). Principal and interest are paid ratably through payroll deductions.

(f) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, the participant's vested benefits are distributed to the participant, or the beneficiary of the participant, in a single lump sum or installment payments.

(g) Forfeited Accounts

Forfeited accounts may be used to reinstate former participant forfeitures, reduce future Employer contributions and/or used to offset Plan expenses. At December 31, 2024 and 2023, there were \$28,719 and \$64,029 in forfeited nonvested accounts, respectively. During 2024, approximately \$92,000 of forfeitures were used to reduce employer contributions.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, Continued

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer's Pension and Investment Committee determines the Plan's valuation policies utilizing information provided by their investment adviser and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(g) Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

(3) Investment Contract with Insurance Company

The Plan maintains a benefit-responsive investment contract (Voya Fixed Account) with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Units of pooled separate accounts are valued at each account's net asset value (NAV) as determined by the custodian as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Certified Information

Certain information related to assets held for investment in the plan (certified information) at December 31, 2024 and 2023 disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, other income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by the management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the custodian of the Plan).

(6) Party-in-Interest Transactions

Certain Plan investments are either shares of mutual funds held by Voya or an investment contract issued by Voya. Voya provides administration and custodial services to the Plan and therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Voya during 2024 and 2023 amounted to \$23,616 and \$11,640, respectively. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts. These transactions qualify as exempt party-in-interest transactions.

(7) Plan Termination

Although it has not expressed any intent to do so, the Plan has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

(8) Tax Status

The Plan and trust have been established using a non-standardized prototype plan designed and maintained by the Plan's third-party administrator. The Internal Revenue Service (IRS) has determined and informed the prototype sponsor by a letter dated June 30, 2020 that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
