Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Component Assembly Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Component Assembly Systems, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Fidelity Management Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Note 1 - Description of Plan

The following description of Component Assembly Systems, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on October 1, 1995 and is a defined contribution plan covering substantially all eligible employees of Component Assembly Systems, Inc. (the "Company") and its wholly-owned subsidiaries who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Fidelity Management Trust Company is the trustee of the trust established as part of the Plan.

Contributions

Each year, participants may contribute up to 90% of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the "Code") for 2024 of \$22,500, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees are subject to additional limits set forth in the Code. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant.

The Company can make a discretionary matching contribution to the Plan in an amount equal to a percentage of the participants' elective deferrals. For the year ended December 31, 2024, the Company made a discretionary matching contribution to the Plan in the amount of \$162,832.

The Company can make an additional discretionary profit sharing contribution, the percentage of which is determined on an annual basis by the Company. Such contributions are deemed to be employer nonelective contributions. For the year ended December 31, 2024, the Company did not make an additional discretionary profit sharing contribution to the Plan.

Additionally, to the extent necessary, the Company shall contribute to the Plan the amount necessary to provide the top-heavy minimum contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, allocations of the Company's additional discretionary profit sharing contributions (if any), Plan earnings, and forfeitures, as applicable, and charged with an allocation of administrative expenses (if any). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the portion of participant account balances related to the Company's matching contributions and additional discretionary profit sharing contributions (if any) is based on years of continuous service. A participant shall have a vested percentage in their employer contribution accounts according to a graded vesting schedule as follows:

2	20%
3	40%
4	60%
5	80%
6	100%

In addition, upon the participant's death, disability and attainment of age 65 (normal retirement), all amounts become immediately vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. A participant requesting a Plan loan must have a minimum vested account balance of \$1,000 to be eligible. The loans are secured by the balance in the participant's account and bear interest at the prevailing interest rate, as defined by the Plan. The interest rate is determined as of the date of origination and is fixed for the loan term. Principal and interest are paid ratably through monthly payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the maximum repayment period is ten years.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant immediately becomes fully vested and will receive the full value of their account in a lump-sum amount or in installment payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Participants age 59½ or older may take distributions during employment and may elect to receive the value of the vested interest in their account under a systematic withdrawal plan.

Hardship Withdrawals

Participants may withdraw their vested balances if they meet the hardship-withdrawal provisions contained in the Plan. Withdrawals made under this provision are subject to applicable income taxes and penalties.

Forfeitures

Forfeitures of nonvested matching contribution portions of participant balances may be used to offset current and future employer contributions or reduce administrative expenses. Forfeitures of other nonvested amounts are to be allocated to the eligible participants in the same proportion that each participant's compensation bears to the compensation of all participants for such year. Forfeited amounts of \$27,977 were used to reduce Plan expenses during 2024. The forfeited amount of \$18,268 was transferred to the forfeiture account during 2024. At December 31, 2024 and 2023, the balance in the forfeiture account totaled \$3,956 and \$13,135, respectively.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 (the "SECURE 2.0 Act") was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act builds on the SECURE Act of 2019, which revised existing rules around retirement saving, and contains dozens of new retirement-related provisions with effective dates beginning January 1, 2024 and beyond. The SECURE 2.0 Act is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. However, there was no impact to the Plan's 2024 or 2023 financial statements.

Effective April 1, 2025, the Company elected to adopt the following withdrawal provisions of the SECURE 2.0 Act: a) Domestic Abuse Withdrawals for participants who are victims of domestic abuse, as defined under Section 314; b) Emergency Expense Withdrawals for emergencies, as defined in Section 115; c) Qualified Federally Declared Disaster Withdrawals, as defined in Section 331, and d) Qualified Birth or Adoption Distributions, as defined in Section 113.

Effective on or about January 1, 2024 and January 1, 2025, respectively, the Company elected to not opt out of a unilateral amendment advanced by Fidelity Workplace Services LLC, and thus adopt the following provisions of the SECURE 2.0 Act: a) Increase in Dollar Threshold for Mandatory Cash-Out Distributions, as defined in Section 304 and b) Increased Catch-Up Limits for Ages 60, 61, 62 and 63, as defined in Section 109.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The interest portion included in each loan payment is recognized as interest income in the participant's individual account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest rates on loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company.

The following information, including cash, investments and notes receivable from participants at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued at the NAV of units of the bank collective trust and composed primarily of fully benefit-responsive investment contracts. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Fair Value Measurement (cont'd.)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 5 - Administration of Plan Assets

The Plan's assets, which consist principally of units of participation in mutual funds and unallocated general account contracts, are held by the trustee of the Plan. Company and participant contributions are held and managed by the trustee, which invests cash received and interest and dividend income and makes distributions to participants. All investment decisions are made by the participants in the Plan using a self-directed provision. Fidelity Workplace Services LLC, the recordkeeper, performs nearly all administrative functions of the Plan, including setting up new accounts, initiating withdrawals, calculating participant's vesting percentages, performing top-heavy and discrimination tests on the Plan, and all administrative functions regarding participant loans.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Generally, all administrative expenses for the Plan are paid by the Company.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, the trustee as defined in the Plan. Therefore, these transactions qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules.

Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax Status of the Plan

Effective June 23, 2021, the Company adopted the pre-approved plan document of FMR LLC. The Internal Revenue Service ("IRS") has determined and informed FMR LLC by an opinion letter dated June 30, 2020, that the pre-approved plan document is designed in accordance with applicable sections of the Code. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt. Prior to June 23, 2021, the IRS had determined and informed FMR LLC by a letter dated March 31, 2014, that the Plan and related trust were designed in accordance with applicable sections of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11 - Delinquent Participant Contributions

During the year ended December 31, 2024, the Company did not submit certain employee contributions of \$33,728 in a timely manner. This required the Company to file a notice with the Internal Revenue Service and the Department of Labor, which will result in the payment of an excise tax by the Company. Subsequent to year-end, the Company made corrective contributions through the Voluntary Fiduciary Correction Program ("VFCP").

Note 12 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after December 31, 2024 through October 8, 2025, which is the date that the financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure, except as discussed in Notes 1 and 11.
