**Note 1 - Plan Description**

The following brief description of the Cleveland Mack Sales, Inc. 401(k) Plan, (the Plan), is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Cleveland Mack Sales, Inc. dba Performance Truck and Houston Heavy Duty Truck and Trailer (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on January 1, 1976 and has subsequently been amended.

**Plan Administration**

Delaware Charter Guarantee and Trust Company dba Principal Trust Company serves as the trustee of the Plan. An employee of the Company is appointed to serve as the plan administrator and is responsible for the oversight of the operation and administration of the Plan.

**Eligibility**

The Plan is provided for all eligible employees who are at least 18 years old and who have completed 60 days of service, as defined. The Plan includes a savings feature designed to permit the employee and the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC).

**Contributions**

Participant contributions consist of pre-tax and/or Roth elective deferral contributions and are made to the Plan by electing to contribute a portion of the employee's compensation, as defined, subject to the maximum limit allowed by law. All newly eligible employees automatically begin deferring 6% of their compensation unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are made on a pre-tax basis unless the employee affirmatively designates that any portion or all of the contributions be treated as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, individual retirement accounts and certain other qualified sources as defined in the plan document.

For the year ended December 31, 2024, the Company made matching contributions in an amount equal to 50% of the participant's elective deferral contributions not to exceed the lesser of 6% of compensation or \$2,971. The Company may also make additional discretionary contributions in accordance with the plan document. For the year ended December 31, 2024, the Company did not make any additional discretionary contributions.

**Participant Accounts**

Participants direct the investment of their accounts into various investment options offered by the Plan. Under the Plan, earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document. Additionally, certain transactional fees such as loan and distribution fees, as applicable, are charged to participant accounts.

Net assets available for benefits include the accounts of active participants as well as certain separated, vested and retired participants who have elected to receive their benefits in installment payments or elected to defer receipt of their benefits to a later date. These participants share in the earnings and expense allocations of the Plan, as applicable.

**Vesting**

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Vesting in Company contributions is based on years of service. A participant becomes 20% vested upon the completion of two years of service and vests 20% annually each subsequent year with complete vesting after six years of service. Additionally, regardless of the vesting schedule, participants become fully vested upon reaching early or normal retirement age, death or total and permanent disability.

**Forfeitures**

There were \$143,065 and \$110,490 of forfeited non-vested amounts available at December 31, 2024 and 2023, respectively. Forfeitures can be used to reduce future Company contributions or to pay for plan expenses. During 2024, \$114,773 of forfeitures were utilized to offset Company contributions and \$2,546 of forfeitures were utilized to pay administrative expenses.

**Notes Receivable from Participants**

Notes receivable from participants are loans to participants secured by the vested portion of their accounts. Participants may borrow from their fund accounts up to a maximum equal to the lesser of (a) \$50,000, reduced by the highest outstanding loan balance during the preceding 12-month period ending on the day before the loan is made or (b) 50% of their vested interest in the Plan, reduced by any outstanding loan balance. The minimum loan is \$1,000. Interest rates are based on the prime rate plus 1% on the date of issuance. Principal and interest are repaid through payroll deductions. Loans are to be repaid within five years. Participants may only have one loan outstanding at any given time and no more than one loan will be approved in any 12-month period.

**Benefit Payments**

Distribution of the participant's vested account balance may be made upon termination of employment, death, disability or retirement. Withdrawals may be made by active participants upon attainment of age 59½, due to financial hardship and other allowable reasons as permitted by the plan document. Participants may elect to have their retirement benefits paid in the form of a single lump sum payment or fixed installment payments. All other distributions are paid as a single lump sum payment. Upon termination of employment, death or retirement, participants with an account balance of \$1,000 or less shall receive an automatic lump sum distribution from the Plan. For participants with an account balance greater than \$1,000 but less than \$7,000, the plan administrator shall make a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income tax on contributions and income earned.

**Note 2 - Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments of the Plan, except for the fully benefit-responsive guaranteed interest contract reported at contract value, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments bought and sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are collateralized by the respective participant account balance. In general, notes receivable from participants are placed into default in the calendar quarter following the quarter in which no payment on the note is made and are recognized as distributions based upon the terms of the plan document.

**Benefit Payments**

Benefit payments paid to participants or beneficiaries are recorded when paid.

**Administrative Expenses**

Certain administrative expenses are paid by the Plan. Fees related to the administration of notes receivable from participants and certain other administrative and transactional fees are charged directly to the participant's account. All other administrative costs are paid by the Plan unless paid by the Company, at its discretion. Investment-related expenses are included in the net appreciation or depreciation in the fair value of investments.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances, and the amounts reported in the financial statements.

**Note 3 - Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Delaware Charter Guarantee and Trust Company dba Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to the financial statements as to investments, notes receivable from participants, investment income, interest income on notes receivable from participants, and all of the related information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon these certifications.

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* These are valued daily based upon their quoted market prices.

*Self-Directed Brokerage Accounts:* These investments include common stocks, mutual funds and other investments that are valued daily based on their quoted market prices.

*Pooled Separate Accounts:* These funds are valued at their net asset values (NAV) as determined by the issuer, based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

**Note 5 - Guaranteed Interest Contract with Principal Life Insurance Company**

The Plan has a fully benefit-responsive guaranteed interest contract with Principal Life Insurance Company (Principal). The Principal Fixed Income Guaranteed Option is backed by the general account of Principal; however, contributions to this investment do not entitle the Plan to participate in the investment experience or performance of Principal's general account. The guaranteed interest contract has a fixed rate of interest. Under the terms of the contract, the composite crediting rate is currently reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate, which ranges between 1% and 3% depending on prevailing market conditions.

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. A plan fiduciary-directed surrender or transfer will be subject to a 12-month advance notice or a 5% surrender charge, whichever the plan administrator chooses. There are no reserves against contract value for the credit risk of Principal or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Principal. Such events include (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

**Note 6 - Federal Income Tax**

The pre-approved plan adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving its IRS letter; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

**Note 8 - Late Remittances**

As reported on the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$128 of participant contributions to the Plan relating to the 2023 plan year, within the applicable time frame specified by the DOL's Regulation CFR 2510.3-102. The contributions, including lost earnings were corrected during 2024.

**Note 9 - Party-in-Interest Transactions**

The guaranteed interest contract, pooled separate accounts and the self-directed brokerage accounts are issued or managed by Principal, an affiliate of the trustee of the Plan and, therefore, transactions relating to these investments qualify as party-in-interest transactions. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

**Note 10 - Subsequent Events**

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

Effective January 15, 2025, the Plan was amended to increase the number of loans outstanding at any given time per participant to no more than two and to eliminate hardship distributions.
