INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Walsh Duffield Companies, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Walsh Duffield Companies, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Walsh Duffield Companies, Inc. 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General – The Plan is a defined contribution plan covering most employees of Walsh Duffield Companies, Inc. (the “Company” or “Plan Sponsor”) who are age twenty-one (21) or older and have completed three months of service. The Plan contains an automatic enrollment feature upon an employee meeting the eligibility requirements, which begins at 6%. Employees have the option to opt out of automatic enrollment, if desired. The Plan is sponsored and administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Upon meeting the eligibility requirements, participants may make contributions to the Plan in the form of salary deductions of up to 100% of their compensation. Participant contributions are limited by the maximum allowable contribution under the Internal Revenue Code (the “Code”). Participants age 50 or older can elect to make a catch-up contribution subject to Code limitations. Participants may also contribute rollover amounts representing distributions from other defined contribution plans and certain IRAs. The Company makes a safe harbor contribution for eligible participants in an amount equal to 3% of employee compensation. The Company makes an additional contribution for eligible participants in an amount equal to 4% of employee compensation.

Participants’ Accounts – Each participant’s account is credited with the participant’s contributions, an allocation of the Company’s contributions, and all earnings thereon.

Plan Termination – Although it has not expressed any intent to do so, the Company has a right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Vesting – Participant and employer safe harbor contributions immediately vest 100% to the participant. Additional employer contributions and earnings thereon vest over six years of service. Regardless of years of service, participants are fully vested upon disability or death.

Forfeitures – Participants not fully vested in employer contributions upon termination of employment forfeit their non-vested balances, which are used to reduce employer contributions or plan expenses. During the year ended December 31, 2024, \$19,419 of forfeitures were used to reduce employer contributions. There were no forfeitures available at December 31, 2024 and 2023.

Payment of Benefits – Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan can be made in lump-sum or annuity payments. A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from “hardship”, as defined in the plan document.

1. DESCRIPTION OF PLAN (continued)

Notes Receivable from Participants – Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance, with a minimum of \$1,000. Notes must be repaid within five years. Interest is charged commensurate with local prevailing rates. Note repayments and interest are directed to the investment funds elected by the participant. Notes bear interest at rates ranging from 5.50% to 10.50% and mature through August 2029. Principal and interest are paid ratably through regular payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan has established standards for determining the fair value of assets and liabilities which are subject to reporting at fair value in accordance with accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Common collective trusts: Valued based on the net asset values (“NAV”) practical expedient of units held by the Plan at year end, and generally have no redemption restrictions or unfunded capital commitments.

Mutual funds: Valued based on quoted market prices available on an active market, which represent the NAV of the shares held by the Plan at year end.

Pooled separate accounts: Measured at fair value based on the NAV of units held by the Plan at year end using the NAV practical expedient.

Participant directed brokerage account: Valued at the closing price reported in the active market in which the underlying securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Costs of administering the Plan are shared by the Company and participants.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Subsequent Events – Management of the Plan has evaluated the effects of all subsequent events through September 18, 2025, the date which the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, with the exception of the common collective trusts and pooled separate accounts, which are measured at fair value using the NAV practical expedient. The fair value for the common collective trusts and pooled separate accounts are provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The Plan's investments consist of common collective trusts, mutual funds, pooled separate accounts, and a participant directed brokerage account, some of which are managed by Principal Financial Group and Subsidiaries. As Principal Life Insurance Company, the Plan's custodian, is a member of the Principal Financial Group, these transactions qualify as party in interest transactions.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.
