Opinion

Third Federal Savings Associate Stock Ownership Plan

1 Description of Plan

The following description of the Third Federal Savings Associate Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all eligible employees of Third Federal Savings and Loan Association of Cleveland and Subsidiaries (Association).

Effective May 2007, the Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Retirement Plan Committee of the Association (Committee).

The Plan purchased 10,653,024 shares of TFS Financial Corporation (Company) common stock in 2007 using the proceeds of a bank borrowing (see Note 7) and holds the stock in a trust established under the Plan. The stock was purchased at a price of \$10.00 per share, for an aggregate purchase price of \$106,530,240.

The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against shares once they are allocated to participants in accordance with the provisions of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the years then ended present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with vested rights in allocated stock (Allocated), and
- (b) stock not yet allocated to employees (Unallocated).

Eligibility:

Any employee of the Association age eighteen years or older and who has completed one year of eligibility service is eligible to participate in the Plan. A participant is required to work 1,000 hours during the Plan year and be employed on the last day of the Plan year to be eligible to receive an allocation of the contributions.

Contributions:

The Association may make discretionary contribution, as authorized by the Board of Directors of the Company. The Association may contribute an amount to the Plan which, when aggregated with the Plan's dividend and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payment of principal and interest due on its term loan. Employee contributions are not permitted.

The Association's contributions, if any, may be made in cash or common stock of the Company, or both. For the Plan years ended December 31, 2024 and 2023, the contribution was made in cash and allocated based on the number of eligible participants at year end.

Participant Accounts:

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with the participant's allocation of (a) the Association's contribution and (b) forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible as of the last day of the Plan year will receive an allocation. Allocations of Association contributions are based on a specified allocation schedule, as defined. The Plan's earnings and losses are allocated based on the ratio of the balance of the portion of such account in the trust as of the preceding valuation date less any withdrawals, distributions and transfers from the account since the valuation date to the aggregate balances of the portions of all accounts in the trust fund with similar adjustments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Vesting in the Association's account balance is based on years of service in accordance with the table below:

Forfeitures:

Forfeited amounts will be used to first pay administrative expenses of the Plan or used to re-credit any accounts for participants who have been re-employed by the Association. Any remaining forfeitures are to be allocated to participant accounts in the same manner as the employer contribution. For the Plan years ended December 31, 2024 and 2023, \$199,929 and \$155,283, respectively, were allocated to eligible participants. Unallocated forfeitures amounted to \$0 at December 31, 2024 and 2023, respectively.

Payment of Benefits:

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Distributions may be made in the form of shares of Company stock, with any portion of fractional shares paid in cash, or a participant may transfer the value of the vested interest in his or her account to the trustee or custodian of another qualified plan.

Effective January 1, 2013, the Plan was restated to provide for mandatory distributions to terminated participants with vested balances less than \$5,000 if the participant has not elected to receive a distribution as soon as reasonably practicable following the termination date.

Diversification and Transfers to Third Federal 401(k) Savings Plan:

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least five years of vested service may elect to transfer all or any portion of their accounts to the Third Federal 401(k) Savings Plan. For the Plan years ended December 31, 2024 and 2023, total diversifications were \$2,198,318 and \$2,110,371, respectively.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Allocations:

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Valuation of Investments:

The Plan's investments are stated at fair value. Company common stock is valued at a quoted market price. The closing market price of the Company's common stock at December 31, 2024 and 2023 was \$12.56 and \$14.69, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased, sold, and held during the year.

Payment of Benefits:

Benefit payments to participants are recorded upon distribution.

Administrative Fees:

As provided by the Plan agreement, reasonable expenses incident to the operation of the Plan, including trustee fees, may be paid either by the Plan or by the Association.

Plan Termination:

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Risks and Uncertainties:

The Plan's investments include Company stock. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits. The closing market price of the Company's common stock as of the date of these financial statements was \$13.11.

Subsequent Events:

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining and the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

3 Fair Value Measurements

Under generally accepted accounting standards, a framework has been established for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under the framework are described below:

- * Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- * Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - * Quoted prices for similar assets or liabilities in active markets;
 - * Quoted prices for identical assets or similar assets or liabilities in inactive markets;
 - * Inputs other than quoted prices that are observable for the asset or liability;
 - * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

3 Fair Value Measurements, Continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

* Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stock: Valued at the closing price reported on the active market on which the individual securities were traded.

There were no changes to the valuation techniques used in fair value measurements at December 31, 2024 and 2023.

5 Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 27, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

6 Related Party and Party-in-Interest Transactions

The Plan's investments consist of shares of TFS Financial Corporation and the Plan has a loan payable to TFS Financial Corporation. The Association is the Plan sponsor, and TFS Financial Corporation is the parent company of the Plan sponsor. Therefore, these transactions qualify as related party transactions. Certain professional fees for the administration and audit of the Plan were paid by the Association. Plan expenses relate to the administration of the Plan by Principal Financial Group, the Recordkeeper as defined by the Plan, or Principal Trust Company, the Trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions.

7 Loan Payable

In 2007, the Plan entered into a \$106,530,240 term loan agreement with TFS Financial Corporation. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments.

The agreement provides for the loan to be repaid over thirty years. The loan bears interest at the prime rate, adjusted each year on January 1st (8.50% for 2024 and 7.50% for 2023). The annual principal and interest payment may change each year due to principal pre-payments and interest rate adjustments. The interest rate adjusted several times since January 1st, most recently to 7.50%.

8 Administration of Plan Assets

The Plan's assets, which consist principally of Company common shares, are held by the Trustee of the Plan.

The Association's contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee is also responsible for making interest and principal payments on the outstanding loan, which is reimbursed to the Trustee through contributions as determined by the Association.

Certain administrative functions are performed by officers or employees of the Association or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid by the Plan, or if elected, directly by the Association.

9 Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares in the same proportion as the voting instructions it receives from participants for allocated shares.
