We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of ASPIRO, Inc. (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Description of Plan

The following brief description of 403(b) Thrift Plan of ASPIRO, Inc. (Plan) provides only general information. More complete information regarding the Plan's provisions may be found in the Plan document.

#### General

ASPIRO, Inc. (Organization) established the Plan to provide employees with a systematic means of saving and investing for the future. All permissible employees of the Organization, as defined in accordance with the universal availability standards, unless they choose to opt out, will be automatically enrolled at 1%. All full time employees of the Organization who have 1 year of service, are age 18 or older, and are deferring at least 1% are eligible to receive the Organization's match contribution, effective the first day of the subsequent month after becoming eligible. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

#### Contributions

Participants are eligible to elect to defer 100% of their compensation as a pretax or Roth contribution each year not to exceed the thresholds set by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also transfer to the Plan amounts representing distributions from other 403(b) or qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization provides a contribution to all eligible employees each pay period so long as they are contributing at least 1% of their compensation. The Organization's match contribution is 5% of total qualified participant compensation, as defined by the Plan. The Organization's match contribution is invested directly into the same investment options as directed by the participants. All investments are participant-directed and participants may change their investment options at any time. Contributions are subject to certain limitations.

#### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and allocation of (a) the Organization's match contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balance, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the Organization's base/match contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of service.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants cannot borrow less than \$1,000. Loan terms range from one to five years, except in the case of a principal residence purchase in which the maximum repayment period is ten years. The custodian requires that 120% of the outstanding balance be maintained as collateral and held in a specific account that bears interest at a rate commensurate with similar length loans made by the custodian. Principal and interest are paid ratably through bi-weekly payroll deductions.

### Note 1 - Description of Plan (Continued)

#### Payment of Benefits

Upon retirement, disability, or death a participant or beneficiary receives the entire amount credited to the participant's account in either a lump-sum, or at the participant's or beneficiary's election, an annuity option. Participant balances that are less than \$1,000 are paid via a lump-sum payment. Upon termination, other than by retirement, disability or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum. The Plan also allows for hardship withdrawals of employees' contribution.

#### Forfeited Accounts

At December 31, 2024 and 2023, there were no forfeitures available. Forfeitures of non-vested Organization base/match contributions are first used to reduce certain Plan expenses, if applicable. Any amount of forfeitures remaining will be used to reduce future Organization match contributions to the Plan. During 2024 and 2023, Organization base/match contributions were reduced by \$19,122 and \$7,669, respectively, from forfeited non-vested accounts.

### Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments, except for the interest accumulation account as this is like a cash equivalent, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's custodian.

Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the plan document and the loan policy. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to monthly contract charges, administrative charges and forfeiture processing for participants who are not fully vested are charged directly to the participant's accounts. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Income Taxes

The Organization amended the Plan based on the Prototype Non-standardized 403(b) Plan. The prototype has received a favorable opinion letter from the Internal Revenue Service. As such, the Plan qualifies under Section 403(b) of the Internal Revenue Code and, therefore, is not subject to tax under present income tax laws. The plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while that Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Party-in-Interest Transactions

Certain Plan investments are managed by Mutual of America Life Insurance Company (Mutual of America) and Associated Trust Company, N.A. (Associated) starting January 2024. For 2023, Plan investments were managed by Mutual of America. Associated and Mutual of America are the custodians as defined by the Plan. During 2024, fees paid to Associated of \$27,720 and fees paid to Mutual of America of \$102 qualify as party-in-interest transactions. During 2023, investments were managed by Mutual of America. Mutual of America was the custodian as defined by the Plan during 2023, and fees of \$613 paid to Mutual of America qualified as party-in-interest transactions. Certain employees and officers of the Organization, who are also participants in the Plan, performed administrative services to the plan at no cost to the Plan.

Associated and Mutual of America (Service Providers) provide certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Organization and Service Providers. The Service Providers receive revenue from mutual fund service providers for services the Service Providers provide to the funds. This revenue is used to offset certain amounts owed to the Service Providers for its administrative services to the Plan.

If the revenue received by the Service Providers from such mutual fund service providers exceeds the amount owed under the MSA, the Service Providers remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Organization may make a payment to the Service Providers for administrative expenses not covered by revenue sharing.

### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 7 - Information Certified by the Plan's Custodians**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Associated Trust Company, N.A. (January 3, 2024 to December 31, 2024 and Mutual of America Life Insurance Company (January 1, 2023 to December 31, 2024) (the custodians of the plan).

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
