- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Zippo and Affiliates 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan, established as of January 1, 1988, is a defined contribution plan covering substantially all employees of Zippo Manufacturing Company, W.R. Case Cutlery Company, and Northern Lights Enterprises, Inc. (collectively, Company or Plan Sponsor). Employees are eligible to participate immediately upon hire.

Contributions - Generally, the Plan provides that employees may make regular pretax contributions of 1% to 75% of their salary. The Plan also allows for after-tax Roth contributions. Employees may direct their contributions to be invested entirely in one fund or allocated among all funds, subject to allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers of presently invested contributions among funds are permitted pursuant to the Plan's provisions.

Prior to May 1, 2003, participants could elect to have any part of their accounts that resulted from employee contributions applied to the purchase of life insurance. The total of all life insurance purchased could not exceed 49.9% of the total contributions for ordinary life insurance and 24.9% of the total contributions for term and universal life insurance. Effective May 1, 2003, the insurance option is no longer available to new participants.

The Plan includes automatic enrollment. Effective January 1, 2018, all eligible employees who were not currently participating in the Plan, or were participating below 3%, were automatically enrolled at a salary deferral rate of 3% and a bonus deferral rate of 3%. Unless otherwise elected, contributions will be invested in a designated balance fund until changed by the participant. All employees who were contributing less than 12% salary deferral rate will have their deferral automatically increased by 1% each year up to a maximum 12% deferral unless the participant opts out of the annual increase. The Company makes matching contributions of 100% of salary deferral contributions up to 3% of eligible compensation plus 50% of the next 2% of salary deferral contributions for a maximum employer match of 4%. All new hires of Zippo Manufacturing Company and W.R. Case Cutlery Company are subject to both automatic enrollment and automatic contribution increase. Employees of Northern Lights Enterprises, Inc. are not subject to the automatic enrollment and contribution automatic increase.

The Company will also make additional contributions for participants hired prior to January 1, 2008, equal to 4% of participant's annual compensation for the Plan year.

Zippo Manufacturing Company and W.R. Case Cutlery Company employees hired between January 1, 2008 and December 31, 2022 are also eligible for the additional contribution, determined as follows:

To be eligible for the additional contribution, these employees must be employed as of the last day of the Plan year and credited with a minimum of 1,000 hours of service in the Plan year.

Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or other specific participant transactions, as defined. The benefit to which a Plan member is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures - The non-vested balance of a terminated participant's account is first used to pay administrative expenses. Any remaining forfeitures are then used to reduce employer contributions. Forfeitures were immaterial to the financial statements during 2024 and 2023.

Vesting - Participants are vested immediately in their contributions, Company matching contributions and actual earnings thereon. Vesting in the Company's additional contribution portion of accounts is based on years of credited service. A participant is 100% vested after three years of credited service. Prior to completing three years of credited service, participants are 0% vested.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes are secured by the balance in the participant's account. All notes have a five-year maximum repayment period. The interest rate is set at prime rate at the time the note is taken. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits - On retirement, termination of employment or death, a participant is entitled to the full value of his or her vested account balance. Distributions may be made in cash, an annuity or a rollover. Distributions of account balances of less than \$5,000 are made upon termination of service. Inactive participants must maintain a balance of \$5,000 in the Plan; otherwise, their account balance will be distributed as cash or rollover. A participant who has attained age 59½ may withdraw any part of their vested account resulting from the elective deferral contributions, matching contributions and additional contributions. Hardship withdrawals are permitted by the Plan and are limited to employee elective deferrals plus income allocable.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements, while other fees related to the administration of the Plan are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value in investments.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - Valued at net asset value (NAV). The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Collective Trust Funds - Valued at the NAV of units of a collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value, based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Unallocated Insurance Contracts - Valued at cash surrender value, which approximates fair value by discounting the cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The preceding methods described might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The pooled separate accounts in this category are primarily “target date funds” that seek a total return consisting of long-term growth and current income. Selected funds within this category may invest in domestic and foreign equity, real assets and alternative investments, and fixed-income funds.
- (b) The pooled separate accounts in this category primarily invest in equity securities of U.S. companies with large market capitalization. Selected funds within this category may invest in stocks of foreign companies, convertible debt securities and real estate investment trusts.
- (c) This category represents common collective trusts. These accounts invest mainly in short-term securities, such as commercial paper.

- (g) The pooled separate accounts in this category invest a majority of assets in common stocks of companies that compose the S&P 500, 600 and 400 indices.

NOTE 4 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (Principal) and Massachusetts Mutual Life Insurance Company (Mass Mutual) (the trustees of the Plan).

NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal and Mass Mutual, which are trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, since they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations. In addition, certain administrative functions are performed by officers and employees of the Company at no cost to the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan has no uncertain tax positions at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan would record interest and penalties as administrative expenses, if incurred. There were no interest or penalties recognized in the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Subsequent Events - Subsequent events are defined as events or transactions that occur after December 31, 2024 through the date on which the financial statements are available to be issued. Management has evaluated subsequent events through October 3, 2025, the date that the financial statements were issued, and determined that there were no events that occurred that would require adjustments to our disclosures.
