Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Neighborhood Health Center of WNY, Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The following description of the Neighborhood Health Center of WNY, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General — The Plan is a defined contribution plan covering substantially all employees of Neighborhood Health Center of WNY, Inc. (the “Center” or “Employer”). Generally, an employee may begin making elective deferrals into the Plan as of their date of hire. To participate in the employer match on eligible elective deferrals and employer profit sharing contributions of the Plan, employees must complete one year of service, as defined, and be age 18 or older.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Principal Financial Group (“PFG”) is the record keeper for the Plan and Principal Trust Company, a subsidiary of PFG, is the custodian. Principal Life Insurance Company (“PLIC”), a member of PFG, manages the single annuity contract.

Contributions — Each year, participants may contribute any amount up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (“IRC”), and as defined in the plan agreement. The Plan also permits participants age 50 or older to make catch-up contributions as defined. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Roth elective deferrals are permitted under the Plan.

The Plan provides for discretionary matching contributions on eligible elective deferrals in an amount determined by the Center on an annual basis. Eligible participants will share in any discretionary matching contributions after they complete one year of service, as defined and credited with at least 1,000 hours of service and are actively employed on the last day of the plan year. Catch-up contributions from participants are not subject to matching contributions. For the year ended December 31, 2024, the Center’s matching contribution was 50% of the employee’s elective deferral contribution up to 4% of the employee’s pay, as defined. The Center’s 2024 Matching Contribution of \$344,444 was received by the Plan on February 13, 2025 of which \$314,303 was funded in cash and \$30,141 was funded from nonvested forfeited accounts.

The Center may also make profit-sharing contributions in its discretion which will be allocated among all eligible employees. Eligible participants will share in any discretionary profit-sharing contributions if they are actively employed on the last day of the plan year and have completed 1000 hours during the plan year. There were no profit-sharing Contributions during the year ended December 31, 2024.

All contributions are subject to certain IRC limitations.

Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan. If no investment election is received from the participant, contributions will be directed according to the plan’s default investment.

Vesting — Participants are vested immediately in their elective deferral contributions, rollover contributions, catch-up contributions plus actual earnings thereon. Employer contributions to the plan, plus any earnings they generate, are vested based on years of service. A participant becomes 100 percent vested after five years of credited service.

Participant Accounts — Individual accounts are maintained for each Plan participant. Each participant's account is increased by participant contributions, the Center's matching contributions, if any, and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and the participant's share of expenses and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits — Upon termination for any reason, a participant may elect to receive the value of the participant's vested account in a single lump-sum payment, as defined. In-service distributions, including hardship withdrawals are permitted under the Plan subject to Plan provisions.

Notes receivable from participants — Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. All loans bear a reasonable rate of interest as determined by the plan administrator. Principal and interest is paid concurrent with payroll deductions.

Forfeited Accounts — Forfeited balances of terminated participants' nonvested accounts are used to reduce future Center contributions, if any. At December 31, 2024 and 2023 forfeited account balances were \$31,179 and \$15,993, respectively. Forfeited nonvested accounts totaled \$28,331 during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting — The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits — Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Continued)

Administrative Expenses — Certain expenses of maintaining the Plan are paid directly by the Center and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Market Risk Factors — The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the accompanying financial statements.

Subsequent Events — Plan management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

3. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(a) The single group annuity contract at December 31, 2024 is measured at contract value and has not been classified in the fair value hierarchy. The contract value amounts presented in the above table is intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. See Note 4.

4. Investment Contract with Principal Life Insurance Company

The Plan invests in a single group annuity contract with a fixed rate of interest. In accordance with ASC Subtopic 820-10, this investment is presented in the financial statements at its contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Under the terms of the contract, the crediting rate is reset on a semiannual basis at December 1st and June 1st with a guaranteed minimum interest rate of 1.55%. The average yield earned by the Plan is the interest credited on the single group annuity contract. The crediting interest rate was 1.55% through December 31, 2024.

By definition, a group annuity contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. Interest is credited to the Guaranteed Interest Fund on a daily basis from the date deposits are accepted until paid, transferred or applied in full. Fees may be paid in accordance with the terms of the contract. Certain liquidations are subject to restrictions and surcharges, as defined.

5. Related-Party Transactions and Party-In-Interest Transactions

The group annuity contract is managed by Principal Life Insurance Company, and affiliate of Principal Trust Company. Principal Trust Company is the custodian of the Plan's investments during the year and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees and/or officers of the Center or its affiliates perform administrative services to the Plan at no cost to the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan adopted a volume submitter 403(b) plan document sponsored by FIS Business Systems LLC. FIS Business Systems LLC received an opinion letter from the Internal Revenue Service (IRS), dated March 31, 2017, which states that the volume submitter plan document satisfies the applicable provisions of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Certified Investment Information

The Center, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Principal Trust Company and furnished to the Center. The Center has obtained certifications from Principal Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
