As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Note 1 - Description of Plan

The following brief description of the Save More Retirement Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union employees of the companies listed below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The companies in the Plan include the following controlled group of corporations: Barnard Construction Company, Inc., Barcon, Inc., Barnard Environmental, Inc., Barnard Pipeline, Inc., Interstate Equipment, Inc., Barnard of Nevada, Inc., Barnard Telecommunications, Inc., Continental Pipe Manufacturing Co., Barnard Central America, Inc., Barnard of Australia, Inc., BFBC LLC, Barnard Spencer Joint Venture, and Barnard of Canada, Inc. (collectively "Companies").

Eligibility

Employees not covered by the Davis Bacon Act must be 18 years of age to participate in the Plan. For all employee deferral contributions, employees are eligible to participate immediately upon hire. For all employer match and profit share contributions, employees must have worked 1,000 hours during their first twelve-month period after initial hire date or during one calendar year in order to be eligible to receive a company contribution. Employees covered by the Davis Bacon Act are eligible for prevailing wage employer contributions at the time of hire. Employees subject to collective bargaining agreements are not eligible to participate in the Plan.

Entry Date

Employees may enter the Plan at the time voluntary 401(k) withholding is requested, otherwise employees may enter the Plan on the first day of month coinciding with or following the date they satisfy the Plan's eligibility requirements for company match and profit share contributions. Employees covered by the Davis Bacon Act enter the Plan on the date of hire.

Contributions

Each year, the participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants aged 50 or older before the close of the Plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, Section 414(v) of the Code. The Companies may, but are not required to, contribute matching funds on behalf of the participating employees. The matching contribution percentage is determined at the end of each year. The matching contribution is 100% of the annually declared matching contribution percentage for those participants with salary deferrals equal to or greater than 6% of eligible compensation. The matching contribution is the ratio of the participants' salary deferrals up to 6% multiplied by the matching contribution percentage for those participants with salary deferrals less than 6%. During 2024 and 2023, the Companies declared matching contribution percentage was 5%.

For profit sharing contributions for employees not covered by the Davis Bacon Act, the Companies may, but are not required to, contribute to the Plan an amount determined annually by the board of directors. During 2024 and 2023, the Companies contributions were 5% of the participants' eligible compensation. For employees covered by the Davis Bacon Act, the Companies contribute a fixed dollar amount per hour as determined in the prevailing wage determination for each job. Profit sharing contributions for eligible employees are reduced by any Davis Bacon Act contributions that the employee has received during the year.

Participant Accounts

Each participant's account is credited with the participant's contributions, Companies matching contributions, and allocations of the Companies profit-sharing contributions and Plan earnings. Participant accounts are charged with participant requested or mandatory distributions and certain administrative expenses if a portfolio designed by the investment advisor is selected as the investment allocation. Allocations are based on participant's compensation, account balances, or specific transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their own salary reduction and rollover contributions, plus actual earnings thereon. A participant is immediately vested in contributions and earnings thereon under the Davis Bacon Act. Other participants are fully vested in the Companies' contributions and earnings thereon after completion of two years of credited service, with a minimum of 1,000 hours of service per year.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$51,804 and \$46,011, respectively. These accounts will be used to reduce future employer matching contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$12,962 and \$11,398, respectively, from the forfeited non-vested accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less the participant's highest outstanding loan balance during the previous twelve months, the participant's salary reduction contribution account balance or 50% of their vested account balance. Loan transactions are treated as a transfer from the investment fund to the participant notes receivable. Loans will be permitted only for the purposes of hardship reasons. All loans are required to be repaid within five years of the loan unless the purpose of the loan is to acquire a dwelling unit, which is to be used within a reasonable time as the principal residence of the participant. The notes are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 2%. Principal and interest are paid ratably through payroll deductions or an ACH agreement. A participant may have no more than two outstanding loans at any one time.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ as defined in the Plan document.

Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Employee contributions are recorded in the year in which the contributions are withheld from compensation, along with the related employer match. Profit share contributions are recorded in the year in which the corresponding compensation is paid. Contributions pertaining to the Davis Bacon Act are recorded in the year in which the corresponding Davis Bacon wages are paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$-0- and \$141,883 at December 31, 2024 and 2023, respectively.

Expenses

The Plan's expenses are paid by either the Plan or the Companies, as provided by the Plan document. Expenses that are paid directly by the Companies are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net asset available for benefits. In addition, all mutual funds charge administrative fees to cover the fund's operating costs, including management fees and general administrative expenses, which are netted with the earnings of the funds.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds)– Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust – Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Self-directed brokerage funds – Accounts consist of registered investment companies and money market mutual funds valued at the quoted NAV of shares held by the Plan at year end on the active markets and common stock valued at the closing price reported on the active market on which the individual securities are traded.

Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 5 - Tax Status

The Plan uses an Internal Revenue Service (IRS) pre-approved plan document sponsored by FMR LLC, which received an advisory letter from the IRS dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and money market funds managed by Fidelity Management Trust Company, the trustee, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent Events

Portions of SECURE Act 2.0 (the Act) were required to be implemented for Plan years ending on or after January 1, 2025. The most significant change resulting from the Act affecting the Plan was as follows:

- The Act increases the catch-up limits to the greater of \$10,000 or 50 percent more than the regular catch-up amount in 2025 for individuals who have attained age 60 to 63. The increased amounts are indexed for inflation after 2025.

Portions of SECURE Act 2.0 (the Act) were optional to be implemented for Plan years ending on or after January 1, 2025. The Plan has implemented the following provisions:

- Withdrawal provisions for emergency expenses, domestic abuse, qualified declared disaster and qualified birth or adoption.

The Plan sponsor has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.
