Note 1—Description of the Plan

General – The Caspers Company 401(k) Plan (the “Plan”) was established by JTS Enterprises of Tampa, Limited (d/b/a Caspers Company) (the “Company”, “Employer”, or “Plan Sponsor”) as a defined contribution plan effective June 30, 1971, as amended and restated effective July 1, 2018 and again on March 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Participation – All employees of the Plan Sponsor or its participating affiliates (Caspers Distribution, LLC; Caspers Service Company, LLC) who have completed at least three months of service and have attained the age of 18 are eligible to participate. Participants may enter the Plan after completion of the service requirements. Participants must have completed 1,000 hours of service within the Plan year and be actively employed on the last day of the Plan year to share in the Employer contribution.

Contributions – Participants may contribute up to 80% of their total annual compensation, not to exceed certain IRC limitations, on an annual basis. Participants who have attained the age of 50 are eligible to make pre-tax catch-up contributions, subject to certain IRC limitations. The Company may make discretionary-matching contributions, based on a percentage determined by management, which is computed based on the participants’ elective contributions. The Company may also make additional discretionary contributions to the Plan, which shall be allocated to eligible participants based on a specified formula, as defined. Discretionary-matching contributions to the Plan are made by the Company as determined annually by management of the Company.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company matching contributions portion of their accounts plus actual earnings thereon is based on years of continuous service as defined by the Plan. An active participant who is less than 100% vested is deemed to be 100% vested upon death or total disability. Vesting is determined according to the following schedule:

Participant Accounts – Each participant’s account is credited or charged with the participant’s contributions and withdrawals and an allocation of Plan earnings and losses, Employer contributions, and administrative expenses not paid by the Company. Plan earnings and administrative expenses are allocated to participant accounts based on relative participant account balances.

Forfeitures – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$56,000 and \$28,000, respectively. These amounts may be used to pay Plan expenses or to reduce any nonelective contributions or Employer matching contributions. During the year ended December 31, 2024, no forfeited nonvested amounts were used to pay Plan expenses or reduce any Employer contributions.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount not to exceed the value of the participant’s vested interest in his or her account in either a lump-sum amount, annual installments over the life of the participant and beneficiary, or installments over a period of time not to exceed the assumed life expectancy of the participant or beneficiary. The beneficiary of a deceased participant may also elect to receive benefits over a period of time not exceeding the life expectancy of the beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or an annuity. The Plan also provides for certain hardship withdrawals and non-emergency withdrawals.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

Benefits Paid to Participants – Benefits are recorded when they have been processed and paid by the Plan.

Investments, Investment Valuation, and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations, other than those made using net asset value (“NAV”) as a practical expedient, are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Common/Collective Trust – This investment is an investment vehicle valued using NAV provided by the administrator of the fund, as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is excluded from the valuation hierarchy consistent with U.S. GAAP.

Note 2—Summary of significant accounting policies (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administration Expenses – The Employer may pay some Plan administration expenses with its own assets rather than using Plan assets. To the extent the Employer does not pay Plan expenses with its own assets, the Plan generally will pay the expenses of Plan administration and will assess the expenses paid against the accounts of all participants in the Plan. The Employer may, from time to time, change the manner in which expenses are allocated.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15 of the current year. There were no excess contributions payable for the 2024 year end.

Note 3—Information prepared and certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the qualified institution of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments, at fair value, as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends and interest as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule (schedule of assets).

Note 5—Plan termination

Although the Company has not expressed any intention to do so, it has the right under the terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants are 100% vested in their Employer-matching contributions and the value of each participant's account shall be determined and thereafter distributed in accordance with the provisions of the Plan.

Note 6—Income tax status

The Company adopted a volume submitter profit sharing plan with a cash or deferral arrangement. The volume submitter plan received a favorable opinion letter from the IRS in November 14, 2022, which stated the volume submitter plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan also has no income subject to unrelated business income tax and, therefore, continues to be tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 7—Party-in-interest transactions

Certain administrative expenses are paid to the qualified institution of the Plan, for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. Certain administrative fees have been paid through a revenue sharing agreement with the third party administrator.

Note 9—Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10—Subsequent event

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

Effective June 1, 2025 the Plan was amended to allow for the prior employment service of Caspers Inc., Caspers Group LLC, Admac Enterprises of Tampa LLC, and Pinnacle Hotel Management Company LLC. to count toward eligibility and vesting in the Plan and that prior employment service of Wrights Gourmet House Corporation to count toward vesting in the Plan.

Additionally, effective June 1, 2025 the Plan was also amended to exclude tips and any gross up amounts used to cover taxes on non-cash gift/fridge benefits from the definition of Plan compensation. This includes fringe benefits.
