**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### **NOTE A - DESCRIPTION OF PLAN**

The following description of Accudyn Products, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General and Eligibility:**

The Plan is a defined contribution plan covering substantially all employees of Accudyn Products, Inc. (the Plan Sponsor) who have attained eighteen years of age and have completed three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions:**

Each year, participants may contribute up to the legal limit of pre-tax annual compensation, as defined by the Plan, not to exceed the limits of Internal Revenue Code Section 401(k) of \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of a maximum of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans.

An eligible participant may elect to make both salary deferred savings and Roth 401(k) contributions to the Plan. Employees are auto-enrolled into the Plan at 3% of pre-tax compensation.

The Plan Sponsor may make contributions to the Plan on behalf of the participants under the following provisions:

Discretionary Matching Contribution – The Plan Sponsor may, at its sole discretion, make a matching contribution based on each participant's elective deferrals under the Plan or in an amount equal to a percentage of compensation. The Plan Sponsor matched 100% of each employee's contributions up to 3% of the employee's compensation for 2024.

Discretionary Profit-Sharing Contribution – The Plan Sponsor may, at its sole discretion, make a profit-sharing contribution on each eligible participant's behalf. Such a contribution, if made, will be determined at the end of each plan year. A discretionary profit-sharing contribution of \$-0- was made for the year ended December 31, 2024.

Participants are eligible to receive the discretionary matching and profit-sharing contributions if they have completed at least 1,000 hours of credited service and were employed on the last day of the plan year, unless employment was terminated due to disability, death, attainment of normal retirement age or attainment of early retirement age.

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

##### **Participant Accounts:**

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, Plan Sponsor's contributions, an allocation of the change in market value of the underlying investment, which is based on units owned of the investment, and charged with an allocation of investment fees, which is based on a percentage of the value of the participant's assets.

Each day the investment income and the net realized and unrealized appreciation and depreciation on investments are allocated to participant accounts based on each participant's pro-rata share of the fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Investments:**

Participants direct the investment of their contributions, including matching and profit sharing contributions, and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily, subject to certain restrictions on transfer frequency for certain investments.

##### **Participant Notes Receivable:**

Participants may borrow a minimum of \$500 from their fund accounts up to a maximum of 50% of their total vested account balance, not to exceed \$50,000. The notes are secured by the balance of the participant's account and bear interest at the prime rate plus 1%. The life of a note may not extend beyond five years, unless the note is used to acquire a principal residence, which must be repaid over a reasonable period of time, not to exceed thirty years. Principal and interest is paid ratably through weekly and semi-monthly payroll deductions.

##### **Benefits:**

The Plan provides for normal retirement benefits upon reaching age 65, in addition to early retirement benefits, of which the Plan was amended on June 1, 2023 to include upon the latter of reaching age 60 or completing five years of service. Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive a distribution equal to the vested value of the participant's account. Participants may take distributions from the Plan as rollovers to individual retirement accounts or to another employer plan, or as distributions paid in a single lump sum or in the form of installment payments. Vested account balances of former employees that are below \$7,000 will be distributed within a reasonable period of time. The Plan provides for in-service withdrawals upon reaching age 59 ½. Financial hardship withdrawals are permitted.

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

##### **Vesting:**

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary matching and profit-sharing contributions and earnings thereon is based on years of service, with participants vesting at 25% after the second year and an additional 25% each year thereafter, until fully vested after five years. In the event of death, disability, or attainment of normal retirement age of 65 years old, the full balance of the participant's account becomes immediately vested.

##### **Forfeited Accounts:**

Forfeitures are retained in the Plan and may be used to reduce Plan Sponsor contributions or to pay Plan expenses. Available forfeitures totaled \$8,428 and \$20,065 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions during the year were \$20,065 for the year ended December 31, 2024.

##### **Plan Termination:**

Upon complete or partial termination of the Plan or upon complete discontinuance of contributions by the employer, the participants' interests under the Plan, as of the date of termination, become fully vested and nonforfeitable. The Plan Sponsor has not expressed any intent to terminate the Plan or to discontinue contributions.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting:**

The financial statements have been prepared on the accrual basis of accounting.

##### **Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### **Investment Valuation and Income Recognition:**

Plan investments are stated at estimated fair value, except for fully benefit-responsive investment contracts, in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in insurance contracts are carried at contract value as determined by the insurance company.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### **Investment Valuation and Income Recognition (Continued):**

Net appreciation or depreciation in the fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold as well as held and distributed and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### **Participant Notes Receivable:**

Notes receivable from participants are recorded at their unpaid balances plus any accrued interest. Notes receivable from participants are written off when deemed not collectable.

##### **Allowance for Credit Losses:**

Plan receivables include employee contributions receivable and employer contributions receivable. Plan receivables are stated at the amounts owed from either participants or the employer. The potential risk is limited to the amount recorded in the financial statements. Plan management has determined that no allowance for credit losses is necessary due to the nature of the receivables and historical loss information at December 31, 2024 and 2023.

##### **Payment of Benefits:**

Benefit payments to participants are recorded when paid.

##### **Administrative Expenses:**

Administrative expenses of the Plan are paid by the Plan Sponsor or the Plan, as provided in the Plan document.

##### **Subsequent Events:**

Management evaluated all activity of the Plan through October 6, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

#### **NOTE C - TAX STATUS**

The Plan was established using CCH Incorporated dba FTWILLIAM Com, Non-Standardized Pre-Approved Profit Sharing Plan With CODA Plan, which, according to an opinion letter dated July 13, 2021 from the Internal Revenue Service, may be relied upon by an employer to adopt and qualify as an approved plan under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt.

#### **NOTE D - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Lincoln National Life Insurance Company, the custodian of the Plan. The plan administrator has obtained certifications from the custodian as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the information provided to the plan administrator by the custodian is complete and accurate. Information as to the value of the investments in the Plan, investment income (loss), and all information in the supplemental schedule is presented in reliance solely upon those certifications.

#### **NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds a group variable annuity contract. This contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

With group variable annuity contracts, the Plan owns only the contract itself. Group variable annuity contracts are designed to accrue interest based on credit rates established by the contract issuers. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The credit rating is based on a formula established by the contract issuer but may not be less than one percent. The credit rating is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured breach of the Plan's investment guidelines
2. A violation of a material obligation under the contract
3. A material misrepresentation
4. A material amendment to the contract without the consent of the issuer.

#### **NOTE F - FAIR VALUE MEASUREMENTS**

FASB ASC 820 establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE F - FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used attempt to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds held and managed by Lincoln National Life Insurance Company. Lincoln National Life Insurance Company is the custodian and recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions. These funds had a value of \$5,775,656 and \$4,791,681 at December 31, 2024 and 2023, respectively. Administration fees are paid by the Plan to Lincoln National Life Insurance Company, the custodian and recordkeeper, and to Merrill Lynch, the investment advisor. The Plan paid administration fees of \$32,381 for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. Other costs of administering the Plan are paid by the Plan Sponsor.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
