Section I - Internal Control Related Matters Identified in an Audit

In planning and performing our ERISA Section 103(a)(3)(C) audit of the financial statements of Jupiter I, L.L.C. 401(k) Plan as of and for the year ended December 31, 2024, we considered the Plan's internal control over financial reporting (internal control) other than those controls over investments and related investment activity. Our ERISA Section 103(a)(3)(C) audit was performed in accordance with auditing standards generally accepted in the United States of America except, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, we did not perform any auditing procedures with respect to certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. We considered internal control as a basis for designing our procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses, and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

However, as discussed below, we identified a certain deficiency in internal control that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

A material weakness is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in the Plan's internal control to be a significant deficiency:

During our audit testing and inquiries, we noted that the compensation used for employee and employer contributions is not in accordance with the definition of compensation in the plan document. We recommend that additional review procedures be put in place to ensure that compensation used to calculate contributions is consistent with the plan document; corrections to past contributions be made, if necessary; and legal counsel be consulted to provide interpretive guidance and advice on corrective actions. The impact of not following the Plan's definition of compensation is that the financial statements could be misstated related to contributions. Additionally, the Plan could be out of compliance with IRS and DOL rules and regulations.

Section II - Required Communications with Those Charged with Governance

Our Responsibility Under U.S. Generally Accepted Auditing Standards

As stated in our engagement letter dated July 30, 2025, we conducted our audit in accordance with professional standards except that, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and as instructed by you, we did not perform any auditing procedures with respect to certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (GAAP). The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, were audited by us in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, were subjected to tests of your accounting records and other procedures as we considered necessary to enable us to express an opinion as to whether they are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Our audit of the financial statements does not relieve you or management of your responsibilities. As part of our audit, we considered the applicable internal controls of the Plan. Such considerations were solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal control.

We are responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures specifically to identify such matters.

Planned Scope and Timing of the Audit

We performed the audit according to the planned scope and timing previously communicated to you in our meeting about planning matters on July 30, 2025.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we will advise management about the appropriateness of accounting policies and their application. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024.

We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus.

We noted no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was the Plan's valuation of investments.

Section II - Required Communications with Those Charged with Governance (Continued)

Management has informed us that, in determining the appropriateness of the estimate of investment values, they have recorded the fair values based on market values provided by the investment custodian, plus any applicable valuation adjustments. We performed no specific procedures related to the valuation of the investments due to the scope and nature of an ERISA Section 103(a)(3)(C) audit.

The disclosures in the financial statements are neutral, consistent, and clear. Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was the disclosure of significant accounting policies used by the Plan as described in Note 2 to the financial statements.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Disagreements with Management

For the purpose of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report.

We are pleased to report that no such disagreements arose during the course of our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management.

We did not detect any misstatements as a result of audit procedures.

Significant Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards and plans and strategies that may affect the risks of material misstatement, with management each year prior to our retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition of our retention.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 3, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a second opinion on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Form 5500 - Annual Return/Report of Employee Benefit Plan

Our responsibility for Form 5500 does not extend beyond the financial statements, and we do not express an opinion or any form of assurance on Form 5500. However, we read the Plan's Form 5500 filing, and nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information or manner of its presentation appearing in the financial statements.

Other Information Provided for Your Consideration

Timely Deposit of Employee Deferrals

A Department of Labor regulation requires that benefit plans remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. In no case can this amount of time exceed 15 business days after the end of the month in which the amounts were withheld. The 15-business-day rule, however, is not a safe harbor. The general rule has been interpreted as being as little as zero days for entities with more than 100 employees. The DOL also looks at the consistency of timing and holds employers to the least number of days for deposits when determining if contributions are timely.

Cybersecurity Risks

With the U.S. Department of Labor's increased focus on cybersecurity for ERISA-covered benefit plans, it is vital for management to recognize both the financial and personal data risks these plans face. The value of participant data, while difficult to quantify, represents a significant exposure in the event of a breach, especially since standard theft coverage may not apply. Plan sponsors are now expected to adopt strong cybersecurity practices, including implementing formal, well-documented cybersecurity programs and maintaining vigilant oversight of third-party service providers. By following the DOL's best practices, plan sponsors can better protect plan assets and sensitive participant information, fulfilling their fiduciary duty and reducing the likelihood of costly security incidents.

SECURE 2.0 - What You Need to Know Now

SECURE 2.0 is a comprehensive retirement reform law aimed at expanding access to retirement plans, increasing savings opportunities, and improving financial security for American workers. It was signed into law on December 29, 2022 as part of the Consolidated Appropriations Act, 2023. While SECURE 2.0 includes dozens of provisions aimed at improving retirement readiness, not every change requires immediate action or is applicable to all plan types. For plan sponsors, understanding the key updates taking effect in 2025 is essential for compliance and strategic planning. Below is a summary of the most impactful changes.

- ***Auto-enrollment Requirement*** - Starting in 2025, new 401(k) and 403(b) plans must automatically enroll eligible employees at a minimum of 3 percent, increasing annually up to 10 percent.
- ***Expanded Eligibility for Part-time Workers*** - Employees who work at least 500 hours per year for two consecutive years must be allowed to participate in retirement plans.
- ***Higher Catch-up Contributions for Ages 60-63*** - Participants in this age group can contribute up to \$11,250 in 2025, offering a boost to late-stage retirement savings.
- ***Roth Catch-up Contributions for High Earners*** - Employees age 50 or older, earning over \$145,000 must make catch-up contributions as Roth starting in 2026. Plan sponsors should prepare now.

Plan sponsors must amend their plan documents to reflect SECURE 2.0 changes by December 31, 2026.

Section II - Required Communications with Those Charged with Governance (Continued)

Impact of the One Big Beautiful Bill (OBBB) on Employee Benefit Plans

The enactment of the One Big Beautiful Bill on July 4, 2025 has introduced significant changes to employee benefit plans. Plan sponsors should be aware of several key provisions that directly impact benefit plan design and compliance obligations. The OBBB permanently restores the telehealth safe harbor for high deductible health plans (HDHPs), allowing these plans to waive deductibles for telehealth services without disqualifying enrollees from contributing to a health savings account (HSA). Additionally, the OBBB increases the maximum contribution limit for dependent care FSAs from \$5,000 to \$7,500, effective January 1, 2026. Employers can also offer up to \$5,250 annually in tax-free student loan repayment assistance under a qualified educational assistance program, with this cap indexed for inflation starting in 2027. These changes provide opportunities for plan sponsors to enhance their benefit offerings and ensure compliance with the new regulations.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Jupiter I, L.L.C. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Jupiter I, L.L.C. 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on March 1, 1989 and most recently restated on February 28, 2022 to a preapproved plan. The Plan is available to all employees age 18 years or older who have completed one month of service. The entry date for eligible participants is the first day of the month following obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Management of Jupiter I, L.L.C. (the "Company") administers the Plan. Principal Life Insurance Company (Principal Life); Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust); and Principal Life, on behalf of Principal Global Investors Trust Company (Principal Global) (collectively, the "Custodians") serve as custodians, manage plan assets, and maintain the Plan's records. The Custodians offer plan participants a variety of investment options. Individual accounts are invested in the various investment options at the direction of the participants.

Note 2 - Plan Provisions and Summary of Significant Accounting Policies

Contributions

Participants may make before-tax contributions up to 100 percent of their annual eligible compensation, as limited by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions. There is an automatic elective deferral contribution of 2 percent unless otherwise elected by each participant.

The Company will make a matching contribution of 50 percent of elective deferrals up to 3 percent of eligible compensation. Matching contributions are funded each pay period. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½.

The Company makes wage rate contributions equal to the fringe benefit amount determined in accordance with the prevailing rate schedule for each employee reduced by contributions made to other plans that count toward satisfying the fringe rate stated in the prevailing wage schedule. For the year ended December 31, 2024, the Company made wage rate contributions of approximately \$165,000.

Participants are eligible to defer on an after-tax basis through regular payroll deductions from 0 percent to 100 percent of eligible compensation as Roth 401(k) contributions. Provided requirements are met, withdrawals of contributions and any earnings are tax free to the participant. A participant's combined pretax and after-tax contributions cannot exceed the maximum annual amount allowed by law.

Participants' Accounts

Each participant's account is credited or charged with the participant's contributions and withdrawals, as applicable, and an allocation of the Company's contributions, plan earnings or losses, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the plan document. The benefit to which a participant is entitled is the vested portion of the participant's account.

Vesting

Participants are 100 percent vested in their voluntary contributions, rollover contributions, and allocated earnings or losses thereon.

Any employer contributions (including forfeitures) and the earnings or losses thereon not fully vested when contributed will vest as follows:

Less than 1	0
1 or more	100

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of two notes receivable outstanding at any given time. The notes are secured by the balances in the participants' accounts; bear interest at rates that range from 5.25 to 10.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at note origination; and mature at various dates through December 2032. Notes have a maximum term of 5 years unless such note is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 30 years from the date of the note origination. Principal and interest are paid ratably through payroll deductions. Participant notes receivable are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's note shall continue to be payable in accordance with the provisions of the participant's note or be due in full.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump-sum payment in the amount equal to the participant's vested account balance. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan allows in-plan Roth conversions. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically distributed out of the Plan. The IRS has required minimum distributions once a participant reaches age 70½ during the previous plan year and is no longer employed by the Company.

Participant Termination and Forfeitures

If, at the time of termination of employment, the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay plan expenses and to reduce future company matching contributions. Forfeitures in the amount of \$22,875 were applied to reduce employer contributions during the year ended December 31, 2024. The balance of this account at December 31, 2024 and 2023 was \$2,879 and \$31, respectively, recorded in total investments at fair value on the statement of net assets available for benefits.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policy utilizing information provided by the investment advisors, appoints the investment managers, and the monitors performance of the Plan's investment funds.

Pooled separate accounts and common/collective trust funds are valued as a practical expedient at net asset value (NAV) of units held by the Plan at year end based on the quoted market prices of the securities underlying the investments. There are no redemption restrictions or unfunded commitments on these investments.

Investments in mutual funds are reported at the last reported sales price at the end of the respective periods using quoted market values.

Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in net assets available and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

In January 2025, the Company completed an amendment that changed the employer match to 50 percent of elective deferrals up to 4 percent of eligible compensation and the auto-enrollment up to 4 percent. The amendment also changed the plan's definition of eligible compensation.

In May 2025, the Company spun-off TeamLINX LLC employees into a separate 401(k) plan, and related assets were transferred into the TeamLINX LLC plan.

Note 3 - Certified Information

Principal Life, Principal Trust, and Principal Global hold the Plan's investment assets and execute all investment transactions. The investment balances and related income and losses included in the accompanying financial statements and schedule of assets held at end of year are based solely on information certified by Principal Life; Principal Trust; and Principal Life, on behalf of Principal Global.

Notes to Financial Statements

December 31, 2024 and 2023

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

Note 6 - Party-in-interest Transactions

The Company provides administrative services to the Plan in accordance with the plan agreement and does not charge the Plan a fee for these services.

Certain plan investments are pooled separate accounts, common/collective trusts, and an unallocated insurance contract, which are managed by Principal Life, Principal Trust, Principal Global, and their affiliates. Principal Life, Principal Trust, and Principal Global are the custodians, as defined in the Plan; therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. In addition, the Plan provides for notes to participants, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

Note 7 - Income Taxes

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Effective March 16, 2022, the Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
