#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lucile Salter Packard Children's Hospital at Stanford Tax-Sheltered Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lucile Salter Packard Children's Hospital at Stanford Tax-Sheltered Annuity Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lucile Salter Packard Children's Hospital at Stanford Tax-Sheltered Annuity Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 – The Plan And Its Significant Accounting Policies**

**General** – The following description of Lucile Salter Packard Children's Hospital (LPCH) at Stanford Tax-Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution 403(b) plan covering all employees of LPCH who had met eligibility requirements, as defined in the Plan document. The Plan is subject to applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was frozen on October 31, 1997; therefore, contributions and rollover contributions are no longer allowed.

**Administration** – LPCH appointed the Retirement Committee (the Committee) to manage the operation and administration of the Plan. LPCH contracted with Teachers Insurance and Annuity Association of America and College Retirement Equity Fund (TIAA-CREF), Fidelity Management Trust Company (Fidelity), The Lincoln National Life Insurance Company (Lincoln), and The Variable Annuity Life Insurance Company (VALIC) under Corebridge Retirement Services (Corebridge) to act as the custodians. LPCH contracted with TIAA-CREF, Lincoln, VALIC, and an affiliate of Fidelity to act as third-party administrators to process and maintain the records of participant data. A portion of all expenses incurred for administering the Plan are paid by LPCH.

Effective March 1, 2019, loans are no longer permitted under the Plan.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with GAAP.

**Investment valuation and income recognition** – The Plan's investments are reported at fair value and contract value. The Plan's custodians, TIAA-CREF, Fidelity, Lincoln, and VALIC under Corebridge, certify the contract value of the guaranteed interest accounts and investment contracts and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Payment of benefits** – Benefits are recorded when paid.

**Income taxes** – The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for participants under Section 403(b).

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

#### **Note 2 – Fair Value Measurements**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Annuity accounts* – Units held in, annuity accounts, are valued using the NAV practical expedient as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the annuity accounts and pooled separate accounts, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of the annuity accounts and pooled separate accounts are calculated based on a compilation of primarily observable market information. These accounts may be redeemed daily without restrictions and unfunded commitments.

*Nonfully benefit-responsive guaranteed fixed annuity contract* – Valued at fair value determined by the sum of the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals. Fair value is determined and reported to the Plan by TIAA-CREF.

*Self-directed Brokerage Link accounts* – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 3 – Investment Contracts**

**Fully Benefit-Responsive Investment Contracts**

*TIAA Traditional Annuity Contract (the TIAA Traditional)* – The Plan has an investment in the TIAA Traditional Annuity of approximately \$553,000 and \$561,000 at December 31, 2024 and 2023, respectively, which is a fully benefit-responsive fixed annuity contract that is fully and unconditionally guaranteed by Teacher’s Insurance Association of America (TIAA). TIAA maintains the contributions in a general account. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed 1% to 3% minimum rate of interest, and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the declaration year and is not guaranteed for future years. When the accumulation in the TIAA Traditional Annuity is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation.

There are no events that limit the ability of the Plan to transact at contract value with TIAA-CREF.

*Lincoln Fixed Account* – The Plan has a benefit-responsive investment contract with Lincoln of approximately \$953,000 and \$1,496,000 at December 31, 2024 and 2023, respectively. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate stated on the contract and is declared on a quarterly basis by Lincoln.

Certain events limit the ability of the Plan to transact at contract value with Lincoln. Such events include the following: (1) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (2) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The annuity contract is evergreen and as such does not have a maturity date. The only way the contract can be terminated is if the Plan no longer qualifies under the applicable IRS tax codes.

*Corebridge Fixed Account Plus* – The Plan has a benefit-responsive investment contract with VALIC under Corebridge of approximately \$1,739,000, and \$1,921,000 at December 31, 2024 and 2023, respectively. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no events that limit the ability of the Plan to transact at contract value with VALIC. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by VALIC, Lincoln, and TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Non fully benefit-responsive investment contract** – The Plan has an investment in the TIAA Traditional Annuity of approximately \$84,000 and \$87,000 at December 31, 2024 and 2023, respectively, which is non fully benefit-responsive and is reported in the financial statements at fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their fixed annuity contract at contract value in ten annual installments over a period of nine years plus one day that are subject to a 2.5% surrender charge.

The Plan administrator determines the fair value measurement based on information provided by TIAA-CREF. The fair value measurement procedures are reassessed at least annually. At that time, the unobservable inputs used in the fair value measurements are evaluated based on current market conditions and other third-party information.

#### **Note 4 – Related-Party Transactions**

Certain Plan investments are managed by the custodians of the Plan. Any purchases and sales of these funds are performed in the open market at fair value or contract value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### **Note 5 – Participation And Benefits**

**Participant accounts** – Each participant's account is credited with an allocation of plan earnings or losses based on the participant's account balance in each investment fund. Participant accounts are self-directed to eligible investment options of the Plan.

**Payment of benefits** – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a lump-sum amount, or any forms of annuities allowed in the Plan document equal to the value of the participant's interest in their account. The Plan allows for the automatic distribution of participant account balances that do not exceed \$5,000.

**Vesting** – Participants are 100% vested in their entire accounts.

#### **Note 6 – Certified Investment Information**

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF, Fidelity, Lincoln, and VALIC under Corebridge, qualified institutions:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net realized and unrealized appreciation in fair value of investments and dividends and interest reflected on the accompanying statement of change in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

#### **Note 7 – Plan Termination Or Modification**

LPCH intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA.
