We have audited the financial statements of Advizex Technologies, LLC Retirement 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and have issued our report thereon dated October 8, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians, which are banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 11, 2025. Professional standards also require that we communicate to you the following information related to our audit.

## Significant Audit Matters

### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The financial statement disclosures are neutral, consistent, and clear.

### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no material or uncorrected misstatements identified. The uncorrected misstatements or the matters underlying them could potentially cause future period financial statements to be materially misstated, even though, in our judgment, such uncorrected misstatements are immaterial to the financial statements under audit. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

### *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

- We noted that meeting minutes related to the Plan are not maintained from the formal, generally annual, meetings that take place between plan leadership and outside parties, including the investment advisor. We recommend that detailed minutes be maintained from all of these meetings to ensure those charged with governance of the Plan have considered and approved plan amendments, ensure compliance with ERISA regulations, a formal investment policy is created and followed including review of the investment performance and related fees charged to the Plan, evaluation of service providers and consideration over employee complaints or concerns, if any. Failure to do so could result in the Plan not having adequate records to support decisions related to the Plan and could result in unintended changes to the Plan.

- We noted there appears to be a review over participant accounts during the year; however, this review is not formally documented or retained, to support that the review occurred and the results of the review. We recommend implementing a control in which a sample of participant accounts is reviewed periodically during the year, and that formal documentation of the review is maintained. Failure to do so could result in incorrect participant contributions throughout the year.
- We noted that the ERISA fidelity bond, as well as certain Plan agreements, note the sponsor of the Plan as Rolta Advizex Technologies, LLC, despite the legal company name of the plan sponsor changing to Advizex Technologies, LLC. We recommend that all plan agreements be amended such that the plan sponsor name matches the legal name. Failure to do so could result in potential issues should someone question who the responsible company is related to the Plan, and which company is covered under the required ERISA fidelity bond.
- We noted that there were three individuals on the census that were incorrectly listed as receiving profit sharing contributions when they did not and should not have received the profit sharing contribution. We recommend that the census be reviewed prior to submitting to confirm the census is complete and accurate. Failure to do so could result in incorrect compliance testing results.
- We noted that the Summary Plan Description is not accurate, as the document states that participants will always share in the nonelective contribution regardless of the amount of service completed during the year; however, the actual plan agreements indicate that the profit sharing contribution is only to be provided to participants who were employed as of the last day of the Plan year and completed at least 1,000 hours of service during the Plan year. We recommend that the Summary Plan Description be updated to reflect the actual requirements set in the Adoption Agreement. Failure to do so could result in the incorrect plan definitions being followed and the incorrect amount of profit sharing contributions being made for participants.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated October 8, 2025.

*Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Other Matters*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
