**NOTE 1 - PLAN DESCRIPTION**

The Teamsters and Food Employers Security Trust Fund (the "Fund") was formed pursuant to the Trust agreement covering participants who are working under applicable collective bargaining agreements for employers who contribute to the Fund. The purpose of the Fund is to provide the following benefit programs for active employees and their dependents and retired employees and their dependents:

**Active Employee Benefit Program**

1. Hospital - Medical Care Plan and Employee - Member Assistance Program
2. Death and Accidental Death and Dismemberment Benefit Plan
3. Dental Care Plan
4. Prescription Drug Plan
5. Vision Care Plan

**Retired Employee Benefit Program**

1. Hospital - Medical Care Plan and Employee Member Assistance Program
2. Prescription Drug Plan

Benefits provided to retirees or their dependents are only furnished so long as there are allocated funds for retiree benefits available to pay for such benefits and so long as the last employer prior to the retiree's retirement is currently obligated to contribute to the trust fund for the retiree health and welfare benefits under the collective bargaining agreement covering the same bargaining unit. Should either of these conditions end, the trustees are no longer obligated to furnish such benefits. These are not guaranteed lifetime benefits. Further, the trustees have the right to modify or eliminate any benefit or program at any time.

All Plans of Benefits and eligibility are subject to the terms of the Plan Document, the Trust Agreement and the rules and regulations adopted from time to time by the Board of Trustees.

All benefits under the Plan are paid directly from the Fund and there is no liability upon the Fund, the Board of Trustees, any contributing employer, or any other person or entity to provide the benefits of the Plan beyond the amount in the Fund available for such purpose.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis Of Presentation**

The financial statements of the Fund are prepared in accordance with generally accepted accounting principles.

**Employer Contributions**

Employer contributions are reported as receivables and the related revenue is recognized in the month the participant qualifies for eligibility, in accordance with the provisions of the applicable collective bargaining agreement.

**Retiree Contributions**

Medicare eligible retirees remit monthly contributions of \$115 and non medicare eligible retirees remit monthly contributions of \$168.50 to \$238.50, depending on family content. Deferred retiree contributions represent prepaid remittance of retiree contributions.

**Investments**

If available, quoted market prices are used to value investments. Many factors are considered in arriving at that fair value. In general, however, U.S. Government Bonds and Certificates of Deposits are valued based on yields currently available on comparable securities of issuers with similar credit ratings. Purchases and sales of securities are recorded on a trade-date basis. Investment in mutual funds are valued at quoted market prices, which represents the net asset value. Interest income is recorded on the accrual basis.

FASB Accounting Standards Codification (ASC) 820, which defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). ASC 820 emphasizes that fair value is a market-based measurement that should be determined based on the assumptions market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, ASC 820 establishes a fair value hierarchy that distinguishes between (1) market participant assumptions developed based on market data obtained from sources independent of the Plan (observable inputs) and (2) the Plan's own assumptions about market participant assumptions developed based on the best information available in the circumstances (unobservable inputs). Valuation techniques used to measure fair value shall maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels, as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide information on an ongoing basis.

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. If the asset or liability has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets which are not active;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 inputs are unobservable inputs for the asset or liability. Unobservable inputs are used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at the measurement date. Unobservable inputs reflect the Plan's own assumptions that market participants would use in pricing the asset or liability (including assumptions about risk). Unobservable inputs are developed based on the best information available in the circumstances, which might include the Plan's own data. However, market participant cannot be ignored and, accordingly, the Plan's own data used to develop unobservable inputs are adjusted if information is reasonably available without undue cost and effort that indicates that market participants would use different assumptions.

**Investments (Continued)**

The methods of valuation described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

The plan does not have any Level 3 investments and there were no significant transfers between Level 1 and Level 2 investments during the year ended December 31, 2024.

The fair value hierarchy of ASC 820 gives the highest priority to Level 1 and the lowest priority to Level 3 inputs.

The mutual fund is valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is open-end mutual fund that is registered with the SEC. The fund is required to publish their daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

**Postretirement Benefits**

The Financial Accounting Standards Board issued its Accounting Standards Codification (ASC) to be the single source of authoritative nongovernmental U.S. generally accepted accounting principles (U.S. GAAP). ASC Topic 965, "Plan Accounting - Health and Welfare Benefit Plans," applies to all health and welfare plans, including multiemployer plans, and requires the disclosure of certain benefit obligations on financial statements.

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

**Per-Capita Claims Cost**

Indemnity claims and enrollment data for the thirty-six months ending December 31, 2024 was used to develop the indemnity per capita claims costs. This data was obtained from the Fund financial and statistical reports provided by the Fund Administrator.

Kaiser rates effective November 1, 2024 and Aetna rates effective March 1, 2025 were used to develop the HMO per-capita claims cost. Because the Aetna active and Non-Medicare retiree populations are rated together, we adjusted the Aetna premium upward to estimate the cost of non-Medicare retirees alone. Note that the excess of estimated retiree only cost over the actual mixed active/retiree premium is referred to as an "implicit subsidy of the non-Medicare retirees by the actives", and is required to be accounted for under FASB ASC 965.

For indemnity medical and prescription drug, retirees paid claims in each plan year were divided by the corresponding number of retirees and spouses to yield a per-capita claim. They were then trended to the midpoint of the initial valuation year, adjusted for plan changes, multiplied by a factor to estimate incurred claims, and combined by taking a weighted average. Utilization factors were applied to estimate costs by five-year age bands. These costs are net of deductible and other benefit plan cost sharing provisions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Assumption Changes**

The discount rate was increased from 4.75% to 5.50% to reflect the current market environment. Initial per-capita health claims costs were updated to reflect recent historical and expected further claims experience. Trend rates were reset based on anticipated increases in health claim costs. The mortality rates and retirement rates were updated to those in the latest actuarial valuation of the Western Conference of Teamsters Pension Plan.

**Medicare Prescription Drug, Improvement and Modernization Act**

On December 8, 2003, the President signed into law the Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the Act) for employers that sponsor postretirement health care plans that provide prescription drug benefits. The Act introduces a prescription drug benefit under Medicare (Medicare Part D) as well as a federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.

The forgoing assumptions are based on the presumption that the Fund will continue. Were the Fund to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

**Claims Incurred But Not Reported And Accumulated Eligibility Credits**

Plan obligations at December 31 for health claims incurred by active participants but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan's Benefit Obligations at present value. Indemnity medical and indemnity dental were based on a study of the incurral pattern for claims paid from the period January 1, 2023 to December 31, 2024. Total incurred for 2024 was estimated and the actual 2024 payments was subtracted to yield the medical and dental Incurred But Not Paid (IBNP) claims as of December 31, 2024. Approximately two-twelfths of the 2024 paid claims for prescription drugs, vision, and life insurance was added to get the total IBNP claims at December 31, 2024 (combined for actives and retirees).

Pursuant to the terms of the Master Grocery Collective Bargaining Agreement, the Plan provides eligibility of benefits through the end of the month of covered employment for which contributions have been paid. Accordingly, the liability for accumulated eligibility benefits is due to an extension of welfare benefits to totally disabled participants and for extended death benefits for participants who are totally disabled. The liability was estimated by estimating the number of such participants as of December 31, 2024 and multiplied by 1.97 months of projected 2025 welfare benefit costs and administrative expenses. The average months of disability extension into 2025 were estimated based on data provided by the administrator. No adjustments for discount or mortality were deemed necessary.

**Use of Estimates and Assumptions**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, IBNR, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 3 - BENEFIT OBLIGATIONS**

The Plan's deficiency of net assets over benefit obligations at December 31, 2024, relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreement. It is expected that the deficiency will be funded through future increases in the collectively bargained contribution rates.

The weighted-average health care cost-trend assumption (see Note 2) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$101,316,000 and \$120,390,000, respectively. If the assumed rates decreased by one percentage point in each year, it would decrease the obligation as of December 31, 2024 and 2023 by \$83,533,000 and \$98,210,000, respectively.

**NOTE 4 - INCOME TAXES**

The Internal Revenue Service issued a favorable determination pursuant to Internal Revenue Code Section 501 (c) (9), and accordingly, the trust's net investment income is exempt from income taxes. The Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. Generally Accepted Accounting Principles requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income examination for years prior to 2022.

**NOTE 5 - FUND TERMINATION**

The Fund will remain in effect as long as there are employers who are obligated under collective bargaining agreements to make contributions to the Fund. Upon termination of the Fund, the Trust Agreement provides that all assets will be allocated in a manner consistent with the provisions of ERISA.

**NOTE 7 - CLAIMS AUDITS**

As a supplement to the claims auditing procedures conducted internally, a program auditing medical and dental claims, on a test basis, is being conducted by the Fund's independent auditors on a continuing basis with periodic claims audit reports being submitted to the Board of Trustees.

**NOTE 8 - SIGNIFICANT CONCENTRATIONS OF CREDIT RISK**

The Fund's cash and cash activities are with Comerica Bank. The accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

A substantial amount of the employer contributions receivable are from retail food industry employers located in Southern California.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 10 - SIGNIFICANT TRANSACTIONS WITH PERSONS KNOWN TO BE PARTIES IN INTEREST**

The Fund has contracted for administrative and claims services with BeneSys Administrators beginning December 1, 2012. The administrative and claims fees paid to BeneSys Administrators for the year ended December 31, 2024 and 2023 was \$3,047,978 and \$2,933,229, respectively.

The fund also contracts with investment managers, consultants, attorneys, and auditors who are all known to be parties in interest.

**NOTE 11 - SUBSEQUENT EVENTS**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosures through October 1, 2025, the date the financial statements were available to be issued.
