Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C. Davis Electric Co., Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C. NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the C. Davis Electric Co., Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provision, which is available upon request.

General

The Plan is a defined contribution plan covering all full-time employees of C. Davis Electric Co., Inc. (the “Company”), who have completed 12 consecutive months of service, working at least 1,000 hours, and have reached at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The owners of the Company are responsible for oversight of the Plan. The owners determine the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees of the Company.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. All contributions are subject to certain limitations established by the Internal Revenue Service. The maximum pretax contribution for the years ended December 31, 2024 and 2023 was \$23,000 and 22,500, respectively. Additionally, if a participant has attained age 50, the participant is eligible to make an additional catch-up contribution. This age-50 catch-up contribution cannot exceed \$7,500 and \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes discretionary matching contributions equal to 25% of the first 6% of the participant’s compensation. Additional amounts may be contributed at the discretion of the Company. During the year ended December 31, 2024, the Company made a \$150,000 profit sharing contribution to the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s voluntary contribution, allocations of the Company’s contribution, and earnings from participant directed investments, net of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and profit sharing contributions is based on years of continuous service. A participant is fully vested after six years of continuous service.

Notes Receivable From Participants

No participant may borrow from their fund accounts in accordance with the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount in cash equal to the value of the participant's vested interest in his or her account. If the participant's vested account balance is less than \$5,000 at the date of death, disability, retirement or termination of employment, then that balance shall be distributed in a single lump-sum payment or rolled over into an individual retirement account. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump sum distribution.

Rollovers

The Plan accepts rollover contributions from other tax-qualified plans, governmental 457 plans, and traditional IRAs for those participants who choose to invest in the Plan.

Forfeitures

Forfeits are applied to reduce the Company's contribution at the end of the next plan year during which the participant has received distribution of their vested interest.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions to be vested in one or more of the investment options available to the Plan.

Plan Administration

The Plan is administered by the Company. The Plan assets are maintained by Nationwide Life Insurance Company ("Nationwide") as the certifying entity and contract administrator.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for investments in fully benefit-responsive investment contracts ("FBRIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. FBRIC's are reported at contract value because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a FBRIC through a Fixed Income Fund account (Note 7). See Note 6 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide, the certifying entity of the Plan.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants would become 100% vested in their employer contributions.

NOTE 5 – TAX STATUS

The Internal Revenue Service, by a favorable opinion letter dated August 7, 2001, concluded that the form of the Standardized Paired Profit Sharing 401(k) Plan is acceptable in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting *Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Pooled Separate Accounts* –valued at Net Asset Value.
- *Money Market Fund* – valued at the closing price by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – INVESTMENT CONTRACTS

The Plan entered into a benefit-responsive investment contract with Nationwide called the Fixed Income Fund. Nationwide maintains the contributions in a general account, which are credited on a net daily basis at annual effective rates.

As described in Note 2, contract value is the relevant measuring attribute for that portion of the net assets available for benefits attributable to the Fixed Income Fund.

Contract value, as reported by the Plan by Nationwide, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer as a lump sum distribution with a market value adjustment or an installment payout, at book value, over a period of years.

The Plan’s management has determined that the contract value of the Plan’s fully benefit responsive contract as of December 31, 2024 approximates fair value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Fixed Income Fund does not have a maturity date, and contract provisions do not provide for a distribution at book value at some specified future date. The fund continues in force until all assets have been distributed, or no further payments are due.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

The Plan has entered into a benefit-responsive investment contract with Nationwide called the Fixed Income Fund which is managed by Nationwide. Nationwide is the certifying entity of the Plan and, therefore, these transactions qualify as party-in-interest.

Certain Plan investments are shares of mutual funds managed by Nationwide, and as such, these transactions qualify as party-in-interest transactions. Total assets held by parties-in-interest as of December 31, 2024 and 2023 amounted to \$13,530,444 and \$11,935,649, respectively.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
