### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Moran Environmental Recovery 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Moran Environmental Recovery 401(K) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established effective January 1, 2002. The Plan is a defined contribution 401(k) savings and profit-sharing plan covering all employees of Moran Environmental Recovery and its subsidiaries, Drummac, Inc., Global Diving & Salvage, Inc. and Mainstream Commercial Divers, Inc. (collectively, the Company) who have completed 1 month of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Merger**

As further described in Note 7, the assets of the Plan were transferred to Moran Towing Corporation 401(k) Plan during 2024.

**Contributions**

Participants may contribute between 1% and 90% of compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions under the Code Section 414(v), which are not to exceed a \$7,500 limit. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Company may, at its discretion, elect to make a matching and profit-sharing contribution to the plan. The discretionary matching contribution was 100% of the participant's elective deferral contributions up to 3% of eligible compensation, and 50% of the next 2% of eligible compensation for a maximum of 4% for the year ended December 31, 2024. Participants are eligible for the profit sharing contribution if they meet the eligibility requirements above and are employed on the last day of each quarter and plan year. The profit sharing contribution was 3% of the participants quarterly eligible compensation, and an additional 2% of the participants eligible compensation for the plan year.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of profit-sharing contributions, investment income and administrative expenses are based on participants' compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Fidelity Management Trust Company (Fidelity). These funds include a variety of investment options with various objectives and degrees of financial risk.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions, including the earnings on these amounts. Vesting in the Company contributions portion of their accounts is based on years of continuous service. Participants are fully vested in employer contributions upon the completion of five years of service. Participants are also fully vested upon reaching their normal retirement date, death or total disability.

**Notes Receivable from Participants**

Participants may borrow between \$1,000 and 50% of their account balance, up to a maximum amount of \$50,000. Loan terms range from one to five years, except for those made to purchase a primary residence, which may be offered over a 10-year term, and participants may have one outstanding loan at one time. The loans are secured by the balance in the participants' account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator (currently between 4.25% and 9.5%). Principal and interest are paid only through payroll deductions; however, a participant can make additional payments outside of payroll without penalty.

**Payment of Benefits**

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. The Plan provides that the form of payment shall be a lump sum. If a participant's account balance is \$1,000 or less, then the Plan permits a lump-sum payment without the participant's consent. If a participant's account balance is between \$1,000 and \$5,000, then the Plan permits for the balance to be distributed to an IRA on behalf of the participant. If the account balance exceeds \$5,000, then participant consent is required for any distribution.

The Plan also provides for in-service withdrawals by participants who have attained the age of 59½. Upon financial hardship, a participant is entitled to the value of his or her deferral accounts, but not the earnings thereon, which is payable immediately in a lump-sum distribution. The minimum amount that can be requested for a hardship withdrawal is \$500.

**Forfeitures**

Forfeitures represent the nonvested portion of terminated participants' account balances that could be used to reduce plan expenses or future employer contributions. The Plan utilized forfeitures totaling \$228,006 for the year ended December 31, 2024 to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$230,765, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits distributed to participants are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to recordkeeping, the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan holds various investments which, in general, are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE**

Information presented in the accompanying statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived, without audit, from information certified to be complete and accurate by Fidelity, the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENT**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds:* Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Common Collective Trusts:* The common collective trusts are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of the units held of the common collective trust. The net asset value is used as a practical expedient to estimate fair value.

*Guaranteed Investment Contract:* Insurance contract valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

There have been no changes in the methodologies used or transfers between levels of investments as of and for the years ended December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- a) Certain investments that are measured using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Investments in common and collective trusts provide for daily liquidity and have no redemption features or other restrictions.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain plan investments are shares of mutual funds managed by affiliates of Fidelity. Fidelity is a trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services amounted to \$98,005 for the year ended December 31, 2024. All other administration expenses of the Plan were paid by the Company for the year ended December 31, 2024. Certain employees of the Company who participate in the Plan perform administrative services for the Plan at no cost of the Plan. Notes receivable from participants are also party-in-interest transactions.

**NOTE 6 INCOME TAX STATUS**

The Plan has adopted a nonstandardized prototype plan that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN MERGER AND TRANSFER**

The Company authorized the merger and transfer of the Plan to the Moran Towing Corporation 401(k) Plan (Moran Towing Plan), to be effective January 1, 2025. On December 31, 2024, the Plan's assets were liquidated from the trust and transferred to Fidelity Management Trust Company (Fidelity), the trustee of the Moran Towing Plan. In connection with the merger, Moran Environmental Recovery was added as a participating employer in the Moran Towing Plan and participants were able to participate in that Plan effective January 1, 2025. The Company's fourth quarter and year-end profit sharing contributions, which have been historically deposited into the Plan during the first quarter of the following year, were deposited directly into Fidelity in 2025 and as such have been included as part of the transfer recorded during 2024.
