We have performed audits of the accompanying financial statements of Colomer & Suárez, LLC – CODA Profit Sharing Plan, (formerly Colomer & Suárez, Inc. – CODA Profit Sharing Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Colomer & Suárez, LLC. – CODA Profit Sharing Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Colomer & Suárez, LLC. - CODA Profit Sharing Plan, (formerly Colomer & Suárez, Inc. - CODA Profit Sharing Plan), (hereinafter referred to as the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement for a complete description of the Plan's provisions. Effective June 1, 2023, the Plan name changed to Colomer & Suarez, LLC. CODA Profit Sharing Plan and the Plan sponsor and Employer is Colomer & Suarez, LLC. In addition, the name of the adopting employer is Colomer & Suarez San Juan, LLC.

General

The Plan is a defined contribution plan covering all employees of Colomer & Suárez, LLC. and Colomer & Suárez San Juan, LLC. (hereinafter referred to as the Sponsor) who have worked 1,000 hours in a calendar year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute not less than 1%, nor more than 10% of pretax annual compensation, as defined in the Plan.

The employer's contribution to the plan is 50% of the first 6% of a participant's contribution. No contributions will be made with respect to contributions made by a participant in excess of 6%.

Participants' accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's contribution, if eligible, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Except for forfeitures, allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants shall vest in accordance with the following schedule:

Investments options

Upon enrollment in the Plan, a participant directs its contributions and Company contributions into Mutual Funds.

Participants may change their investment options at any time.

Normal retirement age for each participant must be 65 years old, and the early retirement age permitted under the Plan is 60 years old.

Distribution of benefits

Distribution of benefits that are less than \$5,000 shall be made to participants in a single lump sum payment. If the amount exceeds \$5,000, the participant shall have the option to decide how to receive the distribution.

The Plan shall permit distributions attributable to Sponsor contributions only upon the occurrence of one of the following events:

- a. retirement of the employee or attainment of normal retirement age.
- b. separation from service (for any reason, including death).
- c. permanent disability of the employee.
- d. termination of the Plan.

Payment of benefits

The Plan does not permit participants to receive payment of benefits unless the participant terminates employment.

Participant loans

A participant must be an active employee to be eligible for a loan. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at one percent over the prime rate determined on a monthly basis. Principal and interest are paid through monthly payroll deductions.

Forfeitures

Forfeitures of matching contributions are used to pay administrative expenses and/or to reduce employer contributions.

Plan termination

In the event the Plan terminates, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations.

NOTE B - ORGANIZATION, BASIS OF PRESENTATION, AND ACCOUNTING POLICIES

Organization

The Plan was organized on January 1, 1998.

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan sponsors are Colomer & Suárez, LLC. and Colomer & Suárez San Juan, LLC. (See Note A).

Accounting policies

Cash equivalents

The Plan considers all instruments with a purchase maturity of ninety days or less to be cash equivalents.

Accounting policies - continued

Investment valuation and income recognition

Investments are participant-directed and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

As of December 31, 2024, and 2023 no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Fair value measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are based upon observable and unobservable inputs. Observable inputs reflect market data obtained from independent sources while unobservable inputs reflect the Plan's view of market assumptions in the absence of observable market information. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. In determining fair value, the Plan uses various methods including market, income and cost approaches.

Fair value measurements-continued

The Plan categorizes its fair value measurements into a three-level hierarchy based on the priority of the inputs to the valuation technique. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure fair value fall within different levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument in its entirety.

The Plan categorizes assets and liabilities carried at fair value in the accompanying statement of net assets available for benefits as follows:

- Level 1 - Unadjusted quoted prices accessible in active markets for identical assets or liabilities at the measurement date and mutual funds where the value per share (unit) is determined and published daily and is the basis for current transactions.
- Level 2 - Unadjusted quoted prices for similar assets or liabilities in active markets or inputs (other than quoted prices) that are observable or that are derived principally from or corroborated by observable market data through correlation or other means. Primary inputs to this valuation technique may include comparative trades, bid/asks, interest rate movements, U.S. Treasury rates, Secure Overnight Financing Rate (SOFR), prime rates, cash flows, maturity dates, call ability, estimated prepayments, and/or underlying collateral values.
- Level 3 - Prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. Inputs reflect management's best estimate about the assumptions market participants would use at the measurement date in pricing the asset or liability. Consideration is given to the risk inherent in both the method of valuation and the valuation inputs. Primary inputs to this valuation technique include broker quotes and comparative trades.

For 2024 and 2023 the plan categorized the investments in mutual funds as level 1.

Changes in observability of significant valuation inputs identified during these reviews may trigger reclassifications. Reclassifications are reported as transfers at the beginning of the period in which the change occurs.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payments of benefits

Benefits are recorded when paid.

Administration expenses

All expenses of maintaining the Plan are accounted for as they are incurred.

NOTE D - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Trustee and the auditor of the Plan are considered parties-in-interest to the Plan. The sponsor is not aware of any prohibited transactions with parties-in-interest. Auditing fees paid by the Sponsor on behalf of the Plan were approximately \$17,600 for the year ended December 31, 2024 and \$16,000 for 2023. Trustee's fees and administrative expenses paid by the Sponsor on behalf of the Plan were approximately \$66,000 and \$23,000 for the years ended December 31, 2024 and 2023, respectively.

NOTE E - INCOME TAX STATUS

The Department of the Treasury of the Commonwealth of Puerto Rico has ruled that the Plan qualifies under Section 1081.01 (e) of the Income Tax Act of 2011 (the Act) and is, therefore, not subject to income tax under the present income tax law. The Plan is required to operate in conformity with the Act to maintain its qualification.

The Plan obtained its latest determination letter on May 12, 2016, in which the Puerto Rico Treasury Department stated that the Plan, as then designed was in compliance with the applicable requirements of the Puerto Rico Treasury Department. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Puerto Rico Treasury Department.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities (mutual funds) which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that change in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer's contributions.

NOTE I - DATE OF MANAGEMENT'S REVIEW AND SUBSEQUENT EVENT

At January 28, 2025, in order to be in compliance with the established by Section 1081.01(b) 3(iii) of the Internal Revenue Code of Puerto Rico, the Board of Trustees and Plan Administrator, decided that Colomer & Suarez, LLC (Plan Sponsor) will reclassify to "Post Tax Contributions" the excess amount of the "Pre Tax Contributions" of the highly compensated employees for the amount of \$5,571.07. The form W-2 of those employees will be amended.

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
