### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Candlewick Press 401(K) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Candlewick Press 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of Plan**

The following description of the Candlewick Press 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### ***General***

The Plan is a defined contribution plan established to provide eligible employees of Candlewick Press, Inc. (the “Company”) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the *Employer Retirement Income Security Act of 1974* (“ERISA”). The Plan was originally established on January 1, 1997 and was most recently amended and restated effective May 1, 2021.

### ***Eligibility***

All Company employees, with the exception of non-resident aliens, union employees, leased employees, and temporary and seasonal employees whose regularly scheduled service is less than 1,000 hours of service during the plan year, are eligible to participate in the Plan upon their date of hire.

### ***Participant Contributions***

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of their eligible annual pre-tax compensation, as defined by the plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional “catch up” contribution (\$7,500 in 2024). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and guaranteed interest accounts as investment options for participants.

The Plan also allows participants to defer funds as a Roth 401(k) deferral. These deferrals are subject to federal and state income taxes and the maximum allowable combined contributions of Roth and pre-tax deferrals is \$23,000.

### ***Employer Contributions***

Participants that have completed one year of service, as defined, and are employed on the last day of the plan year are eligible to share in the Company's discretionary matching contributions and discretionary profit-sharing contributions. The Company's profit-sharing contributions are allocated to participants based on each participant's classification. The Plan assigns participants to one of two classifications based on each participant's total years of service. A discretionary dollar amount is provided for each classification and further allocated to each participant pro rata, based on compensation. The Company did not make a profit-sharing contribution during the year ended December 31, 2024. The Company made a profit-sharing contribution totaling \$208,743 during the year ended December 31, 2023. The Company did not make a discretionary matching contribution for the years ended December 31, 2024 and 2023.

### ***Participant Accounts***

Each participant's account is credited with their respective contributions and their allocation of (a) employer contributions and (b) investment earnings or losses.

### ***Vesting***

Participants' voluntary contributions, discretionary matching contributions, and discretionary profit-sharing contributions and actual earnings thereon vest immediately.

***Payment of Benefits***

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½, having been a participant in the Plan for at least five years, or the portion of the account being withdrawn has accumulated in the Plan for at least two years. Distributions to participants are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Notes receivable from participants are reported at the unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document. Notes receivable from various participants are accruing interest at rates from 9.00% to 9.50% with maturity dates through October 2028.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and maximum of \$50,000. Participant loans are subject to the approval of the plan administrator and bear interest equal to 1% above the prime rate. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to ten years. A participant may only have one loan outstanding at any time. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed by the Plan.

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less a discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings consistent with multiples of similar companies based on current market prices. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at estimated fair value as provided by John Hancock Life Insurance Company (John Hancock).

The fair value of guaranteed interest accounts are calculated based on information reported by John Hancock using published rates on which John Hancock pays interest for the specified terms. John Hancock provides the fair market value, comparing the rates in effect on the fair value date to the rates on which the actual interest is determined.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Administrative Expenses***

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the plan document.

### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024.

## **Note 3. Certification of the Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Tax Status**

On November 30, 2020, the Internal Revenue Service (“IRS”) stated that the pre-approved Profit Sharing/Money Purchase/CODA plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The plan has not received a determination letter specific to the Plan itself, however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time by the resolution of the Board of Directors, subject to the provisions of ERISA. In the event that the Plan and related trust fund terminate, all accounts will be valued as of the termination date and account balances will be distributed in full to participants.

#### **Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 7. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are pooled separate accounts and guaranteed interest accounts that are managed by John Hancock. John Hancock is the trustee of the Plan and Sentinel Benefits is the administrator of the Plan, and therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA. Fees paid to John Hancock for the year ended December 31, 2024 totaled \$40,280. Fees paid to Sentinel Benefits for the year ended December 31, 2024 totaled \$48,667.

**Note 8. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted priced in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
