### Note 1: Description of Plan

The following description of the Easter Seals Southeast Wisconsin, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Easter Seals of Southeast Wisconsin (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan. Alerus Financial, N.A (Alerus), the Custodian of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Plan Administrator.

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

#### Eligibility

Eligible employees include all regular full-time and part-time employees of the Employer who are not residents of Puerto Rico or temporary or seasonal, and are over the age of 21 and completed three months of service. As of January 1, 2024, long-term part-time (LTPT) employees who worked more than 500 hours in three consecutive years may enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements. Prior to January 1, 2024, temporary or seasonal employees whose normal work schedule was less than 1,000 hours per year were only eligible to participate in the Plan if they worked more than 1,000 hours during the Plan year and would enter the Plan on the first day of the month subsequent to satisfying their eligibility requirements. In addition to these requirements, employees are eligible to receive a discretionary employer matching and non-elective contribution if they are employed on the last day of the Plan year.

#### Contributions

Each year participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the maximum allowable by the Internal Revenue Service (IRS). Participants may also contribute distributions from other qualified plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

### Note 1: Description of Plan (Continued)

#### Contributions (Continued)

*Auto-Enrollment* - The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

*Employer Match* - The Employer may, at its discretion, make a matching contribution to the Plan. For the years ended December 31, 2024 and 2023, the match contribution was 3% of participating employee's eligible compensation.

*Employer Non-elective Contribution* - The Employer may also, at its discretion, make other non-elective contributions to the Plan. The Employer did not make any non-elective contributions to the Plan during the years ending December 31, 2024 and 2023.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, earnings thereon and an allocation of administrative expenses that are paid by the Plan. Allocations of Plan earnings and losses are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions portion of their accounts is based on years of continuous service. Employer contributions are vested on a graded schedule, as follows:

<i>Years of service</i>	<i>Vesting %</i>
1 year	20 %
2 years	40 %
3 years	60 %
4 years	80 %
5 years or more	100 %

A participant's accrued benefit is 100% vested upon a participant's death, total disability or attainment of normal retirement age of 60.

#### Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, up to the amount of the participant's vested interest in their account. Benefits may be paid in a lump-sum or installment distribution. The Plan allows for in-service distributions if a participant reaches 59 1/2 and allows for hardship distributions subject to Plan provision. A participant who terminates employment with a vested account balance \$7,000 or less will receive an involuntary cash-out distribution.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Employer before becoming 100% vested in the Employer's contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,577 and \$1,161, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the Plan document. Forfeitures used to reduce administrative fees were \$7,242 for the year ended December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Administrative Expenses

Expenses directly attributable to a participant's transaction are deducted from the participant's account. Certain expenses of maintaining the Plan are paid by the Plan. Plan expenses paid directly by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by the Custodian

Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and cash held at December 31, 2024 and 2023, and dividend income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Alerus, the Custodian of the Plan.

### Note 4: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### Note 5: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

### Note 5: Fair Value Measurements (Continued)

There have been no changes in the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investment for an amount different than the reported NAV. The fund is a stable fund and its NAV is based on the underlying investment held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of this fund or unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Party-In-Interest Transactions**

Plan investments in common collective trusts and mutual funds are managed by Alerus for the year ended December 31, 2024. These transactions, as well as administrative expenses, qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

### **Note 8: Tax Status**

The Employer adopted a nonstandard prototype document with an IRS notification letter, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
