## Independent Auditors' Report

### Opinion

We have audited the accompanying financial statements of AIMS Benefit Trust Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of AIMS Benefit Trust Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

**Note 1 - Description of plan**

The following description of the AIMS Benefit Trust Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

**General**

The purpose of the Plan is to provide medical, dental, vision, employee assistance program, and voluntary critical illness and accident benefits to participants of the Plan and their covered dependents under a multiple employer welfare arrangement. The Plan was established effective January 1, 2015, and operates under the AIMS Benefit Trust (the Trust), which was established effective August 1, 2014, and serves as the Plan Administrator and Plan Sponsor. The Plan was amended effective January 1, 2020 in order to change the Plan name from AIMS Health Plan to AIMS Benefit Trust Plan. The Plan is funded by contributions from the Participating Employers and employees and is fully insured by various insurance carriers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 1, 2024.

Medical benefits are provided under group insurance contracts with Cigna Health and Life Insurance Company in 2024, United Healthcare Insurance Company in 2023 and Kaiser Permanente in 2024 and 2023. Dental benefits are provided under group insurance contracts with Cigna Health and Life Insurance Company in 2024, United Healthcare Insurance Company in 2023, and Dominion National in 2024 and 2023. Vision benefits are provided under a group insurance contract with VSP Vision Care, Inc. Employee Assistance Program benefits are provided under a group insurance contract with Janus Associates, Inc. (dba BHS). Voluntary critical illness and accident benefits are provided under a group insurance contract with Reliance Standard Life Insurance Company. The Plan retains no risk of loss associated with these benefits.

Employer means an accredited member, provisional member, associate member or affiliate member of the Association of Independent Maryland & DC Schools (AIMS) (as those categories of membership are defined and administered under the AIMS Constitution), that is in good standing with AIMS, and that meets any other eligibility criteria established by the Trustees from time to time. Participating Employers complete a Participation Agreement, which allows each Participating Employer to, among other things, select an offering of component benefit plans, determine eligibility requirements, including any exclusions, and determine the waiting period and participation date. Eligible employees may elect to waive all benefits. Participating Employers may also elect to offer domestic partner or early retiree coverage. Retirees age 65 and older are not eligible to participate in the Plan, except for retirees of certain Participating Employers, which are allowed to offer vision and dental retiree benefits through prior contracts. Former employees and their dependents are eligible for continued coverage for the number of months specified under the Consolidated Omnibus Reconciliation Act (COBRA) of 1985, if they so elect.

Under the Participation Agreement, the Participating Employer is responsible for, among other things, ensuring that the selections made in the Participation Agreement comply in form with all legal requirements, including the Affordable Care Act (ACA). For “large” employers subject to the Affordable Care Act, the maximum average number of hours per week an employee must work to be considered full time is 30. In addition, the Participating Employer is responsible for ensuring that its operations relative to the Plan comply with all legal requirements, including the ACA, and that the Participating Employer administers the Plan so that it operates in compliance with the selections made in the Participation Agreement. This includes, but is not limited to eligibility, entry dates, waiting periods, and withholding of participant contributions from payroll in the proper amounts.

**Contributions and funding policy**

Participating Employers contribute funds on behalf of their employees as determined on a monthly basis. Contributions for electable coverage levels of participants are withheld from compensation for those electing such coverage. Contributions are based on rates determined by the Trustees, based on the number of covered employees and levels of coverage, and the applicable group insurance contracts through which the benefits are provided. Each Participating Employer is responsible for determining which portion of the monthly premium is to be paid by the participant.

**Payment of benefits**

The Plan provides certain medical, dental, vision and other coverage to Participating Employees based on the type of service rendered.

**Plan expenses**

Expenses incurred in the administration of the Plan are required to be paid with assets of the Plan unless the Plan Sponsor, at its discretion, elects to pay them. The administrative expenses were paid with assets of the Plan for the years ended December 31, 2024 and 2023. Educators Benefit Services provides the Plan with certain administrative services, including accounting, billing, COBRA administration and brokerage related to insurance plan selection and design (see Note 6).

**Note 2 - Summary of Significant Accounting Policies**

**Basis of accounting**

The financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America.

**Cash**

The Plan considers cash and cash equivalents to include anything with maturities of three months or less. All cash accounts are non-interest bearing in nature. Both cash and cash equivalents are on deposit with one financial institution. Balances may exceed the FDIC (Federal Deposit Insurance Corporation) limit of \$250,000; however, management does not anticipate a loss on this account.

**Fair value of financial instruments**

Contributions are accumulated in the Trust to pay medical, dental, vision, employee assistance program, and critical illness and accident premiums for insurance and Plan expenses. The Trustees of the Trust manage the Plan's assets, collect the income thereon, and make the payments therefrom. As of December 31, 2024 and 2023, the Plan's investments were limited to a cash account with Manufacturers and Traders Trust Co. (M&T), which is stated at fair value, and approximates cost.

**Deferred contribution revenue**

The Plan invoices Participating Employers for insurance premiums in advance of the periods to which they relate. Accordingly, these amounts are deferred and recognized in the period earned. Cobra premiums paid in advance are also deferred and recognized in the period earned.

**Payment of benefits**

Premium payments are recorded when paid and expensed in the period to which the benefits relate.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and premiums due to insurers and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to benefit obligations and net assets available for benefits and deductions from benefit obligations and net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Note 3 – Benefit obligations**

Health costs incurred by participants and their dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the Plan Sponsor and the Plan to continue obtaining insurance coverage for benefits.

**Note 4 – Income tax status**

As an employee welfare benefit plan and related taxable trust, the Plan and Trust are required to operate in conformity with the Internal Revenue Code (“IRC”) and ERISA. The Plan Administrator believes that the Plan and Trust are operating in compliance with the IRC and ERISA.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 5 – Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Plan shall first satisfy or make provisions to satisfy the obligations of the Plan. If the Plan Sponsor terminates or partially terminates the Plan, the Trust will pay benefits that participants are entitled to receive under the terms of the Plan.

**Note 6 – Party-in-interest transactions**

The Plan maintains a bank account with M&T, who serves as the Custodian for the Plan. Fees paid to M&T for the years ended December 31, 2024 and 2023 totaled \$11,149 and \$11,355, respectively, and are included in administrative expenses and professional fees in the accompanying statement of changes in net assets available for benefits. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Trust entered into a Memorandum of Understanding with Educator Benefit Services (EBS) effective December 1, 2014 and amended December 1, 2018, in which EBS provides the Plan with certain administrative services, including accounting, billing, COBRA administration, and brokerage related to insurance plan selection and design. In return for these services, the Participating Employers pay a monthly fee to EBS in the amount equal to a percentage of the monthly premium payable to Cigna Health and Life Insurance Company in 2024 and United Healthcare Insurance Company in 2023. The percentage of monthly premium payable to EBS for the monthly fee is approved during the annual renewal process. The percentage of monthly premiums payable to EBS for the monthly fee for the years ended December 31, 2024 and 2023 was 3.5% and 2.5%, respectively. The amounts paid to EBS for service fees during 2024 and 2023 qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. EBS services fees incurred for the years ended December 31, 2024 and 2023 totaled \$1,294,447 and \$1,003,624, respectively. EBS COBRA administration fees incurred for the years ended December 31, 2024 and 2023 totaled \$11,327 and \$12,035, respectively. EBS EAP administration fees incurred for the years ended December 31, 2024 and 2023 totaled \$4,128 and \$4,121, respectively. Expenses incurred for the EBS enrollment system, enrollment communications, sponsored health care concierge plan, sponsored wellness programs, and partial funding of the Plan's EAP program totaled \$718,931 for the year ended December 31, 2024; these expenses were paid using wellness funding from Cigna Health and Life Insurance Company.

**Note 6 – Party-in-interest transactions (continued)**

Expenses incurred for the EBS enrollment system and enrollment communication expenses totaled \$70,000 for the year ended December 31, 2023; these expenses were paid using wellness funding from United Healthcare Insurance Company.

AIMS, and its subsidiary, EBS, are Participating Employers in the Plan. During the year ending December 31, 2024, AIMS and EBS had employee contributions of \$-0- and \$9,914, respectively, to the Plan. During the year ending December 31, 2023, AIMS and EBS had employee contributions of \$-0- and \$6,454, respectively, to the Plan. During the year ending December 31, 2024, AIMS and EBS made employer contributions of \$24,925 and \$78,840, respectively, to the plan for the medical, dental, vision and EAP premiums. During the year ending December 31, 2023, AIMS and EBS made employer contributions of \$23,755 and \$87,307, respectively, to the plan for the medical, dental, vision and EAP premiums.

Prior to the establishment of the AIMS Benefit Trust, an account was set up by EBS to hold reserves that could be used by AIMS Benefit Trust Plan for administrative expenses and for the benefit of plan participants. In 2023, EBS withdrew \$396,375 from the reserves account and deposited the funds in the Plan. Of the \$396,375 that was withdrawn in 2023, \$200,000 was used in 2023 to offset the reduction in the percentage of monthly premiums payable to EBS paid by the schools and for administrative expenses. The remaining \$196,375 that was deposited into the Plan will be used for future Plan expenses. The account set up by EBS to hold reserves was closed in 2023.

In 2024, EBS contributed \$3,164 to the Plan to pay a portion of the 2024 EAP program management fees. In 2024, EBS also contributed \$90,000 to the Plan to pay a portion of 2025 and 2026 EAP program management fees; this is included in deferred revenue as the payments to Janus Associates, Inc. (dba BHS) for 2025 and 2026 EAP program management fees were not remitted in 2024. Total contributions from EBS to the Plan, reported as other contributions in the accompanying statement of changes in net assets available for benefits, include \$3,164 contributed in 2024 and the \$40,000 contributed and recorded as deferred revenue in 2023, recognized as revenue in 2024. In 2023, EBS contributed \$3,092 to the Plan to pay a portion of the 2023 EAP program management fees. In 2023, EBS also contributed \$40,000 to the Plan to pay a portion of 2024 EAP program management fees; this is included in deferred revenue as the payment to Janus Associates, Inc. (dba BHS) for 2024 EAP program management fees was not remitted in 2023.

**Note 7 – Wellness benefits**

The Plan receives funding for wellness benefits from Cigna Health and Life Insurance Company in 2024, United Healthcare Insurance Company in 2023, Kaiser Permanente, Educator Benefit Services (EBS) and participating employers. This funding is used to pay for wellness benefits, events and incentives for eligible participating employers and participants. A portion of the funding is also used to reimburse EBS for enrollment system and communications expenses.

In 2024, the Plan entered into an agreement with Evernorth Direct Health, LLC, Alegis Care – Maryland PC, and Alegis Care – District of Columbia PC for virtual health services to be provided for plan participants enrolled in medical coverage provided by Cigna Health and Life Insurance Company. The initial term of the agreement is thirty-six months. The cost of the services provided under this agreement is covered by wellness benefits provided by Cigna Health and Life Insurance Company.

In 2024, the Plan received wellness benefit income of \$1,536,050 from Cigna Health and Life Insurance Company and \$27,111 from Kaiser Permanente, for a total of \$1,563,161. In 2024, the Plan paid out wellness benefit expenses of \$112,776 to eligible participating employers, \$27,111 to participants, \$718,931 to EBS for enrollment system, enrollment communications, sponsored health care concierge plan, sponsored wellness programs, and partial funding of the Plan's EAP program, and \$682,413 to Evernorth Direct Health, LLC for virtual health services, and \$21,930 remained in the Plan for reimbursement of professional fees, for a total of \$1,563,161.

In 2023, the Plan received wellness benefit income of \$145,000 from United Healthcare Insurance Company, \$30,658 from Kaiser Permanente and \$33,146 from EBS, for a total of \$208,804. In 2023, the Plan paid out wellness benefit expenses of \$108,146 to eligible participating employers, \$40,834 to participants, and \$70,000 to EBS for enrollment system and communication expenses, for a total of \$218,980.

**Note 8 – Medical loss ratio rebate**

Under the ACA, certain insurance companies are required to pay annual rebates if their Medical Loss Ratio (MLR) for groups of insurance policies issued within a state is less than 85 percent for large employer group policies. The MLR is the percent of premiums used to pay for claims or expenses which improve health care quality. During the year ended December 31, 2024, the Plan received an annual rebate from United Healthcare Insurance Company in the amount of \$138,141, which was then allocated to the Participating Employers to distribute to their participants in the amount of \$133,141. During the year ended December 31, 2023, the Plan received an annual rebate from United Healthcare Insurance Company in the amount of \$1,612, which was then allocated to the Participating Employers to distribute to their participants in the amount of \$1,612.

**Note 9 – Subsequent events**

The Plan has evaluated subsequent events and transactions for potential recognition and disclosure through September 10, 2025, the date which the report was available for issuance. No events requiring disclosure have been noted.
