## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
Delve Holdings, Inc. 401(k) Plan  
Seattle, Washington

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Delve Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delve Holdings, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note A - Description of Plan

The following description of Delve Holdings, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan, restated as of January 1, 2022, is a defined contribution plan established for the benefit of employees of Delve Holdings, Inc. (the "Plan Sponsor"). The Plan is designed to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (the "Code") and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective March 1, 2023, the Plan changed its name to Delve Holdings, Inc. 401(k) Plan in conjunction with the corporate separation of McMillen, LLC with McMillen Jacobs Associates, Inc. whereas the Plan Sponsor, the surviving corporation, renamed itself as Delve Holdings, Inc.

Employees of the Plan are eligible to enter the Plan on the first day of the month following employment. In addition, to be eligible to receive the discretionary employer matching and profit sharing contributions, participants must have attained the age of twenty-one (21) and completed six months of service. Each year thereafter, participants must work at least 1,000 hours to be eligible to receive the employer matching and profit sharing contributions. Effective June 1, 2016, eligibility to receive the employer contributions was revised to match the eligibility to participate in the Plan and participants are no longer required to meet a service hour requirement to receive employer contributions.

#### *Plan Amendment*

The Plan was amended on March 1, 2023 to change the Plan name to Delve Holdings, Inc. 401(k) Plan.

#### *Contributions*

Participants may elect to defer up to the maximum allowable under the Internal Revenue Code of eligible compensation and contribute these amounts to the Plan. Participants may make after-tax Roth elective salary deferral contributions. In addition, participants over age 50 before the close of the Plan year are eligible to defer an additional catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

### Note A - Description of Plan (Continued)

#### *Contributions (Continued)*

The Plan Sponsor may make a matching contribution equal to a discretionary percentage of participant salary deferral contributions. Participants must have completed 1,000 hours of service during the Plan year to be eligible for the matching contribution. Effective June 1, 2016, participants do not need to meet a service hour requirement. For the year ended December 31, 2024, the Plan Sponsor has elected to not match the participant salary deferral contributions.

The Plan Sponsor may contribute a discretionary amount each year in the form of a profit sharing contribution. Participants must have completed 1,000 hours of service during the Plan year to be eligible for the profit sharing contribution. Effective June 1, 2016, participants do not need to meet a service hour requirement. The Plan Sponsor did not make any discretionary contributions during the year ended December 31, 2024.

#### *Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions, rollover contributions and employer matching and profit sharing contributions plus actual earnings thereon.

#### *Notes Receivable from Participants*

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of the participant's vested account balance, with a minimum loan amount of \$1,000. Participants may only have one loan outstanding at a time. If they have defaulted on a loan, no additional loans will be granted. Loan payments may be suspended for military service or for up to a year at the discretion Plan administrator. Loan repayment terms may be no longer than five years with the exception of loans qualifying as a home loan. Loans bear interest at 2% above the prime lending rate. Principal and interest are paid through payroll deductions.

### **Note A - Description of Plan (Continued)**

#### *Payment of Benefits*

Payments of benefits may be made on termination of service, due to death, disability, financial hardship or retirement. A participant may elect to receive either a lump-sum payment, installment payments, or an annuity equal to 50% of the participants vested account. Additionally, the Plan allows for in-service distributions at age 50 for employer contributions and 59 ½ for employee contributions.

#### *Forfeitures*

In accordance with the Plan document, forfeiture amounts may be used to reduce future employer contributions or to pay allowable Plan administrative expenses.

#### *Administrative Expenses*

Expenses of administering the Plan are paid by the Plan or Plan Sponsor, at the discretion of the Plan Committee. Expenses related to specific participant transactions are charged to the respective participant's account.

### **Note B - Summary of Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Plan invests in investment contracts through an annuity contract offered by the trustee. Contract value for this investment is based on the net asset value of the contract, as reported by the trustee.

#### *Use of Estimates*

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Note B - Summary of Accounting Policies (Continued)**

*Notes Receivable from Participants*

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions are included in the dividend income. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Subsequent Events*

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.

### Note C - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
Level 2	Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value instrument.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The fair value hierarchy also requires the plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

The Plan's investment in mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges and are at Level 1. The fair value of participation units held in common collective trust funds are based on their net asset values, as reported by the managers of the collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. Underlying investments of the S&P 500 Index Fund consist primarily of common stocks.

The Putnam Stable Value Fund invests primarily in guaranteed and security-backed investment contracts with life insurance companies, bank, and other financial institutions. The collective trust funds provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement. In accordance with standards this investment is measured at fair value using the NAV per share practical expedient and have not been classified in the fair value hierarchy. The fair value amounts presented in the table below is intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statement of Net Assets Available for Benefits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Matrix Trust Company, the Trustee of the Plan, has certified the completeness and accuracy of the investment balances presented on the schedule of assets available for benefits, the net depreciation of investments on the statement of changes in assets available for benefits. Additionally, the following tables sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

**Note E - Income Tax Status**

The Plan is intended to be a qualified plan under Section 401(a) of the Internal Revenue Code, and the Plan is interpreted, applied and administered consistent with the intent to qualify. The Plan operates through a prototype plan of CCH Incorporated, DBA ftwilliam.com., who had received a letter from the Internal Revenue Service indicating the Plan is acceptable.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note F - Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note G - Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
