Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Qualified Opinion

In our opinion, except for the omission of the information described in the Basis for Qualified Opinion section of our report, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Qualified Opinion

As discussed in Note 2 to the financial statements, Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan's financial statements exclude from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to former employees prior to January 1, 2009, as permitted by the Department of Labor Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such accounts are also excluded in the accompanying statement of changes in net assets available for benefits. Management has not determined the impact of this exclusion. In our opinion, disclosure of this information is required by accounting principles generally accepted in the United States of America.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the

financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - PLAN DESCRIPTION

The following description of the Mark Twain St. Joseph's Hospital 403(b) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information on the Plan's provisions.

General

The Plan is a 403(b) plan, also known as a tax-sheltered annuity (TSA), which was originally established effective September 1, 1990 for the benefit of eligible employees of Mark Twain St. Joseph's Hospital (the Organization). A section 403(b) plan is designed to benefit eligible employees of certain employers, which are tax-exempt under Internal Revenue Service (IRS) Code section 501(c)(3). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and the Internal Revenue Code (IRC). The Plan was restated and amended at various dates through December 31, 2024 to comply with applicable laws and regulations.

Effective January 1, 2010, employees of the Organization are covered under the Dignity Health Pension Plan cash balance formula and started making their elective deferrals into the companion Dignity Health 403(b) Savings Plan (Dignity Plan), where they receive matching contributions under a formula designed for Pension Plan cash balance formula participants. The Dignity Plan is sponsored by Dignity Health (formerly Catholic Healthcare West), the parent corporation of the Organization. As a result of these changes, no further elective deferrals or matching contributions were made to the Plan on or after January 1, 2010.

In February 2019, Dignity Health merged with Catholic Health Initiatives, becoming CommonSpirit Health.

Plan Administration

The Organization is the plan administrator and is responsible for day-to-day operations of the Plan. To fund the Plan, the Organization entered into the Multi-Fund Group Variable Annuity Contract (the Contract) with Lincoln National Life Insurance Company (Lincoln), the custodian of the Plan, which invests cash received, interest, and dividend income, and makes distributions to participants. Lincoln also administers the payments of interest and principal on loans to participants.

Contributions

Effective January 1, 2010, no employer or employee contributions of any type are made to the Plan, other than to correct operational errors.

Investment Options

Under the Contract, the Plan offers a combination of variable and fixed investment options. Variable investment options are made available through Lincoln's separate accounts, which have underlying investments in mutual funds registered with the Securities and Exchange Commission (SEC). Fixed investment option is made available through Lincoln's Fixed Account (the Fixed Account), which is guaranteed against loss of principal, less withdrawals, charges and adjustments. The Fixed Account is invested in accordance with applicable state regulations and guaranteed to earn at least a minimum rate of interest, as provided in the Contract. The interest is credited daily and declared on a quarterly basis.

Vesting

Participants are fully vested in their salary deferral contributions and earnings thereon. Vesting in the Organization's matching and discretionary contributions is 20% per year starting after two years of service.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to offset the expenses of the Plan.

Participant Accounts

Individual accounts are maintained for each participant to reflect the participant's contributions (including those rolled over from another qualifying plan) and related employer contributions, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations are based on the proportion that each participant's account balance bears to the total of all participant account balances.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may receive a lump-sum distribution or annuity payments of the participant's vested account balance. Participants should refer to the Plan agreement for more information.

Loans to Participants

Participants may borrow amounts from Lincoln using the assets of the Plan as collateral for the loans, as defined by the Plan document, subject to certain limitations. Principal and interest are paid by the participants directly to Lincoln over a period not to exceed five years, except in the case where borrowed funds are used by the participant to acquire a principal residence. The loans do not reduce the balance of participants' accounts unless the loan is in default at the time when the benefits are distributable.

At December 31, 2024, participants had no outstanding plan loan balances due to Lincoln. At December 31, 2023, participants had outstanding plan loan balances due to Lincoln in the amount of \$9,529.

Administrative Expenses

Administrative expenses are paid by both the Organization and the Plan. Some expenses related to the investment funds are paid from participants' accounts and are reflected in the financial statements of the Plan. All other expenses are paid directly by the Organization and are not reflected in the financial statements of the Plan.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

The Department of Labor (DOL) Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (as clarified by Field Assistance Bulletin No. 2010-01) allows the plan administrator of a 403(b) plan to exclude certain contracts and accounts from plan assets for purposes of ERISA's annual reporting and audit requirements under specified conditions. Accordingly, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to former employees prior to January 1, 2009. The related investment income and distributions have also been excluded from additions and deductions, respectively, in the accompanying statement of changes in net assets available for benefits. The amounts of these excluded accounts and the related income and distributions have not been determined. Accounting principles generally accepted in the United States of America (GAAP) require that these excluded accounts and its related income and distributions be included in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of additions and deductions during the reporting period. The most important of these estimates and assumptions relate to fair value measurements of the Plan's investments. These and other estimates and assumptions are based on the best available information but actual results could be materially different from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Valuation of Investments

Plan assets invested in Lincoln's separate accounts are stated at fair value based on the fair value of the underlying mutual funds, as adjusted for dividends and separate accounts' fees. The fair value of underlying mutual funds is based on quoted market prices. Separate accounts are not publicly traded and are classified within Level 2 of the valuation hierarchy.

The Plan's investment in the Fixed Account is considered to be fully benefit-responsive and is required to be reported at contract value because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract with Lincoln through the Fixed Account, which is part of Lincoln's General Account. The Fixed Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The terms of the investment contract require all permitted participant-initiated transactions with the Plan to occur at contract value with no conditions, limits, or restrictions. The investment contract issuer guarantees the principal and a minimum rate of return. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Investment Contract with Insurance Company – Continued

Certain events, such as market value adjustment and surrender charges, could limit the ability of the Plan to transact at contract value. However, the plan administrator does not believe that any of the events that may limit the ability of the Plan to transact at contract value are probable.

Recognition of Income

Sales and purchases are accounted for on a trade date basis, and interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Change in Fair Value of Investments

Net change in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid. Benefit claims are accrued when they have been processed and approved for payment by the Plan.

Recent Accounting Pronouncements

In the normal course of business, the Plan evaluates all new accounting pronouncements to determine the potential impact they may have on its financial statements. Based upon this review, the Plan does not expect any of the recently issued accounting pronouncements, which have not already been adopted by the Plan, to have a material impact on its financial statements.

Subsequent Events

The Plan evaluated for recognition or disclosure subsequent events through the report issuance date and determined that no such events were identified.

NOTE 3 - TAX STATUS

The Plan is intended to comply with the applicable requirements of Section 403(b) of the IRC. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 3 - TAX STATUS – CONTINUED

In accordance with GAAP, the Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. As a result, the Plan has recognized no interest or penalties related to uncertain tax positions.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 4 - PLAN AMENDMENT AND TERMINATION

The Organization has the right under the Plan document to discontinue its contributions at any time and to amend or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested for any portion of their accounts not fully vested previously.

NOTE 5 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (an exit price). The fair value hierarchy prioritized the inputs to valuation techniques used to measure fair value into three levels, with the highest priority given to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority given to unobservable inputs (Level 3). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one level to another. In such instances, the transfer is reported at the end of the reporting period. There have been no transfers from one level to another during the year ended December 31, 2024.
