### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document and/or the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

Effective February 1, 1987, the Viking Yacht Company ("Company") established a defined contribution savings plan for its employees. The Plan meets the requirements of Internal Revenue Code Section 401(k) which permits employees to exclude contributions to the Plan from their current taxable income, subject to certain limits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees who are 18 years of age and complete six months of service are eligible to participate. For purposes of elective deferral contributions and employer matching contributions, employees are able to enter the Plan the first day of the calendar month coinciding with or next following the date on which the employee meets the eligibility requirements. For all other purposes, employee participation begins as of the first of the quarter coincident with or next following the date on which the employee meets the eligibility requirements.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company contributions and an allocation of the Plan's gains or losses and charged with an allocation of investment expenses. The Plan's earnings and investment expenses are allocated according to participants' relative account balances in the investment options. Certain participant and loan fees, if applicable, are also charged to participant accounts.

#### **Participation, Vesting and Withdrawals**

Employees may elect to contribute from 1% to a maximum of 15% of their base or gross salary, not to exceed \$23,000 (\$30,500 for employees age 50 or older) in 2024 ("basic contribution"). For every dollar an employee invests up to 10% of compensation, the Company will provide a 50% "matching contribution". In addition, effective for Plan years beginning January 1, 2005, the Company will match 50% of any "catch-up" contributions. The Company's Board of Directors, at its sole discretion, may make a "supplemental contribution". No "supplemental contributions" were authorized or made during 2024.

Participants are immediately vested in their voluntary contributions. In addition, Company matching contributions to participants' accounts and rollover contributions from the Company's terminated defined benefit plan, as well as the related earnings thereon, are fully vested at all times. Company discretionary contributions to participants fixed and supplemental contribution accounts, if any, as well as related earnings thereon, vest as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
After 2 years but less than 3	20%
After 3 years but less than 4	40%
After 4 years but less than 5	60%
After 5 years but less than 6	80%
After 6 years or more	100%

The opportunity to withdraw contributions originally excluded from taxable income is limited by the Internal Revenue Code contingent upon attaining age 59-1/2 or for certain situations involving hardship.

#### **Participant loans**

Participants may borrow the lesser of one-half of their vested account balance or \$50,000. The minimum loan is \$1,000. Loans are repaid through bi-weekly payroll deductions over a period not to exceed five years, unless the loan is used to acquire a dwelling unit which is the borrower's principal residence, then repayment within a reasonable period of time. Interest on loans is charged at the prime rate. Loans are secured by the pledge of the participant's interest in the Plan.

#### **Benefits**

Participants are entitled to a benefit payment equal to the amount credited to their account, valued in accordance with Plan provisions described above, upon retirement, age of 59-1/2, permanent disability, termination of employment or death. Payments are generally distributed in a lump sum subject to certain restrictions as defined in the Plan.

#### **Forfeitures**

Forfeitures of terminated participants' nonvested accounts may be used to reduce the amount of future contributions required to be made to the Plan by the Company or to pay plan expenses.

As of December 31, 2024 and 2023, there were no forfeited accounts.

#### **Administrative Costs**

Administrative expenses of the Plan are paid or reimbursed by the Company.

#### **Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act; however, plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

### NOTE B - SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Viking Yacht Company Retirement Savings Plan (the Plan) are prepared using the accrual method of accounting.

#### **Investment Valuation and Income Recognition**

The Plan's investments in registered investment companies (mutual funds) are stated at fair value as reported by the Investment Manager using quoted market prices available in active markets. The investment in the common collective trust is stated at fair value using net asset value as a practical expedient.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend date.

The value of the assets of the Plan will be determined as of the last day of each Plan year quarter.

#### **Participant Loans Receivable**

Participant loans receivable are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document. Loan interest is recognized as accrued.

#### Distributions to Participants

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Date of Management's Review

Management has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.

### NOTE C - RELIANCE ON CUSTODIAN'S REPORT

The administrator of the Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Fidelity Personal Trust Company, the custodian of the Plan, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, other than comparing such information to that contained in the financial statements and supplemental schedules. The information certified by the custodian, which was relied upon in the preparation of these financial statements and schedules, includes:

### NOTE D - FAIR VALUE OF FINANCIAL INVESTMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Mutual Funds**

Mutual funds have quoted market prices for identical assets in active markets; therefore, the investments are measured at fair value using these readily available Level 1 inputs.

#### **Common/Collective Trusts**

Common collective trusts are stated at net asset value per share as a practical expedient.

**NOTE E - TAX STATUS**

The prototype plan has received an opinion letter dated June 30, 2020 from the IRS that the prototype plan sponsored by Fox Rothschild LLP and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan, as amended, is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE G - OPERATING EXPENSES**

Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Investment fees that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. The total amount of fees deducted was \$61,626 for the year ended December 31, 2024.

**NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As described in Note G, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Certain operating expenses are paid by the Plan sponsor on behalf of the Plan. Participant loans qualify as party-in-interest transactions. Certain investments of the Plan are managed by the custodian.

### NOTE I - PLAN TERMINATION

During the years ended December 31, 2023 and 2022, employee contributions were not remitted timely by the Company, however the necessary corrections were made by the Company accordingly. Lost earnings were determined, and the Company remitted the lost earnings to the Plan.
