## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1. Description of the Plan

The following brief description of First American Bank Corporation Profit Sharing Plan (the Plan) is provided for general information purposes only. The Plan was adopted January 1, 1986, and restated effective January 1, 2015. During 2024, the Plan changed its custodian from First American Bank Corporation to Mid Atlantic Trust Company dba American Trust Custody and its recordkeeper from First American Bank Retirement Services to AT Retirement Services, LLC. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a contributory defined contribution retirement plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation. The sponsor of the Plan is First American Bank Corporation (the Company).

**Eligibility and Participation** - Employees are eligible to begin making elective deferrals beginning on the first day of the quarter after they have completed one month of service. Employees who do not decline participation upon eligibility are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation, as defined by the Plan. Full-time employees are eligible for employer match and profit sharing contributions after completing one year of employment, with at least 1,000 hours of service. Employees must be at least 21 years of age to participate in the Plan.

**Contributions** - Each year, participants may contribute a portion of eligible pre-tax and post-tax annual compensation, as defined by the Plan and subject to Internal Revenue Service limits. For the years ended December 31, 2024 and 2023, the Company contributed a safe harbor matching contribution for each participant equal to 100% of each participant's elective deferrals, up to 3% of the participant's compensation, plus 50% of each participant's elective deferrals in excess of 3% but not in excess of 6% of the participant's compensation. For the years ended December 31, 2024 and 2023, the Company elected to fund the employer matching contribution of \$3,329,298 and \$3,147,713 respectively, through a contribution to the First American Bank Corporation Employee Stock Ownership Plan. The Company may also contribute a discretionary profit sharing amount annually, as determined by the Board of Directors. For the years ended December 31, 2024 and 2023, the Company contributed \$2,109,843 and \$1,948,778 respectively, in discretionary profit sharing contributions.

## **Note 1. Description of the Plan (continued)**

**Investments** - Participants may direct contributions into various investment options offered by the Plan. Automatically enrolled participants have contributions invested in a designated investment fund until changed by the participant. Participants must evaluate their own investment goals and objectives. Poor investment performance may cause participants' balances to be lower than the amounts contributed to the Plan on their behalf.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, allocations of any Company profit sharing and matching contributions made to the Plan, as well as allocations of investment earnings or losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Company profit sharing contributions are allocated in accordance with the permitted disparity regulations (Social Security integration).

**Vesting** - Participants are immediately vested in rollovers, trustee-to-trustee transfers, their elective deferrals and safe harbor matching contributions, plus actual earnings thereon. Vesting in the profit sharing portion of a participant's account is based on years of credited service. Participants have no vested interest in their accrued benefit until completing two years of vesting service, at which point the account will vest ratably through six years of service, until 100% vested. A participant becomes 100% vested upon retirement, death or disability.

**Payment of Benefits** - Upon termination, death or disability, benefit payments may be made in lump-sum amounts, partial withdrawals, or periodic installments. No hardship withdrawals are provided under the Plan.

**Notes Receivable from Participants** - Except for participant loans transferred as part of prior plan mergers, the Plan does not otherwise offer participant loans. The loans were secured by the balance in the participant's account. Loan interest rates ranged from 5.75% to 6.25% during the years ended December 31, 2024 and 2023. Principal and interest were repaid ratably through biweekly payroll deductions. There were no notes receivable from participants outstanding at December 31, 2024.

**Forfeitures** - Nonvested amounts forfeited by participants may be used as additional non-elective or matching contributions, to reduce non-elective or matching contributions, or to pay the Plan's administrative expenses. During the years ended December 31, 2024 and 2023, nonvested amounts of \$26,761 and \$19,100 respectively, were forfeited. Forfeitures used in accordance with Plan provisions totaled \$21,183 and \$48,261 during the years ended December 31, 2024 and 2023, respectively. The balance of forfeited accounts was \$27,229 and \$21,183 at December 31, 2024 and 2023, respectively.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Investments** - Investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Company or the Plan, as provided in the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### **Note 3. Priorities upon Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Note 4. Tax Status**

The Plan has adopted a non-standardized form of a prototype plan. The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

## Note 5. Fair Value Measurements (continued)

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

### Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

## **Note 5. Fair Value Measurements (continued)**

### Measurements Using Net Asset Value as a Practical Expedient

Certain investments are valued at the net asset value per share (or its equivalent), used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The investment funds of funds are valued on a unitized basis with underlying assets that primarily include equity and fixed income mutual funds. There are no significant liquidity or withdrawal restrictions on these funds.

The collective investment funds are considered direct filing entities (DFEs) and file a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the investment strategies of DFE investments. There are no significant liquidity or withdrawal restrictions on these funds.

## **Note 6. Party-in-Interest Transactions**

First American Bank Corporation (the Company) is the Plan Administrator as defined by the Plan. Fees incurred by the Plan for services amounted to \$6,504 and \$7,536 for the years ended December 31, 2024 and 2023, respectively. In addition, participants may invest in various investment funds of funds and a collective investment fund that are sponsored by the Company. Therefore, these transactions are party-in-interest transactions under ERISA.

## **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, including credit, interest rate, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.
