### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Emeritus Institute of Management, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in

accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1—Description of Plan

The following description of the Emeritus Institute of Management, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan began January 11, 2023, and serves Emeritus Institute of Management, Inc. (the Sponsor). The Plan is a defined contribution plan covering all employees of the Sponsor who have at least 3 months of service and who have attained the age of 21 years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year participants may contribute a portion of their compensation, not to exceed the amount allowed under current law. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. The Sponsor provides a matching contribution based on the participant's elective deferral. The Sponsor matches 100% of the Participants elective deferrals up to 3% of their compensation and 50% of up to an additional 2% of their compensation. The Sponsor may also make an additional discretionary contribution. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses related to the administration of notes receivable from participants and investment related expenses are charged directly to the participant's account and are included in administrative expenses.

Participant accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Sponsor's matching contribution, (b) the Sponsor's discretionary contribution, if any, and (c) Plan earnings. Each participant's account is also charged with an allocation of administrative expenses, where applicable. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the safe-harbor match contributions plus earnings thereon. Vesting in the Sponsor's discretionary contribution portion of their accounts is based on years of service, as defined.

The following table shows the vesting schedule by years of service for the Sponsor's discretionary contributions:

Forfeitures: Forfeited non-vested accounts may be used to reduce contributions or pay Plan expenses. Forfeitures were used to reduce employer contributions or Plan expenses for the year ended December 31, 2024. During 2024, forfeitures of \$4,971 were used to reduce Plan expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1 and \$9, respectively.

Involuntary distributions: In the rare event a former participant does not provide written distribution instructions to the plan administrator, the plan administrator may elect to pay distributions of vested accounts of less than \$5,000 in a direct rollover to an individual retirement plan designated by the plan administrator.

Payment of benefits: Distribution of a participant's account may be in a single lump-sum payment in cash or in a series of partial withdrawals of a portion of their vested account balance in accordance with the Plan's provisions.

Hardship distributions: Hardship distributions from the Plan are permitted for medical expenses, the purchase of a principal residence, tuition and other post-secondary expenses, amounts necessary to prevent eviction, funeral expenses and certain qualifying repairs to the participant's primary residence. Distributions for this reason are subject to approval by the Plan administrator.

Notes receivable from participants: Participants may borrow from their accounts up to \$50,000. Only one loan is permitted to be outstanding at one time. Interest rates on outstanding loans as of December 31, 2024 and 2023, ranged from 8.50 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions. The loans are secured by the participant's account balance in the Plan.

#### Note 2—Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. In accordance with US GAAP, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Related party and party in interest transactions: Plan fees are paid to Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Fees are also paid to the Plan's investment advisor and audit firm. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$69,127 to these entities for the year ended December 31, 2024.

Plan termination: Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

#### Note 3—Information Certified by the Trustee

Fidelity Management Trust Company, the trustee of the Plan, has certified that the following information is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants
- Investment return
- Interest income on notes receivable from participants

#### Note 4—Summary of Fair Value Measurements

Fair value measurements: In accordance with US GAAP, a fair value hierarchy for inputs is used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan or Trustee. Unobservable inputs reflect the Plan's assumptions about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets and liabilities in inactive markets.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV). The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5—Tax Status

The Internal Revenue Service (IRS) has determined and informed the Sponsor by the letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of an asset, liability, or disclosure in the financial statement.

**Note 6—Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**Note 7—Subsequent Events**
