## **Note 1. Description of the Plan**

### ***General***

The following description of AMDOCS, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by AMDOCS, Inc. (the “Company”) for the benefit of its employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Empower Annuity Insurance Company (“EAIC”) serves as the Plan trustee and custodian.

### ***Contributions***

The Company contributes a matching contribution to the Plan an amount equal to 50% of each participant’s covered compensation, subject to a maximum amount of 6% of each participant’s compensation contributed as elective deferrals. Additional amounts may be contributed at the discretion of the Company; however, there were none for 2024 or 2023. Participants may contribute up to 50% of their annual covered compensation as defined. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company’s contribution portion of their accounts plus earnings thereon is based on years of service. A participant becomes 20% vested after one year of credited service and 20% each year thereafter, resulting in 100% vesting after five years of credited service. The non-vested balance is forfeited upon termination of service. Forfeitures are used to restore certain forfeitures as described in the Plan Document, pay administrative expenses or reduce future employer contributions.

### ***Payment of Benefits***

On termination of service, an employee may elect to receive the value of their vested account either as a lump-sum amount or in installment payments.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,036,485 and \$156,518, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$249,286 and \$636,815, respectively, from forfeited non-vested accounts.

### ***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

### ***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan holds interests in pooled separate accounts and a guaranteed income fund, which invest in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The accounts may invest in securities, mutual funds, index funds or a combination of other accounts. Pooled separate accounts are valued at estimated fair value as provided by EAIC.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

### ***Plan Tax Status***

The Plan has obtained a letter dated September 26, 2022, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### ***Subsequent Events***

Effective July 1, 2025, the Plan was amended and the AMDOCS IT Services, L.L.C. Retirement Savings [401k] Plan ("AITS Plan") was merged into the Plan. The AITS Plan assets of \$102,769,358 were transferred to the Plan into funds comparable to those offered by the custodian and trustee of the AITS Plan, which is also EAIC. The conversion initiated a "Black Out" period beginning June 26, 2025, and continued through July 13, 2025. During this period, funds could not be applied to the employee-selected funds with the EAIC or withdrawn from the Plan until the EAIC had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited and held by EAIC until the completion of the Black Out period. At the end of the Black Out period, these funds were invested in funds as requested by each participant.

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. In addition, the Plan had no assets measured at fair value on a nonrecurring basis.

### ***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy and include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters. Such investments are classified in Level 2 of the valuation hierarchy and include pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan has no Level 3 investments.

### **Note 4. Investment Contract with Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract with EAIC (Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Only an event causing liquidity constraints at the Insurance Company could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value over time. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and any person who owns 50% or more of such an employer or relatives of such persons.

The Plan incurs expenses related to general administration and record keeping. The Company pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.

The Plan invests in certain funds of the EAIC.

**Note 6. Plan Amendments**

Effective August 23, 2023, the Plan was amended to allow ProCom Consulting, Inc (ProCom) to adopt the Plan. Employees of ProCom were allowed to enroll in the plan effective September 18, 2023.

Effective November 1, 2023, the Plan was amended to permit Roth contributions to the Plan.

Effective November 2, 2023, the Plan was amended to allow Astadia, Inc. (Astadia) to adopt the Plan. Employees of Astadia were allowed to enroll in the plan effective January 1, 2024.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
