We have performed audits of the accompanying financial statements of The Chef's Warehouse 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. Description of Plan

The following description of The Chef's Warehouse 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with 401(k) salary reduction and profit sharing features. Plan participants include all eligible employees of Dairyland USA Corporation and its affiliates (the "Company" or "Employer") who have completed 30 days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. The money that is deducted is "pre-tax" dollars. Participants who are age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may change their contribution amounts as of the first day of any month. Participants may also contribute amounts representing distributions from other qualified plans.

At the Employer's sole discretion, the Company may make a matching contribution on behalf of each participant in any specific percentage of the participants' elective deferrals. The Company has made matching contributions for the year ended December 31, 2024. The matching contribution is the lesser of 50% of the participant's contributions or 3% of participant's eligible wages.

The Employer may make discretionary profit sharing contributions in amounts set by the Employer each year. Employees do not have to make 401(k) contributions in order to receive a discretionary profit sharing contribution, which is based on participant compensation. There were no Employer discretionary profit sharing contributions made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings on their specific investments and Employer matching and discretionary profit sharing contributions, if any. Allocations of Plan earnings are based on each participant's account balance while Employer contribution allocations of earnings are based on the participant's compensation, as defined in the plan document. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

Vesting

A participant is 100% vested in their contributions including allocated earnings thereon at all times. For any Employer matching and discretionary profit sharing contributions, the following vesting schedule applies:

Forfeitures

At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts were \$1,374 and \$11,529. These accounts are used to reduce Employer contributions and/or administrative expenses. During 2024, \$401,557 of forfeitures were used to reduce Employer contributions and \$12,132 were used to reduce Plan expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-Service distributions from all contributions are permitted upon reaching age 59 ½. A participant may make a withdrawal for reasons of economic hardship prior to attaining age 59½.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net asset value ("NAV") of the respective investment vehicle and consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the NAV per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The self-directed brokerage account consisted of common stocks. Common stocks are traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 7, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution.

5. Common/Collective Trusts

Invesco Stable Value TR Class III

At December 31, 2024 and 2023, certain assets of the Plan were invested in the Invesco Stable Value TR Class III. This investment is part of the Invesco Stable Value Trust (the "Fund"). The Fund is a collective trust established and maintained by Invesco National Trust Company, the trustee of the Fund.

The Fund may invest in bank, insurance company and other financial institution investment contracts ("GICs"). The Fund holds synthetic guaranteed investment contracts ("synthetic GICs"). Synthetic GICs are portfolios of securities (debt securities or units of collective trusts) owned by the Fund with wrap contracts associated with the portfolios. The Fund's investment contracts are carried at contract value which is equal to the principal balance plus accrued interest plus deposits and less withdrawals. Units are issued and redeemed daily at the Fund's constant NAV of \$1 per unit. Distributions of net investment income are declared daily and paid monthly. Such distributions are reinvested in the month-end net unit value. A participating trust is required to give the Trustee 24 months' irrevocable written notice of intent to redeem all or a portion of its participation in the Fund.

Principal Lifetime Hybrid Collective

The Plan offers 13 common/collective trusts called the Principal LifeTime Hybrid Collective Investment Funds ("Funds"), which include: the Principal Lifetime Hybrid Inc CIT; the Principal LifeTime Hybrid 2015 CIT; the Principal LifeTime Hybrid 2020 CIT; the Principal LifeTime Hybrid 2025 CIT; the Principal LifeTime Hybrid 2030 CIT; the Principal LifeTime Hybrid 2035 CIT; the Principal LifeTime Hybrid 2040 CIT; the Principal LifeTime Hybrid 2045 CIT; the Principal LifeTime Hybrid 2050 CIT; the Principal LifeTime Hybrid 2055 CIT; the Principal LifeTime Hybrid 2060 CIT; the Principal LifeTime Hybrid 2065 CIT and the Principal LifeTime Hybrid 2070 CIT. The unit value of each of these Funds is determined on a daily basis.

Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. The common/collective trusts have no unfunded liabilities.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100% vested in any unvested Employer contributions allocated to their accounts.

7. Tax Status

The Company has adopted an approved volume submitter plan which received an IRS advisory opinion letter dated June 30, 2020, which indicated the form of the Plan satisfied the qualification requirements under Section 401(a) of the IRC. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Principal Trust Company, is the trustee of the Plan. Fees paid by the Plan to the trustee amounted to \$273,568 for the year ended December 31, 2024.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Prohibited Transactions

During 2023, 2022 and 2021, the Employer failed to timely remit to the Plan certain participants' contributions and loan repayments, amounting to \$1,041,033, \$1,823,676 and \$740,678 within the period prescribed by Department of Labor regulations. Also, during 2019, the Employer failed to timely remit loan repayments, amounting to \$11,738 within the period prescribed by Department of Labor regulations. In November 2023, \$100,184 of the 2022 delinquent contributions were corrected and the lost earnings were allocated to the affected participants. For the remaining \$3,516,914 delinquent contributions and loan repayments, pursuant to the guidance issued by the Department of Labor, lost earnings were calculated and allocated to affected participants in the Plan by the Employer during 2024.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
