Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Brotherhood of Maintenance of Way Employes Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brotherhood of Maintenance of Way Employes Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in notes to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Brotherhood of Maintenance of Way Employees Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Brotherhood of Maintenance of Way Employees Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

DESCRIPTION OF PLAN:

The following description of the Brotherhood of Maintenance of Way Employees Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General- Brotherhood of Maintenance of Way Employees Division of the International Brotherhood of Teamsters 401(k) Retirement Savings Plan is a defined contribution plan covering all employees who have six months of service and have attained age eighteen, except for certain nonresident aliens who have no earned income from sources within the United States. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions-Each year, participants may contribute a percentage of their eligible compensation. Catch-up contributions, Roth contributions, bonus contributions, and rollover contributions may also be made. In addition, the employer may make contributions. Contributions are subject to certain limitations. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

Participant Accounts-Each participant's account is credited with the participant's contribution and allocations of the employer's contributions, and fund earnings, and charged with an allocation of administrative expenses.

Vesting-Participants are immediately vested in their contributions plus actual earnings thereon and employer's contribution portion of their accounts plus actual earnings thereon.

Note Receivable from Participant – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and interest is computed based on the prime rate ranging from prime to prime +2%, which are commensurate with the prevailing rate charged by a person who is in the business of lending money for a comparable loan. Principal and interest is paid ratably through monthly payroll deductions.

Administrative Expenses – Substantially all administrative expenses are paid by the employer.

Investment Options – The assets of the Plan are allocated to the various funds at the direction of the participant.

Payment of Benefits-Upon termination of employment due to death, disability or retirement, participants may request a distribution of their vested account either as a lump sum or in installments.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Estimates-The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments-The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Payment of Benefits-Benefits are recorded when paid.

Interest on participants' loans is recorded on accrual basis.

OTHER COMMITMENTS:

To the best of our knowledge, there are no material lease commitments, contingent liabilities or transactions with persons known to be parties in interest as of December 31, 2024, except transactions exempt by ERISA Section 408.b.

TERMINATION OF PLAN:

The Employer has no legal or contractual obligation to make annual contributions to or to continue the Plan. Although it has not expressed any intent to do so, the Employer reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate, with the approval of the Board of Directors. In the event that the plan would be terminated, each participant affected by such termination shall have a vested interest in his account of 100%. The Plan Administrator will facilitate the distribution of account balances in simple lump sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the Trustee.

TAX STATUS:

The plan obtained its latest determination letter on March 31, 2008, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan has been amended since receiving the determination letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes has been included in the plan's financial statements.

The Plan files Form 5500 annually with the Internal Revenue Service. The tax years that remain open for examination under the IRS are 2021, 2022 and 2023.

BANK CERTIFICATION OF CERTAIN DATA:

Section 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and disclosing under ERISA permits that a bank which holds the assets of a pension plan may certify to the accuracy and completeness of certain financial information and other disclosures required by ERISA. The following information included in the financial statements and supplemental schedules was obtained from data included in the 2023 and 2024 trust reports that Ascensus has certified to the best of its knowledge and belief to as accurate and complete.

RISKS AND UNCERTAINTIES:

The Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. The fair values for investments are determined by reference to quoted market prices. The fair values are priced daily through various pricing services.

Level 1 are quoted prices in active markets for identical assets. Level 2 pricing is generally available through indirect information, such as quoted prices for similar assets in active markets, or quoted prices for identical or similar assets in markets that are not active. Level 3 are the most unobservable, are generally based on the entity's own assumptions on how knowledgeable parties would price assets, and are developed using the best information available in the circumstances.
