Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance

and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. Description of Plan

The following brief description of the American Financial Group, Inc. Welfare Benefits Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Descriptions for more information.

General The Plan is primarily a self-insured, welfare benefits plan sponsored by American Financial Group, Inc. and its participating subsidiaries ("Company" and "Sponsor") for the benefit of employees and eligible retirees. The Plan consists of four primary benefits: medical care coverage, dental coverage, vision coverage and long-term disability coverage. Certain additional benefits provided for in the Plan are not reported within these financial statements because they are funded directly from the general assets of the Company. The Plan is self-insured with respect to medical care coverage.

The Company's medical program has two enrollment options: a qualifying High Deductible Health Plan ("HDHP") with the option to participate in a Health Savings Account ("HSA") and a Surest No-Deductible Medical Plan ("Surest"). Under each option, four levels of coverage are offered: employee, employee plus spouse, employee plus child(ren), and family. Each option has different premium rates and benefit levels. In the HDHP, after annual deductibles are met, participants are responsible for 20% of costs paid to in-network providers and 40% of costs paid to out-of-network providers, up to annual out-of-pocket maximums that ranged from \$5,250 to \$30,100 in 2024, depending on the level of coverage. In the Surest Plan, copay costs range from \$0 to \$2,000 for in-network providers and \$0 to \$6,000 for out-of-network providers, up to annual out-of-pocket maximums that ranged from \$4,400 to \$22,206 in 2024, depending on the level of coverage.

Eligible employees can have a portion of their compensation withheld on a pretax basis and credited to an individual participant HSA and/or flexible spending account ("FSA") to cover qualified out-of-pocket medical expenses. The FSA account is also available for dependent care expenses. In 2024, the Plan matched employee contributions to qualifying HSA accounts of eligible employees enrolled in the HDHP, up to \$825 to \$2,075 per year, depending on the level of coverage. Eligible employees enrolled in the Surest received a credit against annual enrollment costs of \$825 to \$2,075 per year, depending on the level of coverage in 2024.

Administrative costs of the Plan are paid by the Plan unless the Company elects to pay these expenses. United Health Group ("UHG") is the administrator for the medical care coverage, HSA and FSA. Fees paid to UHG accounted for 95% of the Plan's administrative expenses in 2024. UHG processes claims, determines eligible benefits and coordinates with PNC Bank (Plan trustee) on the transfer of funds from the Plan to UHG's claims paying account. Although benefits are processed by UHG, responsibility for payments is retained by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided, discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

Risk Management Although the Plan is primarily self-insured, insurance contracts and coverage terms limit the Plan's liability in certain circumstances. For dental coverage, an insurance contract with Delta Dental provides coverage to those employees who choose to participate in the dental plan, and their spouses and dependents depending on the level of coverage. For long-term disability coverage, an insurance policy with New York Life Group Benefit Solutions provides full coverage for all participants. For medical coverage, a stop-loss policy covers any individual's medical claims after \$950,000 in a calendar year. In addition, there is a \$2 million lifetime medical claims limit on non-essential benefits, per enrolled member.

Participation For active employees, participation in the Plan is voluntary as to the medical, dental, and vision coverage and automatic as to the long-term disability coverage. In addition, retired employees who meet certain service and age requirements as of their date of retirement are eligible to participate in the medical program.

Participant Contributions Participants generally make contributions in the range of 11% to 35% of the expected cost of the medical coverage depending on the plan option chosen by the participant, 28% to 34% of the dental coverage and 100% of the vision coverage. Contributions withheld from payroll are remitted to the Plan as soon as administratively possible.

Employer Contributions Employer contributions to the Plan are remitted as needed to cover benefit payments and expenses, subject to certain limitations. Such contributions are in the range of 65% to 89% of the anticipated annual cost of the medical coverage, 66% to 72% of the dental premiums and 100% of the long-term disability premiums.

The Plan also records a contribution receivable equal to the Sponsor's recorded liability for future benefit obligations of the Plan.

B. Significant Accounting Policies

The accompanying financial statements were prepared on the accrual basis of accounting. The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Changes in circumstances could cause actual results to differ materially from those estimates.

Events or transactions occurring subsequent to December 31, 2024, and prior to September 30, 2025, the date on which the financial statements were available to be issued, have been evaluated for potential recognition or disclosure herein.

Cash and Cash Equivalents The Plan considers all highly liquid investments with maturity dates of three months or less to be cash equivalents. At times, cash and cash equivalents may exceed federally insured limits.

Claims Incurred But Not Reported Medical claims incurred but not reported by participants other than retirees are estimated based on experience and developing trends, such as claim severity and changes in participant demographics. Medical claims incurred but not reported by retired participants are calculated as part of the postretirement benefit obligation.

Stop Loss Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in benefit obligations and net assets available for benefits. Stop loss refunds in 2024 of approximately \$1.07 million have been netted with medical care benefits paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Postretirement Benefits The Company offers postretirement medical care benefits at varying levels to a limited number of employees, primarily those hired before January 1, 1993. The maximum benefit for the majority of eligible retirees is a Health Reimbursement Account contribution of \$25,000 at retirement. The postretirement benefit obligation represents the total present value of estimated future benefits (as determined by an actuary) that are attributed to employee services rendered through the valuation date. Computations are based on historical claims cost, anticipated mortality and morbidity and projected increases in health care costs. The December 2024 valuation assumes that health care costs will increase 6.50% in 2025 with subsequent annual increases declining 0.25% per year to an annual trend of 5.00% for 2031 and each year thereafter. Other significant assumptions in the valuation include an average retirement age of 63, mortality information from the PriH-2012 Mortality Table using generational projection with scale MP-2021 and a discount rate of 5.00% for 2024 and 2023.

The postretirement obligation is based on the presumption that the Plan will continue. If the Plan were to be terminated, different assumptions would be applicable in determining the postretirement benefit obligation.

C. Benefit Obligations

The actuarial present value of benefit obligations is calculated based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would result in material changes to the financial statements. The increase in per capita cost of benefits has a significant effect on the postretirement obligations reported.

D. Tax Status

The Internal Revenue Service has determined that the Plan is exempt from income taxes in accordance with the applicable sections of the Internal Revenue Code. The Plan is being operated in compliance with these requirements, and the related trust continues to be tax-exempt as of December 31, 2024. Accordingly, the Plan has no liability for income taxes.
