**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Eastern Communications LTD 401(k) Plan (formerly, the Racom Corporation Retirement Plan) (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution retirement plan covering all eligible employees of Eastern Communications LTD, LLC (the Company). The Plan covers substantially all non-union employees who are at least 21 years of age and have completed two months of service with employees eligible to enter the Plan on the first month after eligibility requirements have been met. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Company determined the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

**Plan Amendments**

Effective January 1, 2024, the Plan was amended and restated. As part of the restatement, the following Plan provisions were changed:

- The Plan sponsor was changed to Eastern Communications LTD, LLC.
- The name of the Plan was changed to Eastern Communications LTD 401(k) Plan.
- The Eastern Communications LTD 401(k) Profit Sharing Plan and Trust merged into the Plan (see Note 9).
- Collectively bargained employees and nonresident aliens with no U.S. income were added as excluded classes of employees.
- The service requirement for elective deferrals was changed from 6 months to 2 months.
- An age requirement of 21 years was added for employees to be eligible for participation in the Plan.
- Eligible compensation was modified to exclude compensation for the portion of the year in which an employee is not an active participant.
- The frequency of deferral changes was changed from each month to each pay period.
- The Company match was changed from a safe harbor formula to a non-safe harbor match of 50% of deferrals up to 6% of compensation.
- A provision to allow the Company to make a discretionary qualified nonelective contribution was added.
- A requirement was added that participants must have 500 hours of service in the Plan year to be eligible to receive employer contributions.
- A provision to allow notes receivable from participants (participants loans) was added.
- The vesting schedule for discretionary employer contributions was updated to the following: 50% vested after 1 year, 75% vested after 2 years, and 100% after 3 years of service.

**Contributions**

Plan participants may elect to contribute up to 100% of their compensation on a pre-tax or Roth basis, not to exceed the maximum deferral limit under the Internal Revenue Code (IRC). Participants aged 50 or over may make an additional catchup contribution to the Plan. The Plan allows rollover contributions for eligible employees from other qualified plans.

The Company makes a fixed matching contribution to eligible participants equal to 50% of employee deferrals that do not exceed 6% of compensation. The Company, at its discretion, may make additional contributions to all eligible employees, regardless of participation in the Plan. There were no discretionary contributions to the Plan for the year ended December 31, 2024.

**Investment Options**

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Principal Life Insurance Company and Delaware Charter Guarantee & Trust Company dba: Principal Trust Company (Principal). These funds include a variety of investment options with various objectives and degrees of financial risk.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income (loss) and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Vesting**

Participants are immediately vested in their contributions as well as employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's non-safe harbor matching contributions and discretionary contributions plus earnings thereon is based on continuous years of service. Effective January 1, 2024, these contributions become 50% vested after one year of credited service, as defined by the Plan, and continue to vest at the rate of 25% for each successive year of service until 100% vested after three years of service. Prior to 2024, discretionary contributions vested over a period of six years.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator. The notes currently bear interest at rates ranging from 5.25% to 9.50%. Participants may have two loans outstanding at any given time. Generally, principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or reaching normal retirement age, the participant may receive the value of the vested interest in his or her account in various forms of payment, as described in the Plan document. In addition, the Plan also allows for in-service distributions if a participant reaches age 59½ or under certain hardship circumstances. The Plan also provides for automatic cash-out and/or rollover distributions into an individual retirement account for terminated participants whose balance does not exceed certain limits as prescribed by the Plan document and IRC.

**Forfeitures**

Forfeitures of nonvested employer contributions are used to reduce the Company's future matching contributions or pay eligible plan expenses. During 2024, \$6,787 of forfeitures were used to reduce employer matching contributions and \$162 were used to offset plan expenses. Forfeited nonvested discretionary matching accounts totaled \$117 and \$-0- at December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are measured at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**Risks and Uncertainties**

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events were evaluated through October 6, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Information presented in the accompanying statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived, from information certified to be complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee & Trust Company dba: Principal Trust Company, the qualified institutions of the Plan, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value (NAV) practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds:* Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

*Guaranteed Interest Accounts:* These accounts represent investment contracts with Principal. Fair value is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity (some investments allow withdrawals without penalty for death, disability, termination or retirement). The fair value is determined by comparing current market interest rates to the interest rate on the account and adjusting for the number of years until the maturity date. The fair value of guaranteed five-year interest accounts are classified within Level 3 of the valuation hierarchy.

*Pooled Separate Accounts:* Pooled separate accounts are stated at their NAV as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The NAV is used as a practical expedient to estimate fair value.

*Collective and Collective Trust:* The common and collective trust is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of the units held of the collective trust. The NAV is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 GUARANTEED INVESTMENT CONTRACT**

The Plan has entered into a benefit-responsive guaranteed investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract is a traditional investment contract. The contract value of the investment contract at December 31, 2024 and 2023 was \$659,848 and \$-0-, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Principal. Such events include the following: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal. Principal currently serves as the custodian and recordkeeper of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also considered party-in-interest transactions.

**NOTE 7 TAX STATUS**

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 9 PLAN MERGERS AND TRANSFERS**

Effective January 1, 2024, the Eastern Communications Ltd 401(k) Profit Sharing Plan & Trust was merged into the Plan. The transfer of assets was completed in January 2024.
