## Independent Auditors' Report

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Controlled Environment Systems, LLC 401(K) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Controlled Environment Systems, LLC 401(K) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Controlled Environment Systems, LLC 401(K) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Notes to Financial Statements

#### **Note 1 – Plan description**

The following brief description of the Controlled Environment Systems, LLC 401(K) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan documents or summary plan description for a more complete description of the Plan's provisions.

##### *General*

The Controlled Environment Systems, LLC 401(K) Plan was established by Controlled Environment Systems, LLC (the "Company") effective January 1, 2009 for the benefit of its employees. The Plan is a defined contribution plan and is subject to the provisions of the Internal Revenue Code ("IRC") and the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

##### *Eligibility*

The Plan covers all company employees except for union employees, certain nonresident aliens, part-time employees, reclassified employees, and employees who are residents of Puerto Rico. Employees are eligible to participate after three months of service provided they have reached 21 years of age. Employees are automatically enrolled in the Plan unless the employee elects otherwise. The initial deferral rate is 4% of compensation and contributions are invested in the appropriate Retirement Date Fund based on the employee's age. An automatic 1% increase in deferral percentage will be made annually to each participant's account unless the employee elects otherwise, and the increase will be capped at 6%.

##### *Contributions*

Each year, participants may contribute between 1% to 100% of their compensation (as defined by the Plan) on a pre-tax or after-tax Roth basis, subject to certain limitations per the IRC.

The Plan is referred to as a safe harbor "qualified automatic contribution arrangement 401(K) plan." The Company will contribute an amount equal to 100% of a participant's contributions up to a maximum of 1% of the participant's compensation, plus 50% of the participant's contributions in excess of 1% but not in excess 6% of the participant's compensation. Participants who are 50 and older may also be eligible for catch-up contributions.

The Company may make additional nonelective discretionary contributions on behalf of eligible employees to the Plan for a plan year. Additional discretionary contributions are allocated based on the classifications of participants specified by the Company. There were no additional discretionary contributions for 2024.

The Plan allows rollover contributions from other qualified retirement savings plans.

##### *Participant accounts*

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with transaction fees related to participant transactions. Matching contributions are allocated based on participant contributions.

##### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon.

Employer safe harbor matching contributions are subject to a two-year graded vesting period wherein participants with one year of service are 50% vested in the safe harbor matching contributions and participants with two years of service are 100% vested. Participants with less than one year of service are 0% vested.

### Notes to Financial Statements

All other employer matching and discretionary contributions are subject to a six-year graded vesting period wherein participants become 20% vested in the employer matching and discretionary contributions after 2 years of service. Each year of service thereafter provides participants an additional 20% of vesting in the employer matching and discretionary contributions.

A service year is credited to a participant for each year in which at least 1,000 hours of service, as defined by the Plan document.

#### *Forfeitures*

Non-vested forfeited amounts are used to first offset administrative expenses of the Plan, then to reduce Company contributions.

#### *Payment of benefits*

The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and the income thereon allocated to such participant's account, subject to the Plan's vesting requirements. Upon retirement, disability, death or termination, the participant or beneficiary may receive a lump-sum amount equal to the value of the funds allocated to his/her account or a distribution in monthly, quarterly, semi-annual, annual or other installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant or beneficiary, as defined by the Plan.

#### *Notes receivable from participants*

Participants of the Plan may elect to borrow from their vested account balances a minimum of \$500 up to a maximum of 50% of their vested account balance or \$50,000, whichever is lower. Maximum loan amounts must be reduced by the participant's highest outstanding loan balance in the 12-month period before the date their loan is granted. The notes are secured by the balance in the participant's account and, as of December 31, 2024, bore interest at rates ranging from 5.25% to 10.50%. Uncollectible notes receivable are charged to the participant's account. All notes must be repaid within five years, except for notes used to acquire a principal residence, which must be repaid within thirty years. The interest rate charged on notes receivable from participants is equal to the prime rate on the first business day of the month before the loan is originated plus 2%.

### **Note 2 – Summary of significant accounting policies**

#### *Basis of accounting*

The financial statements of the Plan are prepared on the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and expenses are not recognized until received or paid, respectively.

#### *Use of estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

#### *Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the discussion under Fair Value Measurements (Note 4) for a description of valuation methodologies used for assets measured at fair value.

### Notes to Financial Statements

Purchases and sales of securities are recorded on a trade-date basis. Gain or loss on sales of investments is based on average cost. Interest income is recorded, as earned, on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits which consist of the realized gains or losses and the unrealized appreciation and depreciation on those investments.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

#### *Payment of benefits*

Benefits are recorded when paid.

#### *Administrative expenses*

Plan administration expenses, including recordkeeping and investment advisory services, are paid by the Plan. The Company is the plan administrator.

#### **Note 4 – Fair value of investments**

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Notes to Financial Statements

For the years ended December 31, 2024 and 2023, the Plan's assets measured at fair value consist of mutual funds, which are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's mutual funds are categorized as Level 1 within the fair value hierarchy. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

#### **Note 5 – Plan termination**

The Plan was established with the expectation that it will continue indefinitely. The Plan may be terminated if the Company so decides; however, the Company has not expressed an intent to terminate the Plan.

#### **Note 6 – Income tax status**

The Plan has not obtained a private letter ruling or determination letter from the Internal Revenue Service stating that the plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Service Code ("IRC"). However, the Plan operates under a prototype plan sponsored by Empower Retirement, LLC. The prototype plan sponsor has obtained an opinion letter dated November 14, 2022, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by the Federal and State tax authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 7 – Related party transactions**

Affiliates of the trustee, Reliance Trust Company, sponsor investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with recordkeeping services qualify as party-in-interest transactions. Notes receivables from participants are also considered party-in-interest transactions. These transactions are considered exempt from the prohibited transactions rules under ERISA.

#### **Note 8 – Risks and uncertainties**

The Plan provides for various investment options in mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities can occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
