We have performed audits of the accompanying financial statements of Seaway Hotels 401(k) (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1—Plan description

The following is a summary of major Plan provisions. Participants should refer to the Plan document for more complete information.

General – The Seaway Hotels 401(k) (the “Plan”) was established by The Biltmore Hotel, L.P. (the “Sponsor”) as a defined-contribution plan on October 23, 1993, and was amended and restated on June 1, 2022, to comply with the periodic plan restatement requirements of the Internal Revenue Service (“IRS”). The Plan is subject to the provisions of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Participation – Employees and officers of the Sponsor and its affiliates (Newark Refrigerated Warehouse, Inc. and Sand Key Associates LP) (collectively, the “Company” or “Employer”), who have attained the age of 21 and completed three months of service, are eligible to participate in the Plan. The Plan provides for entry dates on the first day of the month following the satisfaction of the entry requirements.

Contributions – Participants may contribute up to 100% of their total annual compensation, not to exceed \$23,000 established by the Internal Revenue Code (“IRC”). Participants, who have attained age 50, are eligible to make pre-tax, catch-up contributions subject to \$7,500. Employer and participant contributions are invested at the direction of the participant in various pooled separate accounts or guaranteed interest accounts. The Employer can make a discretionary-matching contribution based on the employee elective contributions and compensation. The Employer elected to match 25% of the first 6% of employee elective contributions for the year ended December 31, 2024. Additionally, the Employer may, at its discretion, make profit sharing contributions. The Employer elected not to make profit sharing contributions for the year ended December 31, 2024.

Participant Accounts – Each participant account is credited with the participant’s contributions. Plan earnings or losses are allocated based on the participant’s elected investments. Employer discretionary-matching and profit sharing contributions are allocated based on the relative participant salary reduction contributions and relative participant account balances, respectively. Participant accounts are reduced by benefit payments and an allocation of administrative expenses.

Forfeitures – Forfeitures may be used to pay administrative expenses or to reduce Employer-matching contributions. As of December 31, 2024 and 2023, there were no forfeitures available. There were forfeitures totaling approximately \$13,900 used to reduce administrative expenses and Employer-discretionary matching contributions during the year ended December 31, 2024.

Vesting – If a participant leaves the Company for reasons other than normal retirement, total permanent disability, or death, the participant will be eligible to receive the vested percentage of the balance credited to the participant’s account. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years of service	0%
2 years, but less than 3 years	20%
3 years, but less than 4 years	40%
4 years, but less than 5 years	60%
5 years, but less than 6 years	80%
6 years or more	100%

Upon employee normal retirement, death, or disability, Employer-matching and profit sharing contributions become 100% vested.

Notes Receivable from Participants – The Plan administrator may authorize participant notes from the borrowing participant's accounts. The Plan administrator has complete discretion in the matter of notes, although the Plan administrator must act in accordance with a uniform nondiscriminatory policy. The amount of the note may not exceed the lesser of: (1) 50% of the vested interest in the participant's account, or (2) \$50,000. The \$50,000 limit is subject to reduction by the amount of certain previously outstanding notes. Any note funded from the Plan must be adequately secured, must provide for a reasonable interest rate, and must be repaid within an agreed-upon period of time (generally within five years unless the note proceeds are used to purchase a principal residence for which the time period is not to exceed 30 years). Notes receivable outstanding at December 31, 2024 and 2023 bear interest at a rate of 6% per year maturing through March 2052.

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits due to terminated participants are paid to the participant in a lump sum if a distribution is requested or can be retained in the Plan following termination. In the event of any participant's total and permanent disability or death, the participant or his/her estate may elect to receive a lump-sum amount equal to the value of the participant's vested account. The Plan provides for an involuntary distribution of all terminated participant accounts with vested accrued benefits of \$5,000 or less excluding any portion of the account balance that is attributable to rollover contributions (and earnings or losses allocable thereto).

Note 2—Significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Investments, Investment Valuation, and Income Recognition – Investment contracts are reported at fair value, with the exception of fully benefit-responsive investment contracts ("FBRIC") which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to FBRICs because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan has an investment in guaranteed interest contracts with American United Life Insurance Company (the "qualified institution" or "AUL") at December 31, 2024 and 2023, which are fully benefit-responsive (see Note 5).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 2—Significant accounting policies (continued)

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value:

Pooled Separate Accounts – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The funds are traded on secondary markets which are not active; however, the underlying investments are traded on active markets and NAV of these funds are published by the administrator of the fund and have readily determinable fair values. As such, these investments are classified within Level 2 of the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Benefits Paid to Participants – Benefits are recorded when processed and paid by the Plan.

Administrative Expenses – The Company pays the Plan's administrative expenses and professional fees, while the Plan pays the investment advisory expenses.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Such estimates include those regarding fair value. Actual results could differ from those estimates.

- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan holds an interest in guaranteed interest accounts (AUL Fixed Fund and AUL Stable Value Fund) with the qualified institution. The investment objective of these funds is to earn a fixed rate of income. The accounts are credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by the qualified institution. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed interest accounts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest accounts.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was approximately \$3,331,000 and \$3,432,000, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 6—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution portion of their account.

Note 7—Tax status

The Plan is substantially identical to the OneAmerica Financial Partners, Inc. Defined Contribution Pre-Approved Plan ("Prototype Plan") approved as to form by the IRS and, therefore, will not be issued a separate determination letter.

The Prototype Plan is a qualified profit sharing plan under Section 401(k) of the IRC and, as such, is exempt from federal income taxes under Section 501(a) of the IRC. The AUL Prototype Plan obtained its latest determination letter on November 30, 2020, in which the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with applicable laws and requirements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8—Party-in-interest transactions

Certain Plan investments are managed by the qualified institution. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transaction rules (ERISA, Title I, Section 408(b)). Fees paid during 2024 for professional services rendered by parties in interest were based on customary and reasonable rates for such services.

Note 9—Risks and uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As the values of the Plan's individual investments have and will fluctuate in response to changing market conditions, the amount of potential losses that will be recognized in subsequent periods, if any, cannot be determined.
