As a result, the Plan has changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Note 1 – Description of Plan**

The following description of Hammacher Schlemmer 401(k) Plan (the Plan) provides only general information. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution profit sharing and 401(k) plan established by Hammacher Schlemmer (the Plan Sponsor and Company) for the benefit of eligible employees of the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Company were subject to the following eligibility requirements:

- Age: 18
- Service: None for elective employee contributions
- Status Exclusions:
  - a. Members of collective bargaining agreement unless the agreement required the employee to be included under the Plan
  - b. Leased employees
  - c. Non-resident aliens with no U.S. earned income
  - d. Temporary and casual employees
  - e. Employees of BGE, Ltd., who did not work exclusively for Hammacher Schlemmer.

Upon satisfying the eligibility requirements, employees could participate in the Plan on the first day of the next month. Participants were eligible to receive discretionary employer matching contributions and discretionary employer profit sharing contributions upon satisfying the eligibility requirements and if they were employed as of the last day of the Plan year.

During 2024, the Company was acquired. As a result of the transaction, the Company terminated all employees, and accordingly, contributions and further enrollment to the Plan ceased effective August 9, 2024. The Plan Administrator coordinated a group rollover of terminated participant balances and a transfer of active loan balances for participants rehired by the acquiring entity. The remaining assets in the Plan relate to participants who did not elect to rollover balances to the acquiring entity's plan due to restrictions on investments held in the managed income fund, or did not authorize distribution of their account balances.

**Termination of the Plan**

On August 5, 2024, the Plan made the formal decision to terminate the Plan effective August 9, 2024. Upon making the formal decision to terminate the Plan, the Plan entered into good faith amendments necessary to ensure the Plan's compliance with the applicable provisions of the CARES Act and the SECURE 2.0 Retirement Savings Act of 2022. Upon the Plan termination, all affected participants became fully vested in their accounts. The Plan was terminated in accordance with provisions of ERISA.

**Termination of the Plan** (Continued)

The Plan, in accordance with its responsibilities as a named fiduciary for the Hammacher Schlemmer 401(k) Plan, instructed Fidelity Management Trust Company (FMTTC), in its capacity as Trustee of the Fidelity Group Trust for Employment Benefit Plans, to withdraw the Plan's position in the Managed Income Portfolio (MIP). Withdrawals initiated by the Plan Sponsor will normally be provided at contract value as soon as practicable within twelve months following written notice to the Trustee.

As a result of the decision to terminate, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. All plan assets have been distributed through September 4, 2025.

**Contributions**

The Plan was funded through employee elective deferrals and Company contributions. Each year, participants could elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants could be permitted to deposit or "roll over" into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The following contribution types were allowed by the Plan:

- Elective deferrals
- Roth deferrals
- Rollover contributions
- Discretionary Employer matching
- Discretionary Employer profit-sharing

Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change their investment options at any time.

The Plan had an automatic enrollment provision (7% salary deferral) whereby employees must elect out of the Plan if they did not wish to participate.

**Contributions**

The Company could make discretionary profit-sharing contributions which would be allocated in accordance with the plan document provisions. Participants must be employed on the last day of the plan year to be eligible to receive discretionary profit-sharing contributions. The Company made no discretionary profit-sharing contributions to the Plan for the year ending December 31, 2024.

**Contributions** (Continued)

The Company could make discretionary matching contributions. The Company would communicate the amount of any discretionary employer matching contributions, if made. The Company made no matching contributions to the Plan for the year ending December 31, 2024. There were insignificant qualified non-elective contributions to the Plan for the year ending December 31, 2024.

**Participant Accounts**

Each participant's account was credited with the participant's contribution, allocation of the Company's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations could be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants were immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. The method for crediting vesting service for Company matching and profit-sharing contributions was based on vesting periods of service. Participants were credited with a period of service for 12 months from date of hire. If participants were employed on or after their Normal Retirement Age, or if they terminated employment on account of death or disability, they were 100% vested in their Company matching and profit sharing contributions. All participants became fully vested upon termination of the Plan.

**Forfeited Accounts**

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allowed forfeitures of non-vested Company contributions to be used as follows:

- Pay Administrative Expenses
- Reduce Company Contributions

As of December 31, 2024 and 2023, forfeited non-vested accounts were insignificant. There were no forfeited non-vested accounts used for the year ended December 31, 2024.

**Investment Options**

Upon enrollment in the Plan, a participant could direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant could change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

**Notes Receivable from Participants**

Participants who were active employees could borrow against their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans, in the form of promissory notes, were secured by the balance in the participant's account, and bore interest at reasonable rates, which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through payroll deductions and generally repaid within 5 years, unless for the purchase of a primary residence.

**Benefits Paid to Participants**

Upon termination of service, disability, or retirement, a participant was entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

As required under Section 401(a)(9) of the IRC, a participant must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the year in which the participant reaches age 70½ or 72 if the participant is not 70½ prior to January 1, 2020, or (ii) the year in which the participant retires.

The following types of distributions were also allowed by the Plan:

- Hardship
- In service
- Involuntary cash-outs
- Rollover source withdrawal at any time

**Plan Expenses**

The Plan's expenses were paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments.

**SECURE 2.0 Act**

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. Upon making the decision to terminate the Plan, the Plan elected to adopt a good faith amendment for the SECURE 2.0 Act. The good faith act is effective for distributions occurring on or after January 1, 2024, and increased the involuntary cash-out limit applicable to Plan distributions from \$5,000 to \$7,000.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

As a result of the Plan termination, management determined that the liquidation of the Plan was imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. The 2023 financial statements were prepared on the going concern basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued. Plan management has determined that no events or transactions, other than those described in Note 1, have occurred subsequent to the statements of net assets available for benefits date that require disclosure in the financial statements.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Stable Value Collective Trust Fund

A stable value fund that is composed primarily of government and corporate fixed income securities that is valued at the net asset value (NAV) of units of the bank collective trust. The NAV is used a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value amounts presented in these tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments, at fair value line item presented in the statements of net assets available for benefits.

Gains and losses realized and unrealized, for the year ended December 31, 2024, are reported under net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

**Note 5 – Related Party and Party-in-Interest Transactions**

Plan investments are managed by the trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issued loans to participants, which were secured by the vested balance in the participant's accounts and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest. Employees of the Company provided administrative services to the Plan for which no fees are charged.

**Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 – Tax Status**

The Plan sponsor adopted a plan, which received a favorable opinion letter issued to the document provider from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.
