As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. 1. DESCRIPTION OF PLAN

The following description of the Bowen Engineering Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Bowen Engineering Corporation (the Company, the Employer or Plan Sponsor) covering all employees not subject to collective bargaining agreements who are age 20.5 years or older. Each employee that is employed at the plan year end shall be eligible to receive a safe harbor matching contribution. Employees must also be 21 years or older and complete one year of service, as defined in the Plan, to be eligible for profit sharing and discretionary matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Plan Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's 401(k) Plan Committee.

Contributions

Each year, participants may contribute up to the maximum amount allowable by the Internal Revenue Code (IRC). These contributions can be made through a combination of participants' pre-tax contributions and post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan allows for a safe harbor matching contribution equal to 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective contributions that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Plan also allows a discretionary matching contribution and a nonelective (profit sharing) contribution as determined by the Employer. There was no discretionary or profit sharing contribution made in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investments of their contributions and the Employer's contributions into various investment options offered by the Plan.

Participant contributions in 2024 and 2023 were paid after the time frame required by the Department of Labor (DOL). The Plan Sponsor remitted 2024 and 2023 late contributions during 2024 and 2023. The lost earnings will be remitted subsequent to year end.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution and the Employer's matching contributions, as well as allocations of the Employer's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant

transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and the Employer's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and nonelective (profit sharing) contribution portion of their accounts plus actual earnings (or losses) thereon is based on years of service. Participants become 100% vested after six years of credited service. If not already, a participant becomes fully vested upon the occurrence of the participant's attainment of normal retirement age, death while employed by the Company, or satisfying the requirements for disability retirement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 less their highest outstanding loan balance in the last twelve months, or 50% of the participant's vested account balance. Under terms of the loan agreements, loans must be payable in not more than five years, unless used to acquire or construct the primary residence of the participant, which must be payable in not more than twenty years. Loans are secured by the balance in the participant's account and bear interest at a fixed rate, defined as prime plus 1% at the loan date. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to the attainment of normal retirement age (as defined), death, disability or other reasons, a participant with an account balance greater than \$5,000 may elect to receive a lump-sum distribution or installment distributions, have the balance rolled over to an eligible retirement plan, or leave the funds in the Plan for a distribution at a later time. A participant who has terminated employment and has a vested balance that does not exceed \$1,000 will receive a lump-sum distribution. A participant who has terminated employment and has a vested balance between \$1,000 and \$5,000 may elect to receive a lump-sum distribution or have the account balance rolled over to an eligible retirement plan. Hardship and in-service withdrawals, as well as required minimum distributions and automatic distributions to former participants, as defined in the plan agreement, are also permitted from a participant's account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$63,862 and \$30,386, respectively. The non-vested portion of former participants' accounts may be used to reduce future employer contributions or pay administrative expenses. During the year ended December 31, 2024, the Company did not use non-vested forfeitures to reduce the Company's safe harbor matching contribution or pay administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. Accordingly, benefit payments, corrective distributions and administrative expenses are accounted for when paid. Because this method of accounting differs from the accrual method of accounting, these statements are not intended to be presented in conformity with accounting principles generally accepted in the United States of America.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Investment held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 4 for discussion of fair value measurements.

Investment transactions are recorded as of the settlement date, which does not differ materially from the trade date. Interest income and dividends are recorded when received. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions

based upon the terms of the plan document. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Investment management fees for individual contracts are paid by the Plan and recorded as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain other expenses of the Plan, including third party administration and professional fees, are paid directly by the Employer.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits (modified cash basis) date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 9, 2025.

3. INFORMATION CERTIFIED BY PLAN'S TRUSTEES

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC), the trustees of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants information reflected on the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan's investments in mutual funds are considered to be Level 1 investments.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of this traditional investment contract was \$4,368,023 and \$4,868,698 at December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on an agreed-upon formula established by the contract issuer, but cannot be less than -0-% as of December 31, 2024. The crediting rate is reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to twelve months. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others.

The Plan invests in assets held by EAICA and ETC, which are the trustees of the Plan. Empower Retirement, LLC is the recordkeeper of the Plan and contract issuer of the SAGIC Diversified Bond in which the Plan invests. These transactions qualify as party-in-interest transactions.

ETC, the trustee and custodian, and Morgan Stanley, the Plan's investment advisor, receives payment from Empower Retirement, LLC through a profit sharing agreement. Blue & Co., LLC is the Plan's independent auditor and receives payment from the Employer for these services.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts. The plan administrator will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with the Plan until all assets have been distributed by the trustee.

8. TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by Empower Retirement, LLC, which has received an opinion letter from the IRS dated November 14, 2022, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
