## **DESCRIPTION OF THE PLAN**

The following description of Woodburn Nursery & Azaleas, Inc. Retirement Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering all employees of the Plan sponsor, Woodburn Nursery and Azaleas, Inc. and the commonly controlled company, Fessler Farms, Inc. (collectively, the "Company" or "Employer") who have one year of service and are age twenty-one or older. Employees may enter the Plan on the January 1 or July 1 that coincides with or follows the date on which they become eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. The Plan provides for Trustees to be appointed by the Board of Directors of the plan sponsor. These individuals are officers or employees of the sponsor Company. The Plan Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Plan's Board of Trustees.

### **Employee Contributions**

The Plan has a 401(k) feature which allows participants to defer up to 100 percent of their pre-tax annual compensation, as defined by the Plan, subject to a statutory maximum contribution each year.

### **Employer Contributions**

The Employer matches 100 percent of each participant's contributions up to the first three percent of each participant's compensation, plus 50 percent of contributions that exceed three percent, not to exceed a total of five percent of the participant's compensation. Additional amounts may also be contributed at the discretion of the Board of Directors. Matching and discretionary contributions totaling \$720,337 were made for the year ended December 31, 2024. It is the policy of the Plan sponsor to fund contributions to the Plan on a regular basis. There were no changes in the funding policy from the prior year.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions as well as allocations of the Plan sponsor's profit-sharing contributions and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All investments of the Plan are participant directed. Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature.

### ***Vesting***

A participant is always fully vested in their own contributions, employer matching contributions, and earnings thereon. Vesting in the employer discretionary contributions portion of a participant's account is based on years-of-service, at a rate of 20 percent each year after the first year, becoming 100 percent vested after six years of credited service.

### ***Payment of Benefits***

On termination of service or retirement, a participant with a vested interest in his or her account balance of at least \$7,000 may elect to have that amount rolled over to another qualified retirement account or paid out directly to them as a lump sum. Accounts with balances less than \$7,000 are subject to mandatory cash distribution.

The Plan also provides a participant who demonstrates "financial need," as defined by the Plan, with the option of taking a withdrawal from the participant's vested account balance.

### ***Forfeited Accounts***

Forfeitures may be used to pay plan expenses or to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested amounts totaled \$1,488 and \$0, respectively. In 2024, fees totaling \$1,488 were paid from forfeited nonvested accounts.

## **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value and contract value, as applicable. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount that would be received by the participant for permitted transactions. The Plan Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See additional information in the "Fair value measurements" and "Group Annuity Contract" notes to the financial statements.

### ***Investment Valuation and Income Recognition (Continued)***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

## FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end and closed-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## GROUP ANNUITY CONTRACT

The Plan has a group annuity contract with Standard Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and applicable fees or expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

## **GROUP ANNUITY CONTRACT (Continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or
- (d) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

## **INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

Charles Schwab Trust Bank, the Custodian, holds all investments and executes all investment transactions on behalf of the Plan. Information regarding the value of all cash, investments, interest and dividend income and net appreciation/depreciation in the fair value of investments has been certified by the custodian as complete and accurate in accordance with 29 CFR Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the *Employee Retirement Income Security Act of 1974*.

## **RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments were held by Charles Schwab Trust Bank, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in the summary of significant accounting policies note, the Plan made direct payments to the third-party administrator and investment advisors of \$64,092 for 2024, which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to Plan operations. Other parties-in-interest include the Plan's board of trustees, participants, and anyone performing services for the Plan.

## **PLAN TERMINATION**

Although it has not expressed any intent to do so, Woodburn Nursery & Azaleas, Inc., has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

## **TAX STATUS**

The Company has adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the form of the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
