We have performed audits of the financial statements of USIC 401(k) Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of USIC 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

The following description of the USIC 401(k) Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by USIC, LLC (Company). Participating employers are USIC Locating Services, LLC; Blood Hound, LLC; JF2, LLC (d/b/a On Target Utility Services), Protek Holdings, LLC; and Reconn Holdings, LLC, collectively (Company). The Plan is for the benefit of its Company and subsidiaries employees who have completed ninety days of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company (Principal Trust) is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of 1% to 75% of eligible compensation, as defined in the Plan Document. The Plan allows "catch-up" contributions for those participants age 50 years and older and for participants to transfer other qualified employer retirement plan assets to the Plan. The Plan also allows rollover and Roth contributions. Contributions are subject to certain limitations.

The Company may make quarterly discretionary matching contributions that are allocated to each eligible participant's account based upon the participant's salary deferral amount for those actively employed at the end of the calculation period unless termination due to death, disability, early or normal retirement. For the years ended December 31, 2024 and 2023, the Company elected to make matching contributions equal to 50% of each participant's salary deferral amount on the first 6% of the participant's eligible compensation.

The Company may make additional discretionary contributions that are allocated to each eligible participant in proportion to eligible compensation and are unrelated to any participant salary deferral amounts for those participants that have worked greater than 1,000 hours and who are employed on the last day of the quarter or Plan year unless termination due to death, normal retirement or disability. No additional discretionary contributions were made during the December 31, 2024 and 2023 Plan years.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after five years of credited service earning 20% each year after one year of credited service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Upon retirement or termination of service, distributions from the Plan are paid out in a lump-sum. Distributions may also be made to Plan participants as provided in the Plan Document. Participants may request withdrawals of their salary deferrals if they satisfy hardship requirements established by the Plan Administrator in accordance with Internal Revenue Service (IRS) guidelines.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$88,855 and \$180,937, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$928,512 and \$567,441, respectively, from forfeited nonvested accounts.

The December 31, 2024 and 2023 employer contribution receivable is reduced by \$153,251 and \$172,118, respectively, for forfeitures used when deposited in 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants before March 15, 2024. Excess contributions payable were not material in 2024.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The repayment period may not exceed five years unless the loan is used to purchase the participant's primary residence, subject to certain restrictions. Loans are secured by the balance in the participant's account and bear interest at a rate comparable to the rate charged by a commercial lender. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Pooled separate accounts are valued at estimated fair value as provided by Principal.

The Plan's interest in the collective investment trust funds are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The funds are valued using NAV as a practical expedient. The objective is the safety and preservation of principal and accumulated interest. There are no unfunded commitments or restrictions and redemption frequency is daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype profit-sharing plan and trust/custodial document sponsored by Principal Life Insurance Company. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype document has received a favorable opinion letter from the IRS. The Plan has been amended since the prototype received an opinion letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Certain other expenses of the Plan, such as investment manager fees and broker fees, are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Note 3. Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. See Note 2 for the definition of inputs utilized to determine fair value. There are no Level 2 or Level 3 securities held by the Plan.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan invested in certain funds offered by Wells Fargo and Principal. No expenses were paid to Wells Fargo during 2024 or 2023. The Plan paid \$482,612 and \$407,011 of administrative expenses to Principal during December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Note 7. Reconciliation of Financial Statements to Form 5500

Differences between the net assets reported in the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the net assets reported in the accompanying financial statements are due to the Reliance MetLife Stable Value common collective trust not having adopted ASU 2015-12 and the excess contribution refundable liability from 2023. Accordingly, the Form 5500 reflects an adjustment to the fair value of that investment and the excess contribution refundable liability for that reason.

Note 8. Subsequent Events

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
