Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Hallstrom Retirement Program, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Hallstrom Retirement Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of The Hallstrom Retirement Program (“the Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all full-time employees of Zip-O-Log Mills, Inc. (“the Company”), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan’s sponsor and serves as plan administrator.

Eligibility - Employees of the Company are eligible to participate in the Plan upon reaching age 18 if they have completed three consecutive months of service within the Plan year. To receive the employer profit sharing contribution, participants must be employed on the last day of the Plan year unless terminated due to normal retirement, death, or disability. To receive the employer safe harbor match contribution the employees must be eligible to participate in the Plan and complete one year of service as defined by the Plan document.

Contributions -

Participant contributions - Each year, participants may contribute between 1-100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to not participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation. The automatic deferral rate will increase by 1% beginning in year three of participation and continue each subsequent year, up to a maximum deferral rate of 6%.

Employer safe harbor match and profit sharing contributions - The Company makes safe harbor matching contributions to the Plan equal to 100% of each eligible participant’s elective contributions not exceeding 3% of the participant’s compensation plus 50% of the participant’s elective contributions exceeding 3%, but not exceeding 6% of the participant’s compensation. The safe harbor matching contribution for the year ended December 31, 2024 was approximately \$517,000. The Company may contribute an additional profit sharing amount at its discretion. The profit sharing contribution for the year ended December 31, 2024 was \$1,000,000 of which approximately \$140,000 was funded through plan forfeitures.

Contributions are subject to regulatory limitations.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Participant accounts - Each participant's account is credited with the participant's contributions and Company matching contributions as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting - Participants are vested immediately in participant, employer safe harbor match, and rollover contributions plus actual earnings thereon. Vesting in the employer profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. Regardless of the vesting schedule, participants become 100% vested if termination is due to death, disability, or normal retirement age.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. The terms of the loan repayments may range up to five years unless the loan is used to purchase a principal residence, in which case the term of the loan is not to exceed ten years. The loans will bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The loans carry interest at rates ranging from 3.25% to 8.50% with various maturities through October 2029. Principal and interest are paid ratably through payroll deductions.

Payment of benefits - Upon termination, retirement, death or disability, a participant may elect to receive either a lump-sum amount or equal installment payments equal to the value of the participant's vested interest in his or her account. The Plan participants may make hardship withdrawals in accordance with the rules in the Plan Agreement. For terminated participants with a vested benefit of \$5,000 or less, the Plan will distribute the vested benefit regardless of whether the participant consents to receive it.

Forfeitures - Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay plan administrative expenses or reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$141,253 and \$336,815, respectively. For the year ended December 31, 2024, forfeitures were used to pay \$12,750 in Plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - The investments are reported at fair value and contract value. The Plan's custodian, Standard Insurance Company, certifies the contract value of the guaranteed investment contract and the fair market value of all other investments. If available, the quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment on the terms of the Plan document.

Contributions - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the employer are recorded in the year in which related participant compensation is earned.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of the fair value of investments.

Subsequent events - The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

All plan assets stated at fair value were measured using net asset value as a practical expedient for fair value. In accordance with ASU 2015-07, these investments have not been classified in the fair value hierarchy.

NOTE 4 - GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE

The Plan has a fully benefit-responsive investment contract (FBRIC) with Standard Insurance Company (Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a monthly basis for resetting.

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 4 - GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE (Continued)

In addition, certain events allow the issuer to terminate the contract with the Plan with 30 days written notice. Such events include the following: (1) the Plan's failure to abide by state or federal law, (2) the Plan's failure to render performance necessary to comply with the terms of the contract, (3) the Plan's failure to maintain assets of least \$25,000, or (4) plan disqualification. Upon termination by the issuer, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

NOTE 5 - TAX STATUS

The Plan document is a volume submitter profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, the custodian of the Plan.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Standard Insurance Company, the custodian and recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Standard Insurance Company receives fees for managing the Plan investments, which affect investment performance. Standard Insurance Company also has an administrative service contract with the Plan. Fees paid by the participants of the Plan to Standard Insurance Company under the service contract for the year ended December 31, 2024 totaled approximately \$11,400.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
