### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Laidig Systems, Inc. Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following description of Laidig Systems, Inc. Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established January 1, 1983, and is a defined contribution plan covering substantially all employees of Laidig Systems, Inc. (the Company or Plan Sponsor) who have completed six months of service (as defined) and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Contributions from participants and the matching contributions from the employer are recorded in the year in which the participant's contributions are withheld from compensation. Each year, participants may contribute a percentage of pre-tax and/or post-tax wages as defined by the Plan, up to the maximum amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct these contributions into various investment options offered by the Plan.

The Company has elected to provide safe harbor matching contributions to the Plan and may also make an additional discretionary contribution. For the year ended December 31, 2024, the Company contributed a safe harbor match on a tiered scale of 100% of the first 3% of contributed compensation plus 50% on the next 2% of contributed compensation. The Company did not contribute any additional discretionary contributions for the year ended December 31, 2024. Company contributions are invested into the various investment options in a manner that is consistent with participant contributions. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contributions, if any, and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. A participant's account is charged an administrative fee for processing benefit payments as defined by the plan document. The benefit to which a participant, or beneficiary, is entitled is the vested benefit that can be provided from the participant's account.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. Defaulted loans are treated as assets of the Plan until there is a distributable event.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Notes receivable terms generally range from one to five years, unless the note qualifies as a home purchase, as defined by the Plan Agreement. The notes are collateralized by the balance in the participant's account and will bear interest at a reasonable rate. Notes are limited to two per participant. Principal and interest are paid ratably through payroll deductions.

**Vesting:** Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Participants vest in discretionary matching contributions and other historical employer matching contributions over a six-year graded schedule.

**Payment of benefits:** Upon termination of service, a participant may elect to receive a lump sum amount or installments equal to the participant's vested interest in the account. In-service withdrawals are not permitted unless the participant has met certain hardship conditions or has reached the retirement age. Under the Plan, participants, or their beneficiaries, are entitled to 100% of their account balance upon death or disability. Benefit payments are recorded when paid.

**Forfeited accounts:** Forfeitures of the discretionary matching contributions and other historical employer matching contributions will be used to reduce the employer's safe harbor match. There were no forfeited nonvested accounts at December 31, 2024 and 2023. There were no forfeitures used to reduce the employer safe harbor match made during the year ended December 31, 2024.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan Sponsor and, therefore, are not reflected in the Plan's financial statements.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Fair value measurements:** Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

#### **Note 2. Significant Accounting Policies (Continued)**

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Shares of registered investment companies (mutual funds):** Valued at the closing price reported on the active market on which the individual securities are traded.

**Common/collective trust fund:** Valued based on the net asset value (NAV) of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 9, 2025, the date the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Plan Termination

Although they have not expressed any intent to do so, the Company has the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 6. Related Party and Party-in-Interest Transactions

Ascensus is the custodian of the Plan; therefore, transactions with the custodian qualify as party-in-interest transactions. Fees paid by the Plan to the custodian totaled approximately \$27,000 for the year ended December 31, 2024.

#### Note 7. Income Tax Status and Uncertain Tax Position

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### Note 8. Delinquent Contributions

During 2024, the Plan Sponsor inadvertently failed to deposit approximately \$2,600 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor intends to deposit lost earnings in an amount of approximately \$6 to correct the failure. The Plan Sponsor intends to file Form 5330 and pay the applicable excise tax to the IRS. The correction will be made from the Plan Sponsor's Assets and not from the assets of the Plan.
