#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Superior Optical Labs, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of Superior Optical Labs, Inc. (the Company), who have completed 3 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offering, monitors investment performance and reports to the Plan's Board of Directors.

**Contributions** - Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute a percentage of after tax annual regular compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has elected to make a safe harbor matching contribution of 100% of participant's elective deferrals up to 3% and 50% of the next 2% of a participant's eligible compensation to be contributed to the Plan. In addition, the Plan allows for discretionary contributions at the option of the Company's Board of Directors. There were no discretionary matching contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of the Company's discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Plan's discretionary matching contribution after six years.

**Payment of Benefits** - On termination of service due to death, disability, retirement or due to any other reason, a participant receives a lump sum amount equal to the value of the participant's vested interest in his or her account. In addition, a partial or installment distribution may be permitted, if needed, to satisfy the required minimum distributions rules.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of their highest outstanding balance of loans from the Plan or fifty percent (50%) of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates equal to 2% above the prime rate, as defined. Principal and interest is paid ratably through biweekly payroll deductions.

**Forfeited Accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,742 and \$-0-, respectively. These accounts are used to reduce future employer contributions or to pay Plan expenses. During the year ended December 31, 2024, employer contributions were reduced by \$6,908 from forfeited nonvested accounts.

#### **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who is responsible for their integrity and objectivity. These policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events** - The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN**

The following is a summary of the plan's investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the plan's financial statements and supplemental schedule, that was prepared by, or derived from, information prepared by Voya Retirement Insurance and Annuity Company (Voya), the custodian of the plan, and furnished to the plan management. #### **NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* - Value based on the observable net asset value (NAV) of the underlying investment and on the price of the underlying investment received from the fund manager.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Voya Institutional Trust Company (VITC) or an affiliate of Voya. Voya is the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan made a direct payment to Voya for fees for recordkeeping services totaling \$37,786, which is included in administrative expenses as reported on the statement of changes in net assets available for benefits. The Company pays directly any other fees related to the Plan's operations.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer contributions.

**NOTE 7 - TAX STATUS**

The Plan is designed to meet IRS guidelines in accordance with applicable sections of the Internal Revenue Code (IRC). No letter of determination has been requested. However, the provider of the prototype plan document has obtained an opinion letter as to its acceptable form under the IRC. Although the plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
