Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hall Industries, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Hall Industries, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note A - Description of the Plan

The following brief description of the Hall Industries, Inc. 401(k) Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General - The Plan, as restated on January 1, 2022, is a defined contribution plan covering substantially all employees of Hall Industries, Inc., Standard Tool & Machine Co., Hall Technical Services, LLC, Hall Technical Services NY, LLC, Hall Equipment, LLC, Hall Fluid Power, LLC, Hall Manufacturing Technology, Hall Equipment Overall & Leasing, LLC, and Hall Technical Products & Design, LLC (collectively Company), other than those employees covered under a collective bargaining agreement, certain nonresident aliens, leased employees, interns, and seasonal employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees are eligible for participation in the Plan on the first day of each calendar quarter coinciding with or after completion of six consecutive months of employment and completion of 500 hours of service. Long term part time employees are eligible starting in 2024 provided they have at least three consecutive years with at least 500 hours of service in each year.

Contributions - Participants can make before-tax contributions and after-tax Roth contributions of a portion of their annual compensation to the Plan (Elective Deferrals) under Internal Revenue Code Section 401(k).

Newly eligible employees are automatically enrolled in the Plan with a contribution rate of 6% of their annual compensation. A participant may opt-out of the Plan or can elect to change their Elective Deferral percentage up to the maximum amount allowed by law. Elective Deferrals are subject to annual limitations prescribed by the Internal Revenue Code (IRC).

Employees may also elect to make “catch-up contributions” provided they have reached age 50 by the end of the current calendar year and have not exceeded other IRC and Plan contribution limits.

The Company may make a Qualified Automatic Contribution Arrangement (QACA) safe harbor contribution, matching contribution, or nonelective contribution. The QACA safe harbor contribution is equal to the sum of 100% of a participant’s Elective Deferrals that do not exceed 1% of the participant’s compensation, plus 50% of the participant’s Elective Deferrals that exceed 1% of the participant’s compensation but do not exceed 6% of the participant’s compensation. The QACA safe harbor contribution amounted to \$388,528 for the year ended December 31, 2024. The matching contribution is at the sole discretion of the Company and is limited to 6% of a participant’s eligible compensation. There were no matching contributions during 2024. The Company may also make a discretionary nonelective contribution on behalf of each eligible participant in the same ratio as each participant’s eligible compensation bears to the total of such compensation of all participants provided the participant is employed at December 31 and has completed one year of service. There were no nonelective contributions during 2024.

Participants may direct their Elective Deferral contributions, as well as the Company’s contributions, into any of a number of pooled separate accounts or guaranteed accounts maintained by the Custodian (Note C).

Participant Accounts - Each participant's account is credited with the employee's Elective Deferral contribution, the Company's contribution, Plan earnings (losses), loan fees (if applicable) and charged with an allocation of administrative expenses.

Vesting - Participants are vested immediately in their Elective Deferral contribution plus actual earnings thereon. Vesting in the Company's matching contribution and nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of service, in the event of their death, or if they become disabled. A Participant is 100% vested after 2 years in the Company's QACA safe harbor contribution. Vesting in the Company's discretionary matching contribution and discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of service, in the event of their death, or if they become disabled.

Notes Receivable from Participants - Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 or 50% of the fair market value of their vested account balance. The term of the loan may not exceed five years except in the case of a loan for the purpose of acquiring the principal residence of the participant. Each loan bears interest equal to 1% above the prime rate. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.5% at December 31, 2024 and 2023. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits - Benefits are paid to the Plan participants in a lump sum, in installments for those participants or beneficiaries who must receive required minimum distributions, or, at the election of the participants, as a direct rollover to another qualified plan that accepts direct rollover distributions. Individual accounts will be distributed upon the death, disability, retirement or termination of employment of the Plan participant. In the event of an immediate and heavy financial burden, the Plan also permits a hardship withdrawal of a participant's fully-vested portion of their account balance in amounts permitted under the provisions of the IRC. In-service distributions are allowed from a participant's fully-vested portion of their account balance as long as the participant has attained age 59 ½.

Forfeited Accounts - Forfeited non-vested accounts are used to reduce the QACA safe harbor contribution. Approximately \$44,000 in forfeitures were used to reduce the Company's QACA safe harbor contribution during 2024. At December 31, 2024 and 2023, there were no forfeited non-vested account balances.

Note B - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (Note D). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Custodian of the Plan's assets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans is recorded on the accrual basis. Participant loans are repaid through payroll reductions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant's employment is terminated the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Operating Expenses - A portion of the expenses of maintaining the Plan are paid by the Company. Expenses paid by the Plan include investment advisory fees, third party administrator fees, and custodial fees.

Benefits - Benefits are recorded when paid to participants or their beneficiaries.

Subsequent Events - Management has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

Note C - Information Certified by the Custodian

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock Life Insurance Company (U.S.A.), the Custodian of the Plan, as complete and accurate, except for comparing such information certified by the Custodian to information included in the Plan's financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 inputs consist of observable inputs other than quoted prices for identical assets and include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability; and Level 3 inputs are unobservable and significant inputs based on the best information available about the assumptions market participants would use in pricing the asset and have the lowest priority.

The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using observable inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodology used in measuring Plan assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - Pooled Separate Accounts (PSAs) invest in equity securities and fixed maturity securities. PSAs investing in equity securities are valued using quoted prices in active markets for identical assets. PSAs investing in fixed maturity securities are valued based on pricing date provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. The investment strategies of these pooled separate accounts vary among growth, income and equity objectives. A prospectus describing each pooled separate account is available from the plan administrator.

Guaranteed Interest Accounts - Guaranteed interest accounts guarantee the return of principal plus compound interest earned over a defined term, less any applicable charges. Fair value, as determined by the Custodian, is determined by comparing rates in effect on that particular valuation date to the rates on which the actual interest is determined and adjusting the value based on the difference in those rates.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The statements of net assets available for benefits presents the fair value of all investment contracts. The statement of changes in net assets available for benefits is prepared on the fair value basis as there are no investments held at December 31, 2024 in fully-benefit responsive investments which are required to be reported at contract value. Notes receivable from participants are valued at the amortized cost of the note.

Note E - Tax Status

The Plan obtained a favorable advisory letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Company and the plan administrator believe that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed.

Note F - Party-In-Interest

Certain of the Plan's assets invested in the pooled separate accounts and guaranteed interest accounts are issued and maintained by John Hancock Life Insurance Company (U.S.A.), who holds all of the Plan's investment assets in a group annuity contract. Transactions executed in these accounts are party-in-interest transactions. Fees paid by the Plan for these services amounted to approximately \$30,000 in 2024.

Note G - Termination Provision

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. Upon such termination of the Plan, the interest of each participant in the Plan becomes non-forfeitable and fully vested and will be distributed to such participant, or his or her beneficiary, at the time prescribed by the Plan terms or the IRC.

Note H – Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
