### Note 1: Plan Description

The following description of the ERRG, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan was adopted by Engineering Remediation Resources Group, Inc. on January 1, 2000 and covers the employees of Engineering Remediation Resources Group, Inc. and Naeva Geophysics, Inc. (collective the "Company"). The Plan is a defined contribution plan covering all qualifying employees of the Company who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan. Fidelity Management Trust Company ("Fidelity") is the appointed trustee for the Plan, and acts at the direction of the Plan's administrator. The 401(k) Plan Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

The Plan includes automatic enrollment for all new employees, which commences 35 days after the employee becomes eligible for the Plan if the employee does not opt out. Deferral contributions for employees entered under automatic enrollment will start at 5% and will increase annually by 1% to a maximum deferral contribution of 8%.

Each year, participants may contribute up to 90% of their compensation or the maximum amount allowed by law, as defined by the Plan, on a pretax or after-tax basis. Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan allows for discretionary employer matching contributions and non-elective employer contributions. Participants must complete 1 year of service with 1,000 hours to be eligible for discretionary employer matching contributions and non-elective employer contributions. In addition, participants must be employed on the last day of the plan year to be eligible for discretionary employer matching contributions and non-elective employer contributions. For the year ended December 31, 2024, the Company accrued, and paid subsequent to the year-end, discretionary employer matching contributions totaling \$301,813.

### Note 1: Plan Description (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their contributions, rollovers, qualified non-elective contributions and qualified matching contributions, plus actual earnings (losses) thereon.

Discretionary employer contributions, if any, as well as all earnings on these contributions vest according to the following schedule:

Participants are fully vested upon retirement, death, disability, or plan termination.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are immediately due upon the participant's termination. Loans must be fully repaid through payroll deductions within five years. If a loan is entered into for the purchase of a primary residence, it may be paid back over a period of ten years. The loans are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates at the time the loans were granted as determined by the plan sponsor. Interest rates on notes receivable from participants as of December 31, 2024, ranged from 4.25% to 9.50% per annum. A participant can only have one loan at any given time.

### Note 1: Plan Description (Continued)

#### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of his or her account as a lump-sum distribution.

Under certain circumstances, participants experiencing financial hardship or who have attained the age of 59 1/2 may withdraw a portion of their vested account balance prior to death, disability, retirement, or termination of employment, as defined in the Plan.

#### Forfeitures

Forfeitures that occur during a plan year will be used to reduce expenses related to the administration of the Plan and to reduce future employer discretionary contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$573 and \$15,618, respectively. During the year ended December 31, 2024, \$23,734 of forfeitures was used to reduce the administrative fees of the Plan.

#### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and a money market account as investment options for participants. Participants may change their investment options at any time.

#### SECURE 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Company has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Mutual & Money Market Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest and dividend income, interest income on notes receivable from participants, and net appreciation in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the supplemental schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024.

This information has not been audited by the Plan's independent auditors.

### **Note 5: Related-Party Transactions and Party-In-Interest Transactions**

Fidelity is the trustee and recordkeeper and Wipfli LLP performs an annual audit of the Plan, and Sageview Advisory Group provides investment advisory services as defined by the Plan. Transactions with these companies qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments of \$97,896 to these parties-in-interest, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

Notes receivable from participants also qualify as party-in-interest transaction, which are exempt from the prohibited transactions rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Plan utilizes a volume submitter plan which obtained a favorable opinion letter from the IRS dated June 30, 2020, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### Note 7: Tax Status (Continued)

GAAP requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in place.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
