Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of Dutch Miller Chevrolet, Inc. 401(k) Profit Sharing Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Dutch Miller Chevrolet, Inc. 401(k) Profit Sharing Retirement Plan (the Plan) is provided only for general information. Therefore, participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan provides retirement benefits to all employees of Dutch Miller Chevrolet, Inc. and its affiliated entities: DM Motor dba Dutch Miller Kia; Dutch Miller of Charleston, Inc.; Dutch Miller of Charlotte, Inc.; Dutch Miller Subaru, Inc.; and Dutch Miller Nissan of Bristol, Inc. (collectively referred to as the Employers). Effective, November 1, 2023, Dutch Miller of Berkley, LLC is also considered an Employer of the Plan. Effective October 1, 2020, all employees of the Employers over age 21, except for those covered under a collective bargaining agreement and nonresident aliens, are eligible to participate once they have been employed for three months. Entry dates are the first day of each month of the plan year coinciding with or following the next date on which the employee meets the eligibility requirements. The trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Each year, participants may elect to contribute any amount of pretax or after-tax (Roth) annual compensation up to 90% of their eligible compensation as defined by the Plan, subject to Internal Revenue Code limits. Effective November 2, 2020, the Plan was amended to elect automatic enrollment for all newly eligible employees. Contributions will be set at 3% and will be allocated to the Plan's default fund until the participant selects other investment options. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Rollover contributions may be made by eligible employees, even if the employee is not participating in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2021, the Company amended the plan to allow for non-discretionary matching employer contributions in an amount equal to 25% of the eligible contributions made by the eligible participants during the contribution period. The non-discretionary match will be received by all eligible participants. Contributions in excess of 8% of the eligible participant's compensation for the contribution period shall not be considered for non-discretionary matching employer contributions. This amendment also removed the discretionary matching employer contribution.

Participant Accounts

An individual account has been established for each participant into which the participant's contribution, the Employers' matching contribution, allocations of the Employers' discretionary contribution, and plan earnings, net of an allocation of administrative expense, if any, are accumulated. Allocations of administrative expense are based on participant account balances. The Plan is participant-directed; therefore, each participant's investment earnings are determined by the participant's individual investment decisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in the Company's matching and discretionary profit-sharing contributions plus actual earnings or losses thereon is based on credited years of service as follows:

Notes Receivable from Participants

Participant loans are not allowed.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum or rollover in an amount equal to their vested balance. Upon death, a participant's vested account will be paid to their spouse or beneficiary in a single lump-sum payment. Payment of amounts greater than \$5,000, upon termination of service, may be deferred until the participant reaches age 72. If the benefit is \$5,000 or less, the vested balance will be transferred to an IRA established by the plan sponsor, unless the participant elects otherwise.

Administrative Expenses

The plan sponsor absorbs some of the expenses related to the operation of the Plan. Any expenses paid by the plan sponsor are excluded from these financial statements.

Forfeited Accounts

Forfeitures are used to reduce employer contributions, restore participants' balances, or to pay administrative expenses. At December 31, 2024 and 2023, forfeitures totaled \$85,477 and \$48,105, respectively. There were \$250 in forfeitures used to pay plan expenses for the year ended December 31, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for benefit responsive investment contracts, which would be reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year.

Investment Valuation and Income Recognition (Continued)

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual method. Dividends are recorded on the ex-dividend date.

Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits paid to participants are recorded when paid.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 - consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.

Level 2 - consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 - consists of significant unobservable inputs for the asset or liability and has the lowest priority.

Collective investment trusts are valued at the net asset value (NAV) of units of a collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Fixed annuities are valued at fair value using the NAV as determined by the issuer based on the current fair values of the underlying assets of the fund. These investments may be redeemed daily.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by Empower, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$47,989 paid to Empower for the year ended on December 31, 2024. Additional investment fees paid to the trustee are netted against investment returns.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the plan administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. Using that guidance, tax positions initially need to be recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021, through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$769,768. Of those balances, no amount had been requested to be paid to the participants that were not paid until subsequent to the Plan's year end.

NOTE 8 – SUBSEQUENT EVENTS

The plan administrator has evaluated events and transactions subsequent to December 31, 2024, through September 29, 2025, (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The plan administrator has not identified any items requiring recognition or disclosure in the financial statements.

NOTE 9 – PROHIBITED TRANSACTIONS

During 2024, the plan sponsor failed to remit all employee contributions to the Plan on a timely basis, which is a prohibited transaction under ERISA. The plan sponsor is in the process of calculating the lost earnings to the participants and will contribute that amount to the Plan in order to correct the prohibited transactions.
