Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Accent Family of Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 – Plan Description

The following description of the Accent Family of Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Accent Packaging, Inc. and the following participating employers: Accent Building Materials, Inc., Cavert Rebar, LLC and Cavert Logistics, LLC (collectively, the “Company”). The Plan commenced effective June 1, 2017, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). The Plan was amended and restated effective June 1, 2022 to comply with the latest rules and regulations.

Plan Custodians and Trustee

The Plan’s assets are held by Principal Life Insurance Company (“Principal”), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and Principal Global Investors Trust Company (collectively, the “Custodians”). Among other duties, the Custodians receive contributions, hold and invest fund assets in accordance with the directions of participants, and make disbursements as directed by the Company. Two officers of the Company serve as the Plan’s Trustees.

Plan Merger – Transfer of Assets to this Plan

Effective October 1, 2024, the Coastal Wire Company, Inc. 401(k) Plan & Trust (the “Merged Plan”) merged with and into the Plan. The formal transfer of all assets was completed on November 6, 2024, and net assets totaling \$2,034,837 were transferred from the Merged Plan into the Plan. This amount is included on the statement of changes in net assets available for benefits.

Eligibility and Plan Entrance Date

Certain employees are not eligible to participate in the Plan, including those under collective bargaining agreements, leased employees, and non-resident aliens who receive no U.S.-source income. All other employees of a participating employer become eligible to participate in the Plan upon reaching the age of 18 and completing six months of service. Employees may enter the Plan on the first day of the calendar month beginning the month coincident with or next following satisfaction of eligibility requirements.

Contributions

Participants may elect to contribute, on a pre-tax or Roth basis, up to 100% of their annual eligible compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024. Participants may also transfer amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”), subject to approval by the Company.

The Plan provides for Employer matching contributions and Safe Harbor Employer matching contributions for eligible participants. Prior to October 1, 2024, for each pay period, the Company made matching contributions in an amount equal to 100% of participant contributions of the first 3% of eligible compensation, and 50% of the next 2% of eligible compensation, up to a maximum of 4%.

Note 1 – Plan Description (continued)

Contributions (continued)

Effective October 1, 2024, for each pay period, the Company made Safe Harbor Employer matching contributions in an amount equal to 100% of participant contributions, limited to 4% of eligible compensation.

For participants that did not receive a full Employer match in a given year, the Company makes a year-end “true-up” contribution to provide such participants with the match they would have received had the timing of their contributions not limited the Company match. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant account is credited with the participant’s contributions, Safe Harbor Employer matching contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants have the option of directing their account balances to one or more investment options offered by the Plan, which vary in types of investments, rates of return, and investment risk.

Vesting

Participants are vested immediately in their contributions, Safe Harbor Employer matching contributions, and actual earnings thereon. Employer discretionary non-elective contributions vest at a rate of 20% per year beginning after the second year of credited service, becoming fully vested after six years of credited service.

Notes Receivable from Participants

Effective January 1, 2023, the Plan was amended to allow initiation of new notes receivable from participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate is set at 2% above the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the participant’s vested account balance. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$8 respectively. These accounts will be used to reduce future employer contributions and to pay administrative expenses. Also, in 2024, employer contributions were reduced by \$93,578 from forfeited nonvested accounts and \$349 were used to pay administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts ("FBRICs"). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to FBRICs because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for FBRICs, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought, sold, and/or held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Note 2 – Summary of Significant Accounting Policies (continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Pooled Separate Accounts** – Valued using the NAV of units held by the Plan at year-end as provided by Principal. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 3 – Fair Value Measurements (continued)

- **Pooled Separate Accounts (continued)** – Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or unfunded commitments. Redemption frequency is immediate.
- **Common Collective Trust Funds** – Valued using the NAV provided by the fund administrator. NAV is used as a practical expedient to estimate fair value. Although the NAV’s unit prices are quoted on a private market that is not active, the unit prices are based on underlying investments that are traded on an active market (market approach). There are also no restrictions on the NAV price or its equivalent. Participant transactions may occur daily, there are no unfunded commitments, and redemption frequency is immediate. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

The Plan’s independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedules.

Note 5 – Guaranteed Investment Contract

The Plan has entered into a traditional FBRIC with Principal. The Separate Account Guaranteed Interest Contract (“SAGIC”) maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the SAGIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the SAGIC is fully benefit-responsive, contract value is the relevant measurement for the portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is reviewed on a quarterly basis for resetting. The SAGIC does not allow for a crediting interest rate below 0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to, the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring. The SAGIC does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the investment agreement.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds or units of pooled separate accounts and common collective trusts that are managed by the Custodians. These transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all remaining assets in the affected participants' accounts shall be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA.

Note 8 – Tax Status

The Plan operates under a non-standardized, pre-approved profit-sharing plan sponsored by Alliance Benefit Group of Houston, Inc. ("ABG"). The IRS has determined and informed ABG by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, it is not currently the subject of any active audits.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 – Prohibited Transactions

The Company failed to remit to the Plan's Custodian certain participant loan repayments in the aggregate amount of \$424 within the period prescribed by DOL Rules and Regulations. The DOL considers late deposits to be nonexempt prohibited transactions. Delays in remitting contributions to the Custodian were due to unintentional administrative errors. The Company is in the process of correcting contributions to the affected participants' accounts to compensate those participants for potential lost earnings due to the delays.
