## **Basis for Opinion**

## NOTE – A: DESCRIPTION OF THE PLAN

The following description of the Baystate Pools 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established to provide employees of Baystate Pool Supplies, Inc. (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). Fidelity Management Trust Company is the Trustee of the Plan. The Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility: All Company employees with the exception of residents of Puerto Rico and any employee covered by a collective bargaining agreement are eligible to participate in the Plan upon attaining the age of 21 years and providing 3 months of service to the Company.

The Plan includes an automatic enrollment provision. Therefore upon meeting the eligibility requirements, the Company automatically, on behalf of the participants, defers 3% of the participants' eligible compensation, as defined by the plan document. Additionally, participants who remain enrolled in the Plan, will automatically have their deferrals increased by 1% annually on February 1, until a deferral rate of 10% is reached.

Participant contributions: Upon meeting eligibility requirements, participants may contribute up to 90% of their plan compensation on a pre-tax or after-tax Roth basis, subject to IRC limitations. Participants who are at least 50 may make an additional "catch up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified plan known as rollover contributions, subject to certain requirements. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund, and common collective trust funds as investment options for participants.

Employer contributions: The Company may make matching on behalf of participants meeting the above eligibility requirements at the discretion of its Board of Directors. For the year ended December 31, 2024, the Company made discretionary matching contributions of 30% of each participant's deferral contributions up to 5% of the participant's eligible compensation, for a maximum match of 1.50% of compensation. During the year ended December 31, 2024, employer matching contributions totaled \$194,037.

The Company may also make discretionary non-elective profit-sharing contributions on behalf of eligible participants. Employees must have provided 1,000 hours of service during the plan year and must be employed on the last day of the plan year to be eligible for non-elective profit-sharing contributions. The Company did not make any non-elective profit-sharing contributions during the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses, which are allocated to participants' accounts based on each participant's account balance within each fund.

**NOTE – A: DESCRIPTION OF THE PLAN (Continued)**

Vesting: Participants are fully vested in the portion of their account which represents their contributions and the income earned thereon. Participants become 100% vested in the Company's matching and non-elective profit-sharing contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in the Company's matching and non-elective profit-sharing contributions and earnings thereon vest according to the following schedule:

Forfeited Accounts: When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeited balances are first used to restore re-employed participants' accounts. Any remaining forfeitures may be used to pay plan expenses or to reduce Company contributions. As of December 31, 2024 and 2023 the balance of the forfeiture account totaled \$6,464 and \$1,286, respectively. Forfeitures totaling \$2,157 were used during the year ended December 31, 2024 to reduce employer matching contributions.

Payment of Benefits: Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan are made in a lump sum Installment payments, partial withdrawals and annuities are not permitted under the Plan. A participant may also request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Distributions to participants are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. Loans must bear a reasonable rate of interest. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed.

Other income: The Plan includes a recordkeeping expense account under which certain mutual fund expenses that are charged by the mutual fund companies to the individual participants are recaptured by the Plan and held in a money market account.

**NOTE – A: DESCRIPTION OF THE PLAN (Continued)**

Other income (continued): These funds are then used to pay for expenses of the Plan that benefit the Plan participants as approved by the IRS, Department of Labor and ERISA. During the year ended December 31, 2024, these funds amounted to \$802 and are included in other income in the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the balance in the account totaled \$1,440 and \$584.

**NOTE – B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting/Presentation: The accompanying financial statements have been prepared on the accrual basis of accounting. The financial statements and notes are representations of management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Investment Value and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the period or at the time of purchase during the period.

Fair value: Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in generally accepted accounting principles more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings. The Plan's financial assets reflected in the financial statements at fair value include its investments, see Note C.

Use of Estimates: Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Accordingly, actual results could differ from those estimates, and such differences may be material.

Expenses: Substantially all of the administrative expenses incurred by the Plan are paid by the Plan. Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in either net appreciation of fair value of investments or administrative expenses.

**NOTE – C: FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**NOTE – C: FAIR VALUE MEASUREMENTS (Continued)**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. This hierarchy consists of three broad levels:

*Level 1* – Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Unobservable inputs for the asset or liability that are significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and level 3 inputs are only used when higher level inputs are not available. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no assets or liabilities measured at fair value on a non-recurring basis.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at the closing price reported by the fund sponsor from an actively traded exchange.

*Common collective trust:* Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts, asset backed securities, corporate bonds, and other securities. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE – C: FAIR VALUE MEASUREMENTS (Continued)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. Fair values of assets and liabilities measured on a recurring basis at December 31, 2024 and 2023 are as follows:

**NOTE – D: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in full to participants.

**NOTE – E: TAX STATUS**

The Plan operates under a pre-approved plan which the Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has evaluated the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Certain plan investments are mutual funds and a money market fund that are managed by the trustee. As such, transactions with the trustee for the Plan, qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA.

**NOTE – H: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
