## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
the SupplyOne 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SupplyOne 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the SupplyOne 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SupplyOne 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



## Notes to the Financial Statements For the Years Ended December 31, 2024 and 2023

---

### 1. Description of Plan

The following description of the SupplyOne 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering all full-time employees not represented under a collective bargaining agreement, certain employees represented by a collective bargaining agreement, of SupplyOne, Inc. and certain of its wholly-owned subsidiaries (collectively known as the “Company”) who have attained three months of service and are age 21 or older. Effective with the September 18, 2024 amendment, employees are eligible to participate after attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Merger and Amendment** – Effective September 18, 2024, the Plan was amended and restated to facilitate the merger of the Wrap-N-Pack, Inc. 401(k) and Retirement Plan (the “Wrap-N-Pack Plan”) into the Plan and implement provisions of the Coronavirus Aid, Relief and Economic Security “CARES” Act, Setting Every Community Up for Retirement Enhancement “SECURE” Act and other law changes which affect the Plan. As of the effective date, participants of the Wrap-N-Pack Plan became participants in the Plan and were eligible to make contributions in accordance with the Plan’s provisions which include prior service with Wrap-N-Pack. As a result of the merger, assets totaling \$1,933,133 were transferred into the Plan on September 18, 2024. Certain participating employers adopted provisions on May 1, 2025.

**Contributions** – Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, up to the maximum annual deferral allowed by the Internal Revenue Service (“IRS”) in the form of pre-tax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2023, the Plan was amended to adopt safe harbor provisions. During 2024 and 2023, under the safe harbor provisions, the employer made a basic matching contribution equal to 100% of the first 3% of eligible compensation contributed by each participant, plus 50% of any elective deferrals in excess of 3%, up to a maximum of 5% of the participant’s compensation. These safe harbor contributions are made to ensure compliance with applicable nondiscrimination testing requirements under the Internal Revenue Code (“IRC”).

The Company may make an additional discretionary matching contribution, applicable to elective deferrals up to 6% of the participant’s annual eligible compensation. During 2024 and 2023, the employer did not elect to make a discretionary matching contribution.

**Company Acquisitions and Plan Rollovers** – During 2024, the Company completed certain acquisitions. The 401(k) plans of the acquired companies were terminated, and participants were given the option to roll over their account balances into the Company’s Plan. Contributions totaling \$19,817,587 are included in rollovers for the year ended December 31, 2024.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and rollovers, as well as allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are vested immediately in their contributions and rollover contributions plus actual earnings (losses) thereon. Company contributions are 20% vested after one year of service, and increase 20% annually until 100% vesting is achieved at five years of service. Participants are immediately vested in safe harbor contributions.

**Investment Options** – Upon enrollment in the Plan, a participant may direct contributions into any number of currently offered mutual funds, and a guaranteed fixed interest account. In addition to these fund options, participants may also elect to invest in a self-directed brokerage account which allows participants to expand their investment options to funds not offered by the Plan. Individual participant accounts are maintained by the third-party administrator, and participants may change their investment options at any time.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have up to a maximum of ten loans outstanding at any time. The loan must be repaid within five years or up to ten years for the purchase of a primary residence. The loans are secured by the participant's vested account balance. The loan interest rate is set at 1% above the prime rate, as stated in the Wall Street Journal. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or equal monthly, quarterly, semi-annual, or annual installments.

**Forfeited Accounts** – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,522 and \$36,232, respectively. These accounts may be used to offset Plan expenses, or to reduce the Company's contributions. Forfeitures attributable to matching contributions may be used to reduce any matching contributions, and forfeitures attributable to nonelective contributions may be used to reduce any nonelective contributions. During 2024, forfeitures of \$43,576 were used to reduce employer matching contributions. During 2023, forfeitures of \$63,564 were used to reduce employer matching contributions related to 2022. During 2024 and 2023, forfeitures of \$3,003 and \$-0- were used to offset Plan expenses, respectively.

## 2. Summary of Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value, except for its fully benefit-responsive investment contract which is reported at contract value, see Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the years.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Transfers** – Plan transfers are recognized at the fair value of the assets on the effective date of the transfer.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent Events** – Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

*Level 1:* Unadjusted quoted prices in active markets for identical assets or liabilities.

*Level 2:* Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets.

*Level 3:* Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year-end.

*Self-directed brokerage accounts:* The balance of this account is made up of a money market fund, corporate stocks, mutual funds, and unit trusts, at year-end. The fair value is based on observable market quotations and is valued at the closing price reported on the active market on which individual securities are traded.

#### 4. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America, that is a traditional investment contract. Empower maintains the amounts allocated to the contract in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting interest rate is determined on a quarterly basis, as designated by Empower. The crediting interest rate is subject to guaranteed minimum floor, as defined on an annual basis by Empower.

This contract meets fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed investment contract at December 31, 2024 and 2023 was \$3,507,087 and \$5,436,272, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its financial obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include, but are not limited to: (1) amendments to the Plan agreement (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) or premature termination of the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with Empower and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **5. Information Prepared and Certified by Trustee and Custodian**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower"), the trustee and custodian of the Plan, a qualified institution.

### 6. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Empower, the trustee and custodian of the Plan for which fees are paid, and, therefore, these transactions qualify as party in interest transactions. Additionally, certain fees incurred and paid to the record keeper, and participant loans are also considered party in interest transactions. These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

The Plan sponsor failed to remit certain participant contributions in a timely manner during 2024 and 2023, as required by Department of Labor Regulation 2510.3-102 and are considered prohibited transactions. Contributions pending full correction as of December 31, 2024 totaled \$245,563. Contributions pending full correction as of December 31, 2023 and corrected during 2024 totaled \$2,106.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

### 8. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and Plan's management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
