If a participant's age as of the end of the Plan Year exceeds Normal Retirement Age, the Annuity Ratio Factor is the product of (a) 1.06 (which shall be prorated based on the number of calendar months from the last day of the preceding Plan Year to the computation date) and (b) the ratio of the present value of a monthly annuity for life computed as of the age of the participant as of the last day of the immediately preceding Plan Year to the present value of such annuity computed as of the last day of the current month. The annuity shall be computed on the basis of the GATT Mortality Table, at the interest rate specified in the Plan.

Yield The yield of the Plan's assets computed consistently with the date as of which Contributions are made. For purposes of computing an Actuarial Equivalent, the assumed Yield for all future years shall be equal to the interest rate used for computing such Actuarial Equivalent.

Normal Form of Benefit The Normal Form of Benefit payment for a participant, who is not married, is a straight life annuity payable to the participant for his life. Incremental TB Incremental TB is the product of Z and the Compensation Factor, with adjustments for certain participants as prescribed in Amendment 2, effective January 1, 2019.

Compensation Factor For a Participant, who is a legacy Member, the Compensation Factor is 0.0% of the Participant's Compensation for the Plan Year.
