Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Commerzbank Aktiengesellschaft 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

1. Description of Plan

The following description of Commerzbank Aktiengesellschaft 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a qualified retirement profit-sharing 401(k) salary deferral (defined contribution) plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Employee Benefits Committee (the Committee) of Commerzbank Aktiengesellschaft (the Company). The Committee, in consultation with professional advisors, oversees the administration of the Plan, reviews claims for benefits, and determines the investment offerings of the Plan's assets.

The Plan covers all employees of the Company except union employees, leased employees, nonresidential aliens, delegated personnel, residents of Puerto Rico, employees not on a U.S. payroll of the Company, and certain interns or temporary employees that do not meet the eligibility requirements.

Eligibility Requirements

All employees, except those mentioned previously, are eligible to participate immediately upon employment. Interns and temporary employees are eligible to participate after they have reached age 21 and have completed at least 1,000 hours of service during an eligibility computation period.

Contributions

Each year, participants may contribute up to 60% of eligible compensation into the Plan. However, salary deferrals cannot exceed a minimum dollar amount determined by the Federal Government each year. For 2024, that amount is \$23,000, excluding the catch-up provision, of pretax annual compensation. This Plan contains an automatic enrollment feature to encourage saving for retirement. Unless affirmatively elected otherwise, certain new and eligible employees will have 8% of their compensation contributed on a pre-tax basis as a deferral contribution for them to the Plan. Unless affirmatively elected otherwise, those participants who are still automatically enrolled will have their pre-tax deferral rate increase by 1% each year until it reaches a maximum of 10% of compensation.

The Company matches 100% of the first 5% of eligible compensation that a participant contributes to the Plan. The Company may also contribute an additional 4% of eligible compensation on behalf of the participant. Additional amounts may be contributed at the discretion of the Company's management. Contributions are subject to certain limitations, as regulated by the Internal Revenue Service (IRS). For the year ended December 31, 2024, there were no additional discretionary employer contributions to the Plan. Participants may also contribute amounts representing distributions from other defined benefit or defined contributions plans (rollover), except any distributions from an individual retirement account or annuity consisting of nondeductible contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's matching and discretionary contributions, and Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balance, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct employee and employer contributions into any of the 32 investment options offered under the Plan. The Plan also allows participants to direct their own investments in a self-directed brokerage account option. The participants may enroll in the Fidelity Portfolio Advisory Service at Work (the Service).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12-month period. The loans are secured by the balance in the participant's account and bear reasonable rates of interest, which are commensurate with prevailing rates as determined by the Plan administrator. Participants may only have two loans outstanding at any given time and may not refinance an existing loan or obtain an additional loan for the purpose of paying off an existing loan. The maximum loan period is five years unless the loan is for the purchase of a primary residence in which case the repayment period cannot exceed ten years from the date of the loan. The loan payments are to be paid twice a month through payroll deductions and will be considered to be in default if not paid according to the Plan's loan policies.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's matching portion of their accounts plus actual earnings thereon are vested based on graduated schedules over three years for non-elective contributions and earnings and five years for non-discretionary contributions. In addition, services with the following predecessor employees are included for the purpose of vesting: Europhypo AG (New York Branch), Dresdner Bank AG (New York Branch), Dresdner Klienwort Services LLC, and Commerz Markets LLC.

Payment of Benefits

Distributable events include termination of employment, minimum required distribution, retirement, disability, and death. A participant (and designated beneficiary in the event of death) may elect to receive the vested account balance in a lump sum or installment distributions. If the vested account balance exceeds \$1,000, the participant may delay distribution until required by law to receive the minimum required distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$689,304 and \$615,164, respectively. These accounts will first be used to fund the employer contributions, and any remaining balance will be used to reduce subsequent years' administrative expense and employer

contributions. Forfeitures used to reduce the administrative expenses and employer contributions in 2024 were \$4,040 and \$667,283, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements is in accordance with accounting principles generally accepted in the United States of America (GAAP), which requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based on the terms of the Plan document.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

The Plan elected to include certain special distribution provisions related to Domestic Abuse Withdrawal, Emergency Expense Withdrawal, Qualified Declared Disaster Withdrawal and Qualified Birth or Adoption Distribution in accordance with the Setting Every Community Up for Retirement Enhancement Act 2.0 (SECURE Act 2.0) with an effective date of January 1, 2025. The Plan also elected to provide employer matching contributions on employee qualified student loan repayments with an effective date of April 1, 2025. The Plan will be formally amended in accordance with the requirements of the SECURE Act 2.0 prior to December 31, 2026.

Management has evaluated all activities of the Plan through October 8, 2025, the date the financial statements were available to be issued and concluded that no other subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of an input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes on the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Trusts - Common Trusts are valued at NAV as a practical expedient in place of measurement at fair value.

Self-Directed Brokerage Accounts (SDBAs) - SDBAs are comprised of mainly registered investment companies, common stock, interest-bearing cash, and corporate debt. Registered investment companies held in the SDBAs are valued at the NAV reported by the managers of the funds, typically determined at the close of regular trading. Common stock held in the SDBAs are valued at the closing price reported on the active market on which the individual securities are traded. Interest-bearing cash is valued at cost, which approximates fair value. Corporate debt is valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

5. Tax Status

The Plan was established using the Fidelity Non-Standardized Pre-Approved Profit-Sharing Plan with cash or deferred arrangement (CODA), which, according to an opinion letter dated June 30, 2020 from the IRS, may be relied upon by an employer to adopt and qualify as an approved plan under the applicable sections of the Internal Revenue Code (IRC).

The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Information Prepared and Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest income from notes receivable from participants, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party and Party-in-Interest Transactions

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fidelity Management Trust Company gives credit to the Plan when recordkeeping revenue received in connection with Plan services exceeds agreed-upon compensation. Revenue credits are presented in other income in the statement of changes in net assets available for benefits and were used to pay the Plan's administrative expense. The revenue credit used to cover Plan's administrative expense for 2024 and 2023 were \$110,897 and \$73,706, respectively.

The Plan issues notes receivable to participants, which are secured by the vested balance in the participants' accounts. Notes receivables from participants also qualify as exempt party-in-interest transactions.
